# FIRE RULES AND STIPULATIONS

## OPEN FIRES:

- Select a safe place for our open fire. Clear a circle 10 feet across.
- Clear the circle to bare dirt, being sure to remove all burnable material. Keep your fire small and in a shallow pit or within the circle
- Build the fire on level ground away from steep slopes, rotten logs, stumps, dense dry grass and litter.
- Do not build any fire on a windy day.
- Do not leave a fire unattended at any time. It is a violation of State and Federal law to do so.
- Put your fire out – OUT COLD- before you leave. Let the fire burn down, separate the embers, mix and stir the coals with dirt and water if you have it. Make certain the fire is out by feeling it with your hands.
- NEVER BURY A FIRE. It can escape from under the dirt. Keep mixing and stirring until you KNOW it's out.
- Consult the regulation 20.2.60 NMAC for further details.

## SMOKING: IF YOU SMOKE, SMOKE SAFELY!

In your car, always use your ashtray. Never throw burning material out of the car window. In the woods, never ride or walk around while smoking. Top, sit down, clear a two foot spot to bare dirt and use it as your ashtray. Be sure to put all matches, ashes and burning tobacco out cold in the bare spot.

## OTHER PERMIT STIPULATIONS

**Land owner must notify CRCC Dispatch at (505)287-2983 prior to the start of the burn And upon completion and extinguishment of fire. Notification is to be made each time landowner is to burn. Landowner must follow NM Regulation on Open Burning 20.2.60 NMAC. Landowner must abide by all critical fire danger conditions and should check the daily forecast to ensure it is safe to burn.**

Notice; if you discover a fire try to put it out. In any case report it promptly to the nearest Fire Department or Law Enforcement Agency or call 911.
