- **IMPORTANT!** Make sure you list on the bottom of page 1 **ONLY THOSE WHO CAN BE INCLUDED ON YOUR CHOICE OF MEMBERSHIP**. Only if a family membership is selected may you enter your spouse and your children (unmarried and under age 24 only). Make sure sex, age and date of birth have been entered. If applicant is a minor (junior), a parent or legal guardian must complete application. If applicant is a child care worker, application must be signed by a parent or guardian of the child(ren) to be accompanied.
- **DOCUMENTS & SIGNATURE REQUIRED WITH APPLICATION:** All applicants must submit a copy of a current original utility bill (gas/electric) registered in their name as well as an acceptable photo I.D. (SEE NOTE BELOW) to verify identity and residency. Also, if included on page 1, a copy of each child's or senior citizen's birth or baptismal certificate to verify age and/or family relationship. All applicants must have read the Certification below, and their signature, electronic or otherwise, constitutes having read and understood same.
 - **Note:** • A valid driver's license or passport is acceptable "PHOTO" ID (as are last year's ID cards) but neither verify residency!
• You must show an original utility (gas/electric) bill when registering. Only utility bills will be accepted!
• Additional verifications must be provided if and when requested at any time.
- **PAYMENT INFORMATION:** If the total membership fee is under \$1,000, payment in full must accompany your application. If the total is \$1,000 or more, payment may be made in two installments – at least one half of the total must be submitted with your application. **THE BALANCE IS DUE (WITHOUT NOTICE) ON OR BEFORE JUNE 1, 2016, OR A \$25.00 SERVICE CHARGE WILL BE ADDED AND SUSPENSION OF PRIVILEGES TAKES EFFECT.** Locker rentals must be paid in full at the time of application. All checks should be made payable to the TOWN OF EASTCHESTER and submitted with this application and the required documents in person to: LAKE ISLE COUNTRY CLUB, 660 White Plains Road, Eastchester, NY 10709. For tennis only memberships, check should be made payable to "SPORTIME Lake Isle", and membership enrollment is to be completed with SPORTIME directly at their tennis clubhouse.
- **CERTIFICATION:** I certify that all statements and entries made in this application and any documents submitted in support thereof are true. I understand that should any of these statements, entries, or documents be found to be untrue or incorrect, any and all seasonal membership privileges granted hereunder by the Town of Eastchester may be suspended or revoked without refund of any fees.
- I understand and agree that all persons with seasonal membership privileges as granted hereunder are required to act in strict accordance with the rules, regulations, policies, procedures, and local laws established for the operation of the Town of Eastchester's Lake Isle Country Club, including any revisions made thereto at any time and that failure to comply with same may result in the suspension or revocation of any and all season privileges without refund of any fees. Lake Isle rules & regulations are available upon request in registration office and clearly posted throughout the facility.
- I understand and agree that all persons with seasonal membership privileges as granted hereunder assume all risk and danger incidental to the game of golf whether on the golf course or in any other area of the facility including but not limited to the pool complex and tennis courts...including specifically (but not exclusively) the danger of being injured by hit golf balls, swung golf clubs...and agree that the facility, its players and staff, and the Town of Eastchester are not liable for injury related from such causes.
- Hours of night tennis may be subject to change during various times of the season. Notice will be given whenever possible.
- I agree to pay on or before June 1, 2016 any balance of the total application fee owed but not submitted with this application without further notice whether or not facilities are used. If payment of the balance is not made on or before June 1, 2016, I agree that a \$25.00 service charge for late payment will be added to the balance owed and that all seasonal membership privileges granted by this application shall be immediately suspended. I understand that I shall remain liable for the balance owed plus the \$25.00 service charge with interest and legal charges as may accrue until all that is owed is paid.
- I understand that the Town of Eastchester reserves the right to alter and adjust fees, playing schedules, and to close facilities for special events, reasons of safety, and the public welfare and that **NO REFUND OF ANY FEES WILL BE GRANTED FOR ANY REASON.**
- I understand and agree that the Town of Eastchester's Lake Isle Country Club reserves the right to take pictures to post on Social Media.

SEASONAL MEMBERSHIP DETAILS

GENERAL INFORMATION:

- Resident: means that your primary domicile within the physical boundaries of Eastchester, Bronxville or Tuckahoe. Ownership of real property within the Town or mailing address may not necessarily constitute residency.
- Application Forms: a separate application form must be completed for each membership desired. Please call the Lake Isle Office at (914) 961 – 3453 ext. 1 for additional forms.
- Sex, Age, and Date of Birth: must be entered for all children to be included on family and junior memberships, seniors on senior citizen memberships and those included on child care worker memberships.
- Children under age 2: need not be considered when selecting a membership; they may accompany their parent(s) or legal guardian(s) to the pool without fee; however, name, sex, age, and date of birth must be entered as with other children.
- Children under age 14: are subject to some accompaniment requirements and use restrictions.
- Photo/ID Card: all persons to be included for seasonal membership use must be photographed with the exception of children under age two. Photo/ID cards must be picked up at the Office.
- Locker Rental: locker rental is optional; however, locker room use is available only if option has been selected.
- Holidays: are those days as celebrated by the Town of Eastchester.

SEASONAL MEMBERSHIP DESCRIPTIONS:

- Comprehensive: memberships include golf, pool, and tennis use. Pool & Tennis memberships include both pool and tennis use. All other memberships are designated as for Golf only, Pool only, and Tennis only.
- Any Tennis membership on this application is for the outdoor season only. For tennis only memberships, apply directly at the SPORTIME clubhouse.
- Family: means applicant, applicant's spouse, and/or applicant's unmarried children under age 24 residing with applicant.
- Individual: means any person age 19 or over; Junior applies to ages 14-18.
- Child Care Worker: allows individual pool complex admission and pool use **ONLY** when accompanied by the child(ren) of the specific family signing Child Care Worker application. **ONLY ONE MEMBERSHIP PER FAMILY;** minimum age of child care worker is 17. Verification of working relationship must be provided.
- Individual Weekday Golf: allows golfing on weekdays only (excluding holidays and when golf outings are scheduled on Mondays).
- Senior Citizen Memberships: for persons age 62 years and over only. Applicant's spouse must also meet this age requirement for Senior Family Pool and Senior Comprehensive II. Senior Family Comprehensive I is for senior applicant with non-senior spouse.

The Town of Eastchester does not discriminate on the basis of race, color, national origin, sex, religion, age, or disability in the employment or provision of service. Discounts are available to those having lower income: \$25,275 or less for an individual household, and \$38,585 or less for a family household.
