Event Highlights!

- This event is produced by the Marine Industries Association of the Treasure Coast with grant money from the Florida Inland Navigation District.
- More than 950 volunteers participated in 2012.
- Volunteers reported to one of 20 registration sites in Martin, St. Lucie and Indian River Counties. We covered approximately 125 miles of waterways.
- We removed a total of 7.6 tons of trash.
- Our participation was up by 6% over 2010 and we collected 9% less trash.
- Since 2008: 4,450+ volunteers, 1,300+ Boats & 45.6+ Tons of Trash Removed
- Unusual items:
 - Team Chasin' found a glass eye.
 - Diver's removed several nets and 10 anchors off of Peck Lake Reef
 - Multiples of bicycles, batteries, air conditioning compressors, boat parts, BBQ grills, carpeting. Thousand + bottles & cans and many thousands of cigarette butts.

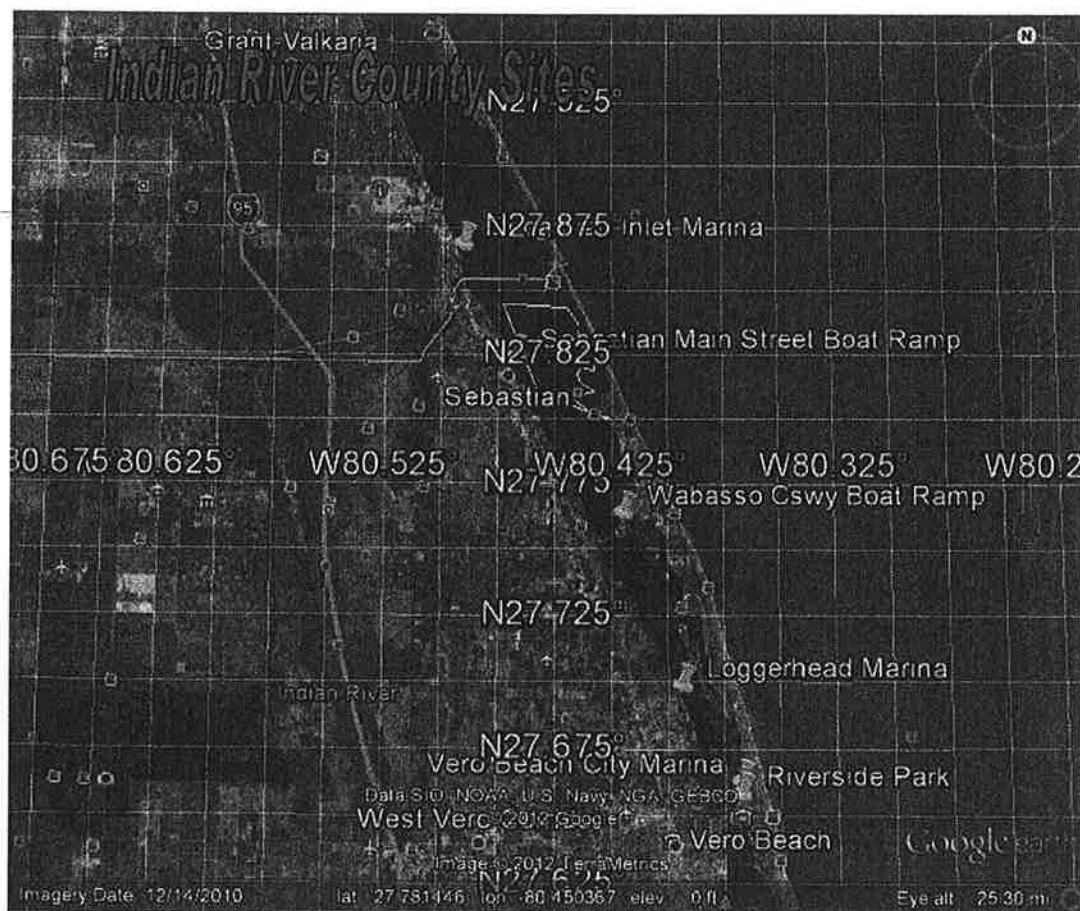

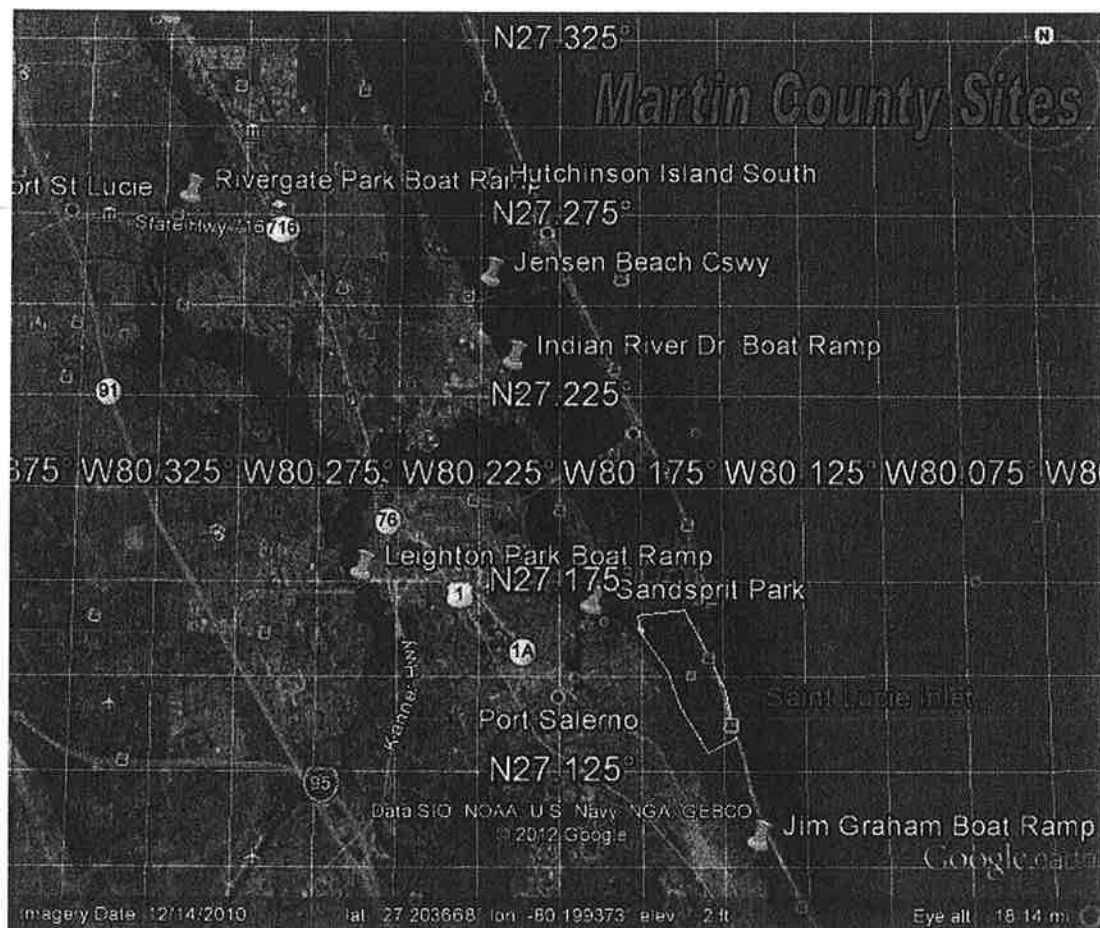

Attached for the Governing Board's consideration is a request for Waterway Cleanup Assistance to fund the 25th Annual Halifax Indian River and 27th Annual Ocean Conservancy International Coastal Cleanup to be held on September 21, 2013. Prior to 2012, these events were held separately on different dates and organized by different staff members of the Volusia County Environmental Management Division. In 2012, these cleanups were combined to be held on the same day and organized by the same program. Last year, Volusia County hosted 37 sites for the combined clean-up effort on September 16, 2012. In total, 1,332 volunteers removed 6,943 pounds of trash off 57 miles of coastlines! The top ten items collected during the event were:

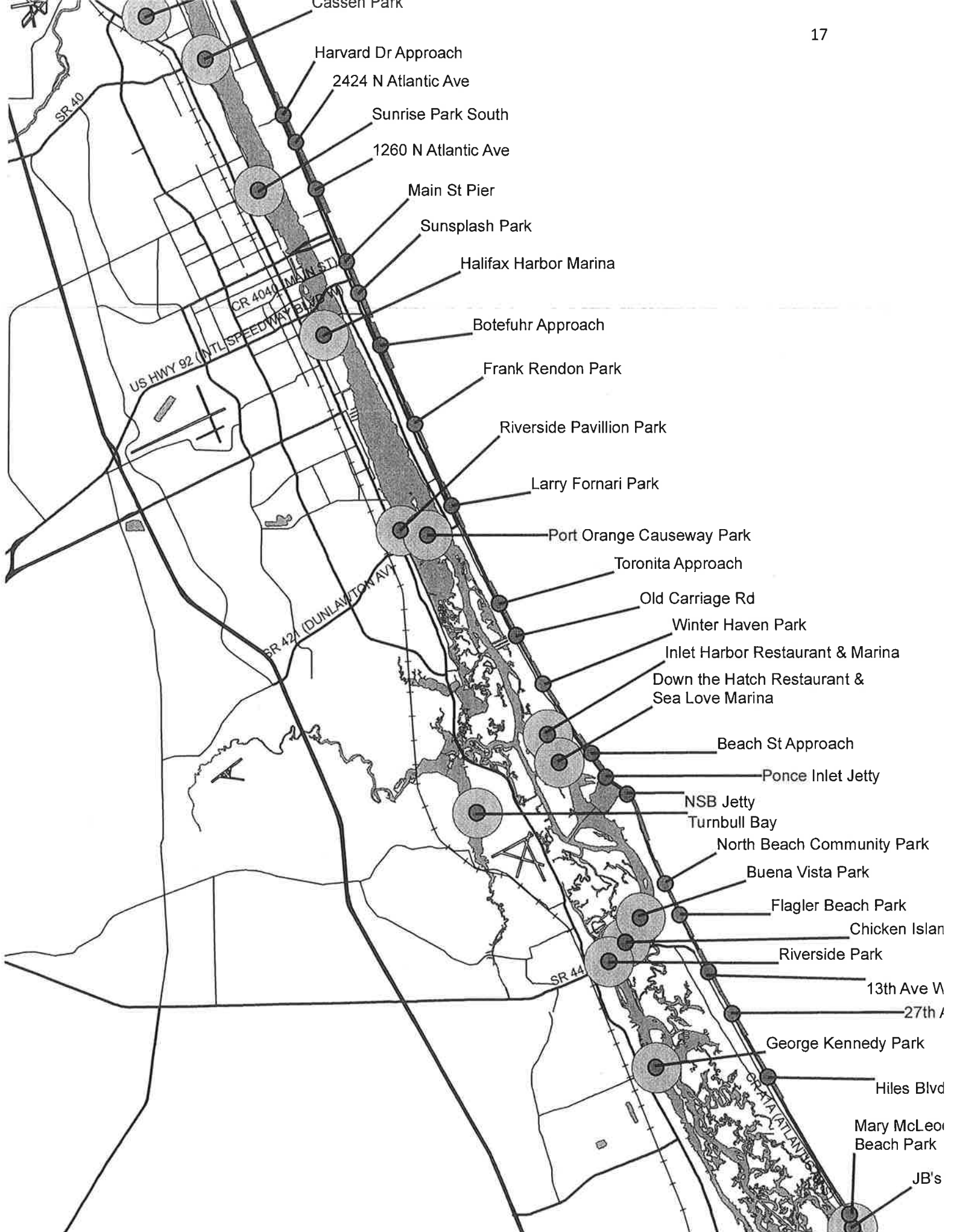

On behalf of the City of Jacksonville and Keep Jacksonville Beautiful, I would like to thank F.I.N.D. for its continued support of KJB's annual citywide, volunteer International Coastal Cleanup.

Since 1999 when the city began electronic data collection on the activity, more than 530,000 pounds of debris and trash have been removed from the Atlantic Ocean, St. Johns River, Intercoastal Waterway and local streams and creeks. In the past five years alone, that amounted to an average 8.5 tons per year.

Cigarette butts remain our biggest issue, with over 13,000 butts removed. The data we collect from this cleanup has been invaluable as we work with Martin County officials to deal with issues and areas of special concern.

The funding provided by your organization is critical to the success of our cleanup, and the impact that the results and data have on our community. The efforts of Keep Martin Beautiful and our growing base of volunteers are critical to helping maintain a clean and safe environment in and around our waterways. Your support is needed now more than ever as we continue to facilitate stewardship of our waterways throughout our entire community. This year's event will take place on September 21, 2013.

We respectfully request the maximum allowable financial support of \$5,000 from the Florida Inland Navigation District, just as you have provided every year since the mid 1990's. We view your support as an investment in our community and our organization. We have always worked hard to maximize that investment, and will continue to do so. Baynanza's History

Baynanza was created in 1982 in an effort by Miami-Dade County to save Biscayne Bay, and to date, it's the largest coastal cleanup in South Florida. This program was created when local community leaders and Miami-Dade County joined forces with other government and private agencies to raise awareness about the dire conditions of one of our most important natural resources, Biscayne Bay. At the time, the Bay was being threatened by the direct impact of pollution from sewage runoff, marine debris, and other contaminants. The main idea for the creation of Baynanza was to get the community involved in the efforts to bring Biscayne Bay back to life, and the name came from a play of words between bonanza and bay. Thirty years later, the Baynanza Biscayne Bay Cleanup Day, has become a staple in the local efforts to clean our coastal areas and community awareness. On this day, thousands of volunteers go out to more than two dozen sites throughout Miami-Dade County to pick up several tons of trash from the shorelines and nearby islands of the Bay. But Baynanza is more than just a 1-day event. This internationally known program is comprised of more than 45 great environmental events organized by several local agencies and sponsors. Overall, Baynanza runs from March to April every year, giving the community an array of educational events to choose from.

Baynanza's Current Success

Miami-Dade County hosted the 30th anniversary of the Baynanza Biscayne Bay Clean-up Day on Saturday, April 21, 2012. Although the weather was far from perfect, more than 2,200 community volunteers braved the wind and rain to assure Baynanza happened. All 28 cleanup sites opened their doors to the volunteers who came out to lend a hand under dreadful weather conditions. At the end of the day, the Baynanza volunteers still managed to collect more than 21 tons of trash from the shoreline of Biscayne Bay.

Baynanza 2013

This year the Baynanza Biscayne Bay Cleanup Day is scheduled to take place on Saturday, April 20th, and is expected to draw over 7,000 community participants. These volunteers will help to clean 23 sites and 16 islands in Biscayne Bay and the Miami River (attachment). Collectively, we hope to pick up more than 40 tons of trash from our waterways.

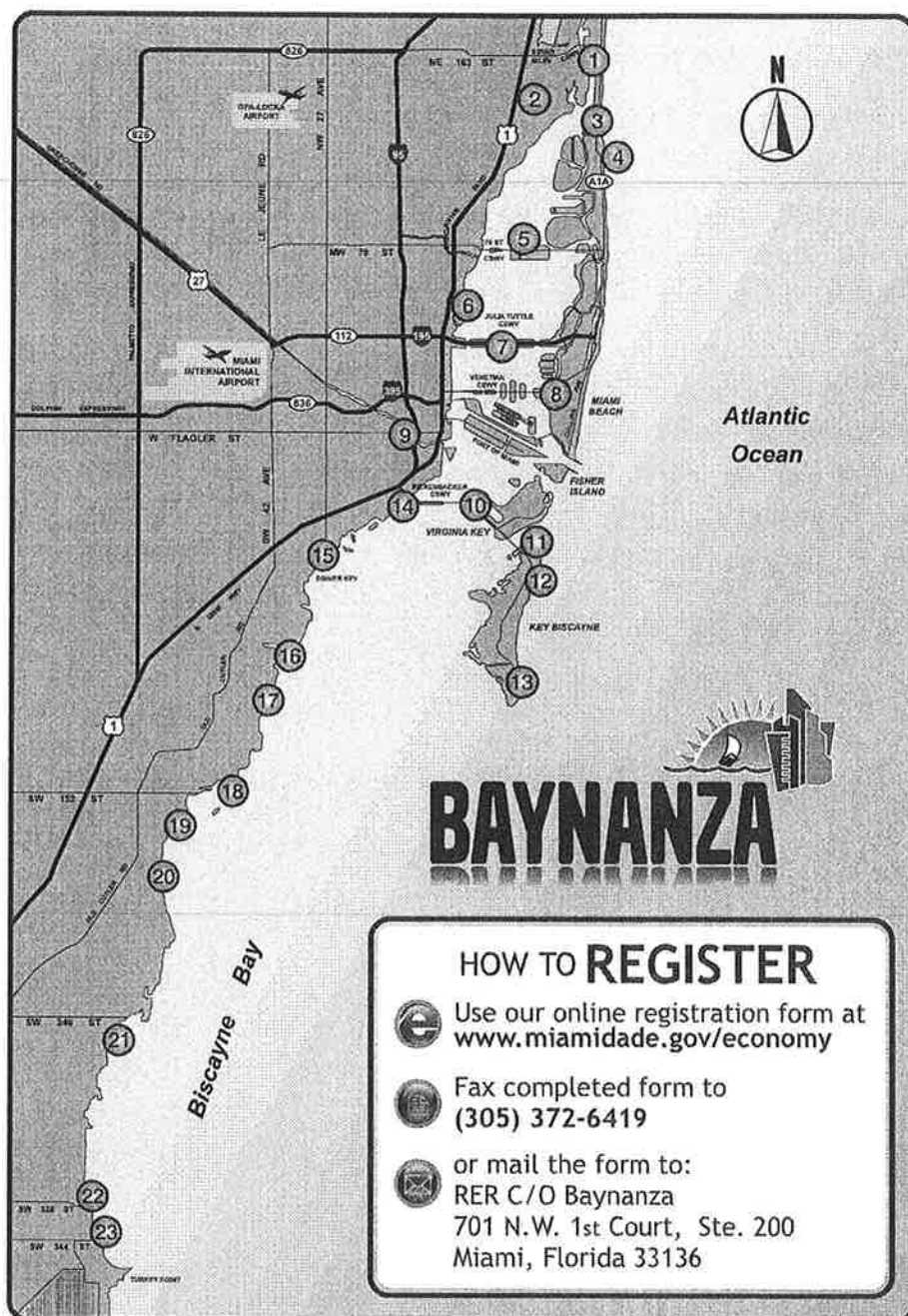
