Item A. Pelican Island Interpretive Signs, Small-Scale Spoil Island Restoration and Enhancement Program Project, Miami-Dade County, FL.

Miami-Dade County has submitted an application for Small-Scale Spoil Island Restoration and Enhancement Program funding for the installation of interpretive signs on Pelican Island, a spoil island within Miami-Dade County. The project will install three (3), 3x3 ft, 12-color educational signs. The project is in consistent with the District's program rules.

Item B. Waterway Cleanup Assistance to the Marine Industries Association of the Treasure Coast for the 8th Annual Treasure Coast Waterway Cleanup Project in Martin, St. Lucie and Indian River Counties.

The Marine Industries Association of the Treasure Coast has submitted requests for Annual Waterway Cleanup Projects in Martin, St. Lucie and Indian River Counties. The District has funded these cleanups for the last five years and it has been very successful. The request is for \$5,000 per county for Martin and Indian River Counties, and \$10,000 for St. Lucie County. The District participates in one other annual cleanup in Martin and IRC, but not in SLC. The proposal is consistent with the District's program rules.

• Miami-Dade Parks, Recreation and Open Spaces Department (MDPROS) would like to enhance visitors' enjoyment and education of Pelican Island, a bird sanctuary and nature preserve, located on a spoil island managed by MDPROS through a 1985 Management Plan Agreement between the State of Florida and MDPROS, by adding interpretive signs to explain the critical ecology on and around the island. We propose to install three, 3 by 3 foot, 12 color, signs, mounted on posts all of which are estimated to last 20 years or more. We request that FIND provide a grant of \$7,500 toward the cost of this project. The Parks Foundation will provide the required \$750.00 match, in cash, as detailed on the budget form attached to this request.

The content of the signs will be determined by our Natural Areas Management (NAM) staff, then designed, constructed and installed by an outside vendor.

The staff of NAM is charged with managing the flora on the island which consists of periodically clearing exotic foliage. At least annually, NAM arranges to host a group of devoted volunteers who assist in managing the foliage .

Other current improvements to the island include a project to replace the deteriorated ADA accessible day dock used by the Pelican Skipper to ferry patrons to and from the island and add a floating dock to provide capacity for smaller water craft which we expect to increase usage of the island.

The three proposed signs will be three by three foot, twelve color, interpretive signs mounted on posts.

Sign 1.- Placed at the trailhead. Sign would contain a map of the island which highlights the trail, dock pavilions, natural area and other important features.

Sign 2. – Located at the midpoint in the trail. Sign would tell history of the island, restoration efforts and pictures.

Sign 3. – Placed at the end of the trail, this sign will describe the ecology species and environmental purpose. It will include pictures of plants and animals.

On behalf of the Keep Jacksonville Beautiful Commission and the City of Jacksonville, thank you for allowing KJB to apply for financial assistance for the organized removal of refuse within the District's waterway in Duval County.

Keep Jacksonville Beautiful is grateful for the past support the Florida Inland Navigation District has provided, allowing the removal of trash and debris from the St. Johns River, International Coastal Waterway, the Atlantic Ocean and local creeks and streams.
