Dear Planning Commission,

The growers request a denial of this long plat subdivision based on current property conditions that prevail at this time. Our concerns are listed below:

- 1) Due to prevailing winter time flood conditions that are present on this property and adjacent properties GH County Health Department should not permit septic tanks on many of these lots. It has always been a grower concern when development tries to build in interdunal wetlands which are currently being used as storm water storage during the winter. This will lead to compromised septic systems that will contaminate down stream oyster growing habitat. Note: The statement that .19 acres of wetland are present on site of the development is not consistent with other wetland delineations of wetlands in the area.
- 2) All of the South Beach interdunal wetlands are tied together. The city of Westport's Winter Creek is already on the TMDL (Total Maximum Daily Load) list as contributing to Grays Harbor's fecal problem. If this subdivision is allowed to proceed as proposed it would add to the fecal contamination already present in the area.
- 3) The South Coastal Flood Hazard Management Plan (June 1997) prepared by CH2MHILL for GH county outlines problems and solutions to the flooding on South Beach. Since 1997 real and potential problems have only worsened as new and proposed development north and south of this proposal have occurred. More cross roads and culverts will only make the flooding in this area and related areas more pronounced.
- 4) Because of flooding in Westport and the South Beach there have been meetings between GH county, Department of Transportation (DOT), State Department of Parks (Parks), Department of Ecology(DOE), State Fish and Wildlife (WF&W), citizens and the city of Westport. The reason for the meetings is the South Beach is flooded during the winter and solutions must be found. Note: One popular solution expressed was to develop a new outlet to the estuary which would exit through shellfish beds in South Bay. The

growers took exception to this quick fix as water quality is already compromised in South Bay.

In conclusion: This long plat should not be approved because of cumulative impacts of flooding, water quality and storm water impacts. Please incorporate by reference: South Coastal Flood Hazard Management Plan of June, 1997.

- 1) The meeting referred to in your Item No. 1 was of an informal nature and took place on March 5th. The purpose of the meeting was to review the 1997 Study as completed by the County and their consultants CH2M Hill, and to openly discuss the mechanism to respond to public inquiry as received by the County and State elected officials. Interested residents of Westport and the South Beach area were in attendance. There was a follow-up discussion later at Westport City Hall and after that some individuals walked the flooded areas. There were no minutes or notes taken by Grays Harbor County, nor any distribution of documents.
- 2) The County has completed a study as published in Draft form in 1997, the documents will remain in draft form until such time as the funding agencies have reviewed and approved it. At this time the County has neither funded nor commissioned additional study. Further public forum will be required prior to implementation of any proposed solution.

This is a request for disclosure of public documents under Chapter 42.17 RCW. By this letter, I am requesting the following documents:

- 1) Copies of documents, plans and meeting notes relating to draining of land around the Westport/Grayland area. Recently representatives from the City of Westport, Grays Harbor County and Washington State Park Department met about this issue, a meeting the public was not invited to.
- 2) The County has requested a study of the flooding problems in this area because in the last ten years increasing amounts of water have hampered road traffic. We request a copy of the results of these studies.

Our Audubon Chapter owns property in the area and we will protect our private property. We recommend to City and County officials that a moratorium be placed on development in the area, especially wetland conversions and filling, until city and county put into effect needed planning changes to prevent increased road flooding. Road flooding did not occur with the frequency or the size that is has in the last ten years.

I am making this request on behalf of the Grays Harbor Audubon Society, a non-profit organization seeking to protect the environment of Grays Harbor County. This information will not be used for any commercial purposes and will advance the public interest.

Commissioner Dixon:

Your attendance at today's flood conference in Westport was appreciated by all. As you have heard and studied, there are serious flooding problems in the South Beach area. Because my residence is on the secondary dune adjacent to Spur 105 commonly known as South Forrest, I am above the flooding. However, my property extends west to the ocean much of which is flooded between the secondary and primary dune for several months each winter. Therefore, I am deried access through my property to the beach as the water is three to four feet deep in places. This is a somewhat frustrating inconvenience and renders my ocean front useless. Never-the-less I still am assessed for tax purposes \$103,000 just for the property since it is deemed waterfront.

The natural flow of water is north from Bonge Avenue toward Westport. Of course, there is the barrier at Ocean Avenue as was discussed which stops the flow. I suspect that as the area was developed over the years between the dunes, there are many more barriers such as roads and fill. Simply breaching Ocean Avenue to facilitate drainage won't solve the problem. I suggest that as a beginning, an aerial photo should be produced while there is a full flood - now in the winter months. I believe this would show not only the extent of the flood, but also where manmade barriers have been constructed. It is virtually impossible to "walk" the area while the water is at it's highest levels. Then with photo in hand, "walk" the area when it is dry during summer months and determine whether or not there are barriers to the flow. Finally, remove the barriers, breach Ocean Avenue and return the water to the bay as it accumulates.

A separate problem - septic tanks. The county should survey all septic tank systems in the flood plain. Many of these are antiquated and do not meet current standards. Even with a satisfactory drainage in place, these unsatisfactory tanks will not only contaminate the flow, but ground water as well. Thank you for your involvement.

Dear Mr. Bashon:

I am writing in response to your letter dated March 27, 1998 regarding the above. State Parks Operations and Resources Divisions staff have now completed a thorough review of the drainage improvement proposal as detailed in your letter. It appears to park staff that this proposal will more likely help the highway and less likely help the park solve stormwater drainage problems. Further, State Parks cannot justify the expenditure of funds toward construction of the proposed culvert; note that a culvert is necessary across the park and an open ditch would not be permitted. Given the benefits to the highway, however, staff agrees that the proposal warrants approval provided that there is no disruption to the short or long term operation of the park.

If WSDOT is still interested in pursuing this project, please contact me at (360) 902-8650 for information on how to make application for a permit or easement across park property.





Grays Harbor County Commissioner,

For the last 3 winters our homes have flooded out. This year exceeds all flooding on record. We have 14" of water in our home. This has never happened in the last 21 years of living here.

We live just south of Westport city limits. The city has little or no sympathy & the county says it has no money. The state highways are flooded here due to this problem. Just South of the State Park the water covers the entire road at times. Very dangerous for a State Highway. When you have to come to a complete stop driving Highway 105, so oncoming traffic can come by and splash so much water you can't see. Cars hydroplane all the time. So we feel it is time to go to the boss and say help.

When we met and talked to the county road guy Jim Selich, Grays Harbor County, he says no money but at least his is sympathetic and understands the problem.

The people number is small, so therefore the impact seems to not matter. Please Help!!! This area is well worth saving.

The 250k study "SOUTH COASTAL FLOOD HAZARD MANAGEMENT PLAN" shows the Cohassett West area the worst area. It also showed that drainage to the east into the Elk River Bay area would have a great impact to the whole area. The Grays Harbor County surveyed the ditch which is indicated in a solid red line on the map attached and it will drain to the East to the South Bay Estuary. Also there used to be pipe outfalls to the West through the primary dunes, but as time goes by the private folks who kept the outfalls groomed and maintained have either passed away or moved. The sand has covered the openings and outfalls. The most recent outfall pipe we can remember used to be where Pheasant Lane is now, it was removed for development. That pipe and six more indicated as green lines on the map should be strategically placed in the standing water area indicated on the map as standing water. To the North within city limits, the drainage North of the lighthouse has grown over since the State Park has taken over, so our natural drainage has slowed down. Plus in the last twelve years the City of Westport has allowed a lot of filling of land for private development and City tax basis which used to hold excess flood water.

We had our home sold last week until this occurred. We had made an earnest payment of 5k on another home & have many other expenses occurred already.

Within 12 hours all of our plans and hopes washed away. We now need to know whether our future holds any help in this matter or if we have to spend \$20,000.00 more to raise and fill our home site which is very difficult to get permits for due to the wetland proximity.

Please instruct the state & city people to expedite the ditch digging to the east at the State Park & clear out the old natural drainage North of the light house to the Airport drainage.

We truly enjoy your leadership and proven ability to Govern this great state, please help.

We would be happy to meet with you and show you personally this situation or any other thing we can do to assist. Thank you very much.

Introduction

On June 25, 1997, a final public meeting was held at Westport City Hall to receive comments on the draft FHMP, which had been distributed in early June. Approximately 20 people attended this meeting. Some had been at one or more of the previous meetings, while others were participating in the process for the first time. The agenda included presentations by the County's consultants and a breakout into small groups to discuss local flooding problems and solutions addressed in the plan. The presentation and subsequent discussions are summarized below.

Project Background and Overview

The presentation began with a description of the planning process and the contents of the draft FHMP. Bill Derry provided an overview, along with descriptions of the proposed engineering solutions and funding options; Jenifer Young-Sadowski discussed policy and regulatory components of the recommended plan designed to prevent future flooding problems. A number of issues were raised during the presentation, including the failure of the Grayland drainage district to provide solutions for SR 105 flooding south of the state park and the blockage of historical north-south drainage in the Cohasset Dunes area. Bill noted that "natural" drainage patterns are difficult, if not impossible, to define in this area, given the low topographic relief, dramatic accretion of the ocean beach, human activities, and the shifting of the dunes over time.

Small Group Discussion of Individual Projects

Display boards depicting the seven engineering example projects and their alternatives were divided into four groups to represent general geographic areas. Each group of boards was placed on a table, and attendees were invited to gather around the appropriate table to discuss the solutions proposed for the problems that affected them. A number of attendees were involved in the discussions of solutions for SR 105 south of Shafer Road (Example Project ABCE), Cohasset Dunes (Example Project I), and Winter Creek near Olympia and Chehalis Streets (Example Projects L and R). No attendees were present to represent the areas along SR 105 north of Shafer Road (Example Projects K, Q, and X). However, these projects were subsequently determined to be appropriate for consideration with the other recommended SR 105 improvements.

Discussion of the "ABCE" solutions focused on Example Project ABCE-2, which would involve the installation of a ditch and culvert system to convey flows north along SR 105 to Shafer Road, then eastward into the Elk River drainage. This was felt to be a better solution than raising the road in ponding areas (Example Project ABCE-1), which would merely displace the additional water. It was concluded that additional topographic information would be needed to confirm that flows could be routed east by gravity. The group also identified some opportunities for conservation easements in this area.

Like the SR 105 group, the group discussing solutions for Cohasset Dunes concluded that raising the roads (Example Project I-2) would not provide a satisfactory long-term solution to the area's flooding problems. Example Project I-1, consisting of a ditch and culvert system with an ocean outfall, was agreed to be a solution worth trying. The group voiced some concerns about the environmental, maintenance, and aesthetic issues related to the outfall, which would need to be explored in more detail. There was also discussion of the potential cost savings of funding and constructing such a project privately. The City of Westport recently annexed an area just north of Cohasset Dunes proposed for residential development; it was suggested that this proposed development, which would reduce the already limited flood storage in the area, participate in designing and funding an expanded version of Example Project I-1 to serve both areas.

For the flooding problems along Winter Creek in the vicinity of Chehalis and Olympia Streets, the group determined that Example Projects R-1 b and c—cleaning and regrading the channel and installing larger culverts to Cohasset Lake—would address the problems more effectively and at lower cost than constructing berms or raising affected homes. The group recommended channel cleaning upstream to the state park to increase conveyance capacity in the ditch, and noted that the capacity of the Cohasset Lake culverts under Chehalis Street appears to be exceeded on the second or third day of a storm. While it was recognized that these improvements might increase flows within the City of Westport, the group felt they were essential to alleviating the existing problems. Additional research needs to be done to establish ownership of the channel and the responsibility for its cleaning and maintenance. There is no authority or funding for the County to maintain the channel; therefore, maintenance is the responsibility of the channel's private owners.

Group Discussion of Conclusions and Future Actions

After the conclusions of each of the small groups had been presented, the entire group discussed the various projects in the context of the planning area. It was determined that the SR 105 projects, both north and south of Shafer Road, pose the greatest hazards to public safety, and that solving them would benefit the greatest number of people. Further discussion led to the conclusion that funding for the project should be extended south to the county line to address drainage problems along the length of SR 105. It was agreed that solutions to flooding along SR 105 should be accomplished within the publicly owned rights-of-way. Several people noted that diversion of SR 105 and state park drainage away from Winter Creek would help to alleviate other problems, most notably in the Chehalis/Olympia Streets area, and should precede other solutions related to that area.

Funding issues were also discussed. Most of the group expressed an interest in collective funding for the SR 105 project. WSDOT and the County were seen as principal contributors to this project, with individual property-owner contributions spread out over a large number of residents who would benefit from the improvements. An area-wide stormwater utility was the mechanism recommended for collecting and administering these funds.
