1. Application
2. Photo static copy of Certificate of Competency
3. Letter of Good Standing
4. Certificate of Insurance naming **VILLAGE OF GREAT NECK** as Certificate Holder and Additionally Insured. You must carry Workers Compensation, Disability and Liability Insurances.
5. Fee of \$150.00

The application is then forwarded to the Building Inspector for approval.
