The owner of the sign or awning ("Structure") and the property owner (together "Owners"), in jointly making this application, hereby jointly and severally acknowledge and agree as follows:

1. Any permit or approval hereafter issued upon this application ("Permit") shall be subject to the strict observance of Chapters 237 and 575 and other provisions of the Code of the Village of Great Neck (the "Village"), and any conditions that may be imposed by any boards, committees, and departments of the Village with regard to such Permit or otherwise with regard to the Structure.
2. Upon information and belief, all of the statements and representations made in or as a part of this application or before or to any Village board, committee, or department in support of this application are true, and if shown to be untrue, shall be a basis for rescinding any Permit.
3. In the event that any Structure is erected or maintained based upon any Permit in a manner contrary to the approval or conditions imposed with regard to such approval, such shall constitute a violation of § 237-7(A) of the Code of the Village, and, following 5-days' notice (or such lesser notice as may be appropriate, if any, for public safety) to the owner at the address given on this application, the Village may enter upon the Premises and remove Structure.
4. The Owner shall indemnify and save harmless the Village and its officers, employees, and agents from all liability, damages, claims, awards, and judgments including, but not limited to, the fees of their attorneys and expert witnesses, for any personal injury or property damage arising from or in any way connected with the erection, maintenance, or presence of the Structure.
5. So long as the Village and its officers, employees, and agents act in good faith in the exercise of their duties, obligations, and rights based upon this agreement, the Owners shall indemnify them and hold them harmless from all liability, damages, claims, awards, and judgments including, but not limited to, the fees of their attorneys and expert witnesses, which may result from such acts.
