Dear Resident:

On behalf of the Board of Trustees and residents, welcome to the Village of Great Neck! I hope that you and your family enjoy your new home. Please visit our Village website at [www.greatneckvillage.org](http://www.greatneckvillage.org) for important updates and useful information.

Village Hall staff are here to assist you with any questions you may have. The Village Hall is located at 767 Middle Neck Road in Great Neck. The contact number is (516) 482-2000. The Village Hall is open Monday through Friday from 8:30 am to 4:30 pm.

I would like to share with you some helpful tips and reminders:

- Sanitation reports to the Department of Public Works. Sanitation pickup is performed twice a week and recyclables are picked up every Wednesday. Please see the attached schedule.
- For special pick up of large/bulk items, such as household furniture and appliances, Sanitation must be notified. You may contact them by phone, (516) 482-2000 extension 142, or email, [info@greatneckvillage.org](mailto:info@greatneckvillage.org). Sanitation is prohibited from removing any construction materials.
- If you are looking to perform any construction to your home, such as a kitchen or bathroom renovation, extensions, paving your driveway, repairs to your sidewalk, building or expanding a patio or deck, replacing siding, updating windows, building a fence or shed, installation of HVAC units, etc., please be sure to contact the Building Department to obtain a proper permit. You may contact them at (516) 482-2000, extension 116 or 118. Safety inspections are required to keep you and other Village residents safe.
- Maintaining your lawn, shrubberies and trees is your responsibility. Village code does not allow for overgrown grass and shrubs. If you are planning on hiring a landscaping professional, they must be registered with the Village. No commercial landscaping is permitted on Saturdays and Sundays. Additionally, gas-powered blowers are prohibited from June through September. To prevent the potential clogging of storm drains, all grass and shrub clippings must be properly discarded.
- If you need to remove a tree from your property, a permit is required. Please contact the Building Department to obtain a permit to ensure safe removal.
- Be considerate when planning a gathering. Unreasonable, loud, disturbing and unnecessary noise of such character, intensity and duration, are prohibited between the hours of 11:00 pm – 7:00 am as this could be detrimental to the health of our neighbors. Courtesy is contagious.

- Maintenance of the sidewalk and the area to the curb is the responsibility of the adjacent property owner. As such, please remember to clear your sidewalk after snow and keep a safe passageway for pedestrians.
- Parking is not permitted on any Village roads or in any parking lots between the hours of 3:00 am-6:00 am.
- Village taxes are due once a year. Tax bills are mailed at the end of May and are due by July 1<sup>st</sup> to avoid penalties.
- Streetlight outages, potholes, missing street signs, concern for a Village tree or any other issues should be reported to the Village Hall so we can address the matter.
