AN ORDINANCE TO AMEND THE CODE OF THE BOROUGH OF HADDONFIELD, IN THE COUNTY OF CAMDEN, STATE OF NEW JERSEY CHAPTER 232 ENTITLED "VEHICLES AND TRAFFIC" ARTICLE V "TRAFFIC REGULATIONS" SECTION 37.1 "MULTI-WAY STOP INTERSECTIONS"

WHEREAS, the Board of Commissioners of the Borough of Haddonfield (hereinafter "Borough") deems it appropriate, necessary, and proper to amend Chapter 232 "Vehicles and Traffic" Article V "Traffic Regulations" Section 37.1 "Multi-way Stop Intersections" of the Borough Code to include additional intersections as multi-way stop intersections;

BE IT ORDAINED by the Board of Commissioners of the Borough of Haddonfield in the County of Camden, State of New Jersey that Chapter 232 "Vehicles and Traffic" Article V "Traffic Regulations" Section 37.1 "Multi-way Stop Intersections" shall be amended to:

SECTION I

1. § 232-37.1 Multi-way stop intersections.

Pursuant to the provisions of N.J.S.A. 39:4-140, the following intersections are hereby designated as multi-way stop intersections. Stop signs shall be installed as provided therein.

<u>Intersection</u>	<u>Type</u>
Reman Avenue and Peyton Avenue	4-way
Mount Vernon Avenue and Peyton Avenue	4-way
Redman Avenue and Avondale Avenue (CR 646)	4-way
Mount Vernon Avenue and Avondale Avenue (CR 646)	4-way

SECTION II

Chapter 232 "Vehicles and Traffic" Article V "Traffic Regulations" Section 37.1 "Multi-way Stop Intersections", be and the same is hereby amended.


Section IV
