PARK AND PAVILION RENTAL:

Deputy Supervisor Neadow - "Normally we would take a \$50 deposit for the pavilion and then it would get returned. We are looking over options of charging the \$50 but keeping it to put in to the funds to help support the park. I made a report on different parks in Niagara County and what they do as far as pavilion rentals. We will talk about that again at another meeting if people wanted to look into it ask any questions when we bring it up again, this is your time to look into the issue. We also talked to our grant writer today regarding putting in an inclusive park and that's moving right along. We may midsummer be able to get started on that over there which will be handicap accessible so I shared some information that was shared with me today on that.

PRIVLEDGE OF THE FLOOR

Kevin Campbell- EDF Renewables – "Good Evening Everyone, just wanted to make a comment on the citizens group you're putting together for renewable energy and community engagement. A colleague of mine and myself were here during the hearing evening, we signed up our names and highlighted as you suggested for people who wanted to sign up for those committees. I saw in the paper though, I guess you are not inviting people who are not citizens to be on those boards, including EDF Renewables. I just wanted to let you know that we are available to be on those boards if you wish for us to do so and we are also happy to share any of our consultants with you or experts to help with providing information from both sides obviously. Bottom line is we just want to support those committees as we can and as you'd like us to do so.

Linda Ark- Root Road - "I'm not looking for anything to be said to me I simply put something together and I simply want it to be a matter of the record. 'We just want to talk to everyone, feel like we're a community and we can work together'- Neadow. 'We would like to be able to look at everything that was held back from us for the last four years'- Zaepfel. It's difficult to trust these newly appointed spokespeople when the two previous statements are so unequivocally false. If you read the minutes for the last four years with eyes wide open and not closed it would be abundantly evident how the same voices of opposition were given the ability to speak month after month, year after year. The purpose of me speaking is to make sure it is a part of the town record. I'm clearly not doing it for any other purpose because that is an exercise in futility. Those of us that support solar have been called greedy and money hungry. I am so proud of those of us who support solar and we have taken the moral high road when maybe we desire to respond in a much different way. The committee being formed will be self-serving in one direction, that's not lost on me. You invite the community to have their voices heard regarding the moratorium, the real question is why? It was for show and nothing more. You couldn't even pretend to be fair minded, serving the whole community with all voices being heard. If so you wouldn't have voted immediately after. The purpose of a public hearing is for the governing body members to hear and consider the views of the public when making the decision. Maybe even to hold the record open for additional write in views. At the end you should explain the steps the board will be taking to use the information that was gathered to make your decision. Your mind was already made up. All voices being heard? Serving the whole community? Do you really know what you're doing or are you just marching to the beat of the opposition just to save face? After all, it wouldn't serve you well to change your position at this point. I just really wanted that to be a matter of the record because if you look back you will see that a lot of things were shared over, and over, and over again and all voices were heard on both sides over and over again. So if you want people to really take you at your word, you need to start with your word being accurate and that is not."

Darrin O'Shea - Pearson Road- "Has the town ever sent out like a questionnaire to every property owner in Hartland asking their opinion, not the EDF one that showed up in some pamphlet."

Elizabeth Neadow- "There was a questionnaire, I believe that was the one that was hidden inside that packet."

Darrin O'Shea-"So this was the EDF questionnaire that most people I know never even saw or knew about it. We filled it out, but I don't care what EDF thinks of it, I want to know what the Town of Hartland people think about it. The town board should be asking the Hartland people. Everyone that lives in this town and pays taxes. I'm not saying I'm for it or against it but I feel like it comes down to what the people want. That's what a republic does, it goes by what the people want. It's not a democracy it's a constitutional republic so it's based on what the people want. "

Elizabeth Neadow states this will be addressed again to see if something can be sent out to every household. At this time there is a public comment that they believe the previous mailer was formulated by previous Supervisor Annabel and put in the flyer. Elizabeth Neadow states the results were posted however she realizes a lot of people did not see this and a better way will

need to be constructed to retrieve this information. Darrin O'Shea suggests sending this questionnaire with the water bill.

Donna Weeks- Hosmer Road- You have spoken a lot of misinformation regarding solar to misinform and scare the residents of Hartland. You claim you want professionals to come speak to the people of Hartland regarding solar in our communities so I say to you, the board, do just that. Get Cornell to come to speak to the issues with the true facts about solar and how it will affect agricultural land and the environment. Cornell is highly respected and will not be biased with the facts they present. The people in this community deserve to hear the truth."

HIGHWAY

Performed winter services as needed.

Brought in 300 ton of salt.

Patched potholes throughout the Town.

- Currently we are trimming trees with the manlift. Southeast Corner of Town is complete - North of 104 from Wruck Road to Countyline Road on Town Roads.
- Truck #50 which was plowing Johnson Creek Road north of 104 had plow damage when the expansion joint on the County's Bridge over Johnson Creek raised and the plow caught it and brought the truck to a dead stop. The cutting edge was damaged, and the hitch where plow meets truck was sprung and needed to be replaced. We cut the expansion joint off with a chop saw so traffic could go thru without damaging their vehicle. County is aware and is going to remove the metal expansion joint next summer and repair the concrete on the bridge. Truck and plow are repaired and in service.
- <u>CDL License's-</u> Colby Shepard completed training and road test and received his class A, Andrew Hill completed training and road test received is class B.
- Flooding- During the rain and snow melt on January 25-26 we put up road flooded in all the usual low area's when Johnson Creek and 18-mile creek went over its banks. Opened several culverts that had snow and other items blocking flow.
- Repaired Road shoulders from flooding.
- 7520 Gow Road Called in with a drainage problem opened culverts and took out small plugs to Hosmer Road. On Hosmer the county ditch was severely plugged where we drain into it. We consulted property owner and opened County roadside ditch.

DRAINAGE

Fixed a drainage blockage in one of our ditches we maintain at 8982 Ridge Rd.
 Watson Farms where a culvert collapsed and was backing up water to all properties to the west. Owner furnished culvert and we replaced it to fix the

problem.

 Working with Niagara County to solve a drainage problem at the corner of Royalton Townline Road and Carmen. It has severe flooding every time there is a major rain event.

WATER

- Repaired a leak on the Northwest corner of Checkered Tavern Road and Ridge Road.
- Repaired a service leak at 8492 Ridge Road.
- Read meters for January see attached for water loss.

Buildings

- Septic in Highway building backed up. Cast Iron Trap was rotted out replaced with plastic pipe. Had Mahar pump the tank.
- Urinal in Town Hall men's room would not shut off replaced the flush valve.

EQUIPMENT

• 2015 Kenworth Plow truck #3- Truck is the only one that has emissions with DEF. The unit has been giving us trouble all winter with different codes which put the truck in lump mode and it will only idle. Have had to tow it in and low bed truck to S&S in Lockport for repairs. During the last major storm it was down. Last time was down for a week just got it back but have had no snow to use it. Because of this problem I have started to turn the last military tractor we have into another plow truck this will take a year.
