Supervisor Annable called the meeting to order with all present standing for the pledge to the flag.

Supervisor Annable opened Public Hearing #'s 1, 2 and 3 at 7:31 PM

#### **Public Hearing for Local Law #1-2017**

## A Local Law adding Chapter 144-17 "Solar Energy Systems"

### Date/Time/Place: January 12, 2017 at 7:30 PM at the Hartland Town Hall

Supervisor Annable asked those in attendance if anyone wished to comment on the proposed Local Law.

Attorney Daniel Seaman explained that this law sets the criteria and regulations for the operation of solar energy systems. There are three type of systems discussed, building mounted, rooftop

mounted, and ground mounted. There would not be a need for a Special Use Permit unless the system would be mounted in a side yard or in the case of a large commercial system.

With all comments being heard and addressed, Supervisor Annable closed the Public Hearing at 7:32p.m.

## Public Hearing for Local Law # 2-2017

# A Local Law adding Chapter 144-18 "Noncommercial Wind Energy Conversion Systems"

## Date/Time/Place: January 12, 2017 at 7:30 PM at the Hartland Town Hall

Supervisor Annable asked those in attendance if anyone wished to comment on the proposed Local Law.

Attorney Seaman stated the requirements of said law which establishes maintenance and fees, as well as permit revocation and violation. The windmills may be up to 165' to service a residence or building on a property. This would require a special use permit along with requirements for removal when no longer useful. It establishes setbacks from property lines.

Supervisor Annable was concerned that if in the future the height requirements would be more than 165', would the local law need to be amended?

Seaman: If that becomes the standard, down the road, then the applicant can apply for an area variance.

Annable: One company asked about a 150' height, and then most were 160-165', now some are asking about 200', in order to grab more wind.

Seaman: The tall windmills will need enough room for a fall zone, so that will limit the size of a structure. Hartland will probably deal mostly with the solar systems.

Councilman Grant: Will the higher windmills need to be lighted?

Seaman: The Federal Aviation Authority would regulate lighting specifications. There is a concern about the effect of the lighting on the neighbors.

With all comments being heard and addressed, Supervisor Annable closed the Public Hearing at 7:40 p.m.

## Public Hearing for Local Law # 3-2017

A Local Law adding Chapter 144-19 "Commercial / Industrial Wind Energy Conversion

Systems"

## Date/Time/Place: January 12, 2017 at 7:30 PM at the Hartland Town Hall

Supervisor Annable asked those in attendance if anyone wished to comment on the proposed Local Law.

Attorney Seaman: This law is composed with several parts, set forth to protect the health, safety and well-being of the Town residents. This is modeled after the Somerset wind turbine law with some differences. Article 10 of State law allows the State to supersede local municipal rule, unless the law proves to be unduly burdensome, so that is why this local law is very specific, with 14 sections.

With all comments being heard and addressed, Supervisor Annable closed the Public Hearing at 7:44 PM.

No vote was taken at this time, pending a recommendation from the Niagara County Planning Board.

  capital improvements mandated by consent orders from government agencies, and
  investments in municipal infrastructure to enhance ecomomic capacity and community
  development; and to
- Examine and report on the property tax cap's impact on local government operations and infrastructure:
- To fund and/or eliminate state mandates, provide meaningful state aid, reform the real property tax system and address cost drivers in the provision of local government services/operations in order to lower poperty taxes for all New Yorkers
