Supervisor Annable stated that the work on Robson Road has begun. The salt shed is up, and we have applied for a grant as well as he is hoping to convert the grant that was for the courtroom to be used for the salt shed.

WATER REPORT: Read and filed

ASSESSOR / CEO REPORTS: Read and filed

Assessor Hartman reported that sales are still extremely high and a reval should be considered. He stated that because the market is so crazy, a 100% reval will set the values too high. He suggested every 2-year re-assessment with 10% a year. If nothing is done, he projects our equalization percent to be 64% next year, which would affect those with exemptions. If the market goes down, he can always back off the increase. Hartman would like to hire his Royalton clerk to work part time at Hartland to do inventory on all parcels. This would be a 2-year project. He would like her to work 4 hours on Fridays. Supervisor Annable and the board will discuss this and possibly work it into the 2022 budget.

Supervisor Annable stated that the new figures from the Census show that Hartland's population is under 4000 down from 4119.
