HIGHWAY REPORT: Read and filed

Superintendent Hurtgam reported that basic highway work continues. Robson Road is scheduled for a complete rebuild in July. The footers for the new salt shed have been poured and the walls will be delivered, the project will be completed within a month. The electronic recycle and tire report is filed.

Irrigation meters have been installed. Water loss for May is 14.13%, which is up slightly from last month.

PUBLIC PARTICIPATION – AGENDA ITEMS:

Councilman Grant expressed gratitude for the work that Norm Lajoie and Audrey Jones on the Hometown Hero project. On behalf of the Veterans and the Town board, he thanked them for honoring our hometown heroes.

Councilman Grant also recognized and thanked Greg Soemann for organizing a crew and donating his time to hang the banners along Ridge Road.

OLD BUSINESS:

Mike Weber has requested the location for the mural project. It had been discussed to place it on the west end of the Highway building, but after review, the park will be considered.

NEW BUSINESS:

The Public Hearing on Local Law #2-2021, Declaring Excessive Lighting a Nuisance in the Town of Hartland, had been left open for further discussion. There were several items to be considered and amended. The measurement of lighting was increased to a reasonable range. The person who would be in violation would be determined by the Code Enforcement Officer and the case would be referred to the Court. The measurement would be considered by the casting of light across the property lines to not cause problems with the neighbors or traffic. Shielding of the lighting and requirements for the shielding was a possible solution, however, the parties could not agree. This precipitated the need to adopt a Local Law that clearly guides the position and conditions for outdoor lighting. This will prevent problems in the future. A penalty for the violation was discussed.

ADOPTION of Local Law #2-2021 entitled

A Local Law Declaring Excessive Lighting a Nuisance in the Town of Hartland

MOTION by Councilman Huntington, seconded by Councilman Grant to adopt the following Local Law:

WHEREAS, a Local Law has been introduced before the Town Board entitled "A Local Law Declaring Excessive Lighting a Nuisance in the Town of Hartland", and

WHEREAS a public hearing regarding the proposed Local Law was held on April 8, 2021, and

WHEREAS, said Local Law is classified as an Unlisted action under State Environmental Quality Review regulations, and

WHEREAS the Town Board finds that having a Local Law regulating excessive light uses is beneficial to the health, safety, and welfare of the residents of the Town, and

WHEREAS the Town Board finds that said Local Law will not have any significant adverse environmental impacts due to its intent to reduce excessive lighting within the Town,

NOW, THEREFORE, BE IT RESOLVED, that the Town Board herby declares said Unlisted action requires no further action under the State Environmental Quality Review Act, and be it further

RESOLVED, that the Town Board hereby approves said Local Law entitled "A Local Law Declaring Excessive Lighting a Nuisance in the Town of Hartland."

Charter Franchise Agreement

RESOLUTION 83-2021

MOTION by Councilman Reed, seconded by Councilman Hill to adopt the following Renewal Agreement with Spectrum Northeast, LLC:

WHEREAS, an application has been made to the Town Board by Spectrum Northeast, LLC, an indirect subsidiary of Charter Communications, Inc., for approval of an agreement to renew the cable television franchise for an additional fifteen (15) years, and

WHEREAS the Franchise Renewal Agreement would bring the franchise into conformity with certain provisions of the Federal Cable Communications Policy Act of 1984, and

WHEREAS, Charter Communications has substantially complied with the material terms and conditions of its existing franchise and with applicable law, and

WHEREAS, the quality of the Charter Communications service, including signal quality, response to customer complaints and billing practices has been in light of community needs,

NOW, THEREFORE, BE IT RESOLVED, that the Town Board hereby renews the cable television franchise in the Town of Hartland for fifteen (15) years commencing on the date of approval by the Public Service Commission, and be it further

RESOLVED, that Supervisor W. Ross Annable be and hereby is authorized and directed to sign and execute the agreement accomplishing said renewal.

Vortex/ Sole Source Supplier

BE IT FURTHER RESOLVED that this Standardization Resolution to Vortex products shall stay in effect for future purchases.
