HIGHWAY REPORT:	Read and filed

The hot box truck had a fire in May, since it is under warranty; it was sent back to Michigan for repair. Repair on Pearson Road, but will wait to pave until the farm equipment use is slowing. The 2017 F150 sold at auction for \$2,200 above the guarantee. Hurtgam reported that the Tire and Electronic drop off ran smoothly.

The diamonds in the park are ready for the season. The Termite backhoe has been worked on for the cemetery and the debris is cleaned out of the creek that is used for irrigation in the cemetery.

Councilman Grant explained that the cemetery has so much water now because there was a logger who was cutting the trees and dropping them into the creek and it was backing up into the cemetery. The Town has cleaned the area. Grant asked that the Board consider installing a 2" line down the driveway and a 2" hydrant with a regulator. This would save with dealing with a pump. The Board agreed that the system needs to be updated. Grant on behalf of the cemetery thanked the Town Board for all the help with the new tractor.

Superintendent Hurtgam has hired an engineering student from UB to work for the summer. He has recently attended a 3 day training at Cornell.

The fuel bid is in the process of being amended and will be advertised.

## WATER REPORT:

The Townline Road extension is underway. Installed several irrigation meters. Veratti Farms has requested to purchase water at the resident rate, rather than the out of town rate.

### **PUBLIC PARTICIPATION:**

Eagle Scout, Jeff Chapman, from Troop 23 approached the Board to request permission to work on LeValley Cemetery as his Eagle Scout project. The work on the stones was begun by Eagle Scout, William Woodman and Scout Chapman would like to continue with the next 3 rows. Supervisor Annable recently attended a class on how to repair old gravestones and would like to offer his help and advice with the project. Jeff would like to begin as soon as possible.

## **NEW BUSINESS:**

Historian, Norman LaJoie announced that his book <u>"Our Story"</u>, a history of the Town of Hartland is completed and has been printed. This endeavor has taken many years and precise work to complete. Mr. LaJoie thanked everyone who has helped with the details and then presented a copy to all the members of the board and the Town Clerk. A round of applause followed for the much deserved author.

Town Clerk Boyler administered the Oath of Office to Suzie Spicer, who was hired as a Parttime Deputy Clerk in the Town Clerk's office.

Attorney Brian Seaman explained a Local Law that would provide that no exemption from taxation shall be applicable with respect to any solar or wind energy system or farm waste energy system. If there is nothing in place, then the solar fields would be exempt from taxes. The Town can opt out of this program which would then make them 100 % taxable. The Town could accept an exemption as a PILOT. The process would require:

1. Notice to the Town

2. The Town would then have 60 days to respond and enter into the PILOT. If the Town does not answer within the 60 days, then the property would be tax exempt for 15 years.

Seaman recommended that there be a set of rules and stipulations that would apply and that there would be a standard procedure for all. It was decided that there should be a Work Session to discuss the details before presenting.

A combined Royalton/Hartland Work Session is planned for Thursday, June 28, at 5PM, to discuss the Frost Law. David Orr form Cornell is willing to meet with both boards to put on a presentation.
