# ASSESSOR / CEO REPORTS: Read and filed

Assessor Hartman reported that the Tentative Roll has been filed in the Assessor's office. Grievance day will be Tuesday, May 28, with 1 session that will run 4 - 8 PM.

# **CEO** Read and filed

Hartman reported that there have only been 4 permits issued; it has been too wet to build. All new violations will have 14 days to comply or they will be sent to the court. Currently all cases that have been sent to court have been fined and are now cleaned up. After the complete loss of the house on the corner of Checkered Tavern Road, the owner does not plan to rebuild. The question of whether the Town could bill for the cost of demolishing a structure after a fire was raised by the Supervisor. Superintendent Hurtgam stated that the Town has never charged in the past for emergency removal.

# **HIGHWAY REPORT:** Read and filed

Superintendent Hurtgam reported that the crew has been battling with the trees affected with the Emerald Ash Bore Beetle. They have taken down 146 dead trees that were in the right of way. National Grid had come in and tagged all trees that needed to be taken down. The concerns are that a tree will fall in the right of way and cause a fatality. Since the emerald ash bore beetle is a huge problem, this will affect the trees for years to come.

All damage from snow plowing has now been repaired. Screened millings to use for recycle and to top the new driveway to the splash pad.

The 2 New Holland tractors will not be delivered until September, so the Superintendent Hurtgam will not take the old ones to auction until then.

#### **WATER REPORT:**

Read and filed

Installed a new guardrail at the Town Park. Installed a new driveway and parking area from the fire hall parking lot to the splash pad. Fencing has been ordered for the splash pad. The hot water heaters have been reinstalled for the Snack Shack.

Administrative Assistant, Janet Slack stated that the tire collection day is all set, no tractor tires will be accepted and all tires must be off the rim.

In honor of Armed Forces Day and Memorial Day, Supervisor Annable read the names of Hartland residents who lost their lives serving as police officers and those who gave the ultimate sacrifice while in battles of the Civil War, World War I and II.

#### Law Enforcement Officers, buried in Hartland Central Cemetery:

Police Officer Jared Forsyth, age 33, killed during a Firearms Training Accident, April 13, 2015

Niagara County Deputy Sheriff, Howard Mead, age 62, died from a fatal injury while struggling with two prisoners at Niagara County jail. Mead was a Major with the Military Police during WWII

Deputy Sheriff Lawrence McParlin, age 35, was shot and killed while serving a summons on May 21, 1918 in Washington DC

# Civil War

Captain Benjamin Foote, Co. E 8<sup>th</sup> NY Cavalry, killed during the battle of Brandy Station June 9, 1863

Lt. Carlos S. Smith, Co. E 8<sup>th</sup> NY Cavalry, killed at Broad Run, Virginia during the Bristoe Virginia Campaign, October 14, 1863

Corp. Henry H. Bickford, Co. E 8<sup>th</sup> NY Cavalry, was awarded the Medal of Honor for his role in stopping the Confederate attack on Fort Stedman, Virginia, March 25, 1865

Brothers; Samuel and William Nichols served together in the 2<sup>nd</sup> NY Independent Battery. They both were captured and spent time in a southern prisoner of war camp. The head stones read "A victim to rebel starvation" They are buried in Stewart Cemetery.
