A Special meeting of the Town of Hartland, County of Niagara, State of New York, was held on the above date at the Town Hall, 8942 Ridge Road, Gasport convening at 5:00 p.m.

Supervisor Annable opened the meeting at 5:18 pm to discuss the 2021 Preliminary Budget. The general tax will go up .05 cents and the water will decrease by \$1.01, resulting in an 11% reduction in taxes next year. Only those residents who live within the Village limits will see an increase because they do not pay town water, they will not benefit from the water reduction. The rate will be \$2.62/thousand.

The Hartland Volunteer Fire Company will receive an additional \$12,000.00 to assist in repairing their parking area in exchange for lifetime use of the lane. This will be paid out of the fire fund.

Refuse rate is up \$10.00 per unit.

Water is down \$1.24 from \$2.26; we have a fund balance.

Councilman Grant asked how many properties got a raise in assessment. Supervisor Annable answered that the assessment does not always increase to the selling price, only if there have been improvements made to the property. The town is now at 88%, the prices have been stagnant for many years. If there were a total re-Val, then the entire town would see increases in assessment.

Supervisor Annable asked if there were any other items for discussion.

With no further questions the board voted to adopt the final budget.
