**Preliminary Budget for the Town of Hartland for fiscal year beginning January 1, 2021**

**Hearing # 1 – 2021 Budget**

Hearing was called to order by Supervisor Annable.

Town Clerk, Cynthia Boyler noted the annexed notice of the hearing on the adoption of the Preliminary Budget.

Pursuant to Section 108 of the Town Law, the proposed salaries of the following Town Officers are hereby specified:

SUPERVISOR: \$ 18,884.00

TOWN CLERK: \$ 53,400.00

COUNCILMAN: (4@) \$ 6,343.00 each

SUPERINTENDENT OF HIGHWAYS: \$ 49,945.00  
JUSTICE: (2@) \$ 19,023.00 each

With everyone desiring to be heard, had been heard, Supervisor Annable closed the hearing at 7:03 p.m.

**Hearing # 2 – Amounts to be raised by taxation**

Hearing was called to order by Supervisor Annable at 7:03 p.m. on the amounts to be raised by taxes and Fire Districts as follows:

Hartland Water District	\$ 319,000.00
Hartland Fire Protection	\$ 238,315.00
Hartland Refuse	\$ 290,790.00

Supervisor Annable stated that the breakdown per thousand was as follows:

Water down from \$ 2.26 to \$1.74, General Fund up .05 cents to \$ 2.62/ thousand.

With no one desiring to be heard, Supervisor Annable closed the hearing at 7:05 p.m.

**Hearing #3 – Fire Protection Contracts**

The following amounts were listed for the fire protection contracts:

Hartland Volunteer Fire Co., Inc.	\$ 139,450.00
Gasport Fire District # 1	\$ 32,521.00
Middleport Volunteer Fire Company No. 1	\$ 45,503.00
Miller Hose Company, Inc.	\$ 10,833.00
Wrights Corners Fire Co., Inc.	\$ 3,664.00

Each fire protection contract shall run from January 1, 2021 through December 31, 2021 and shall thereafter be automatically renewed on a yearly basis until December 31, 2021 unless terminated according to the provision of Section 184 of the Town Law.

Amounts of \$750.00 will be paid to the Towns of Hartland, Middleport and Royalton for the payment of physicals for the firemen.

With all comments being heard and addressed, Supervisor Annable closed the Public Hearing at 7:07 p.m.
