Resignation of Linda Ark

RESOLUTION 135-2017

MOTION by Councilman Huntington, seconded by Councilman Grant to approve the resignation of Linda Ark as Deputy Clerk in the Town Clerk's office, effective December 31, 2017.

Supervisor Annable stated that the County water rates would be increased by .15 cents, reflecting on that he would like to raise the Town rates by .20 cents per thousand to compensate. The minimum would remain at \$ 16.00 and increase all other tiers by .20 cents. Irrigation would remain the same rate; we pay .90 cents and charge \$1.40. Out of Town customers would raise .20 cents per thousand, with \$50.00 being the minimum charge.

Rate increase for water rates

MOTION by Councilman Reed, seconded by Councilman Grant to approve the increase in water rates, by .20 cents per thousand.

Attorney Seaman reviewed the rate increase and suggested that since the out of town rates are double the in town rates, then the increase should also be doubled and the increase should then be .40 cents per thousand.

Spectrum, (Charter Communications), has conducted a study for a build out of addresses to be covered by 2020. A mapping program for individuals to check on the availability to their properties in conjunction to the expansion is ready. The Town may give the website address to individuals who inquire; however, the privacy of all must be protected. The information is not subject to FOIL.

RESOLUTION 140-2017

Councilman Huntington introduced Local Law # 1-2018 to amend the Town of Hartland Zoning Map.

Be it enacted by the Town Board of the Town of Hartland as follows:

The Zoning Map of the Town of Hartland is amended so that the parcel with Tax Map No. 71.00-1-25.2 is changed from General Business Use District to One – Family Residential Use District.

This law shall be effective upon filing with the Office of the Secretary of State.
