CHAPTER 73: PARKING SCHEDULES

SCHEDULE I. HANDICAPPED PARKING.

- (A) For every 20 parking places in front of or adjacent to any public building in the town, there shall be 1 space marked distinctly, Parking for Person with a Physical Handicap. (Prior Code, § 10.32.010)
- (B) The town shall provide for signs to be erected designating the parking places, which signs shall be adjacent to and visible from the parking stall. (Prior Code, § 10.32.020)
- (C) (1) It is unlawful for any person to park or leave standing any vehicle in a stall or space designated for physically handicapped persons, if, immediately adjacent to and visible from such stall or space, there is a posted sign known as the international wheelchair symbol consisting of a profile view of a stylized wheelchair symbol with occupant in white on a blue background, unless the driver of the car or a passenger in the car is handicapped.
- (2) For the purpose of this schedule, the following definition shall apply unless the context clearly indicates or requires a different meaning.

HANDICAPPED. Either having a physical condition requiring the use of a wheelchair, artificial limb, crutch, cane or walker or having a physical disease making it difficult or impossible to walk more than 25 feet without shortness of breath or danger of impairment of health. A certificate by a person licensed to practice the healing arts in the state shall be acceptable by the town as evidence under this schedule.

- (D) Reserved Parking Handicapped Only (symbol) shall be established on the south side of U.S. 4 (Main Street) from a point 175 feet east of the east curbline of S.R. 140 (Jefferson Street) to a point 205 feet east of the east curbline of S.R. 140 (Jefferson Street), a distance of approximately 30 feet. (Prior Code, § 10.32.040) (State Order 22498R, passed 4-19-1954)
- (E) Signs erected shall conform to the manual on traffic control devices standards for designating handicap parking and shall be erected in a manner that does not create a traffic hazard. (Prior Code, § 10.32.050)

SCHEDULE II. LOADING AND UNLOADING.

(A) The Board of Trustees is hereby authorized to determine the location of curb loading zones and
shall have placed and maintained appropriate signs indicating the same.
(Prior Code, § 10.36.010)

- (B) No person shall stop, stand or park a vehicle for any purpose or period of time other than for the expeditious loading or unloading of passengers or materials at any place marked as a curb loading zone (during hours when the regulations applicable to such loading are effective) and when signs are erected giving notice thereof, loading zones are approved for the following locations from 7:00 a.m. to 6:00 p.m., except Sundays and legal holidays:
- (1) On the west side of the Public Square on the Washington Street at the south end of the Public Square as marked;
- (2) On the west side of Jefferson Street, north of Main Street, from a point ___ feet north of the north line of Main Street to a point ___ north of the __ line of Main Street; and
- (3) On the west side of Washington Street, south of Main Street from a point ____ feet south of the south line of Main Street, to a point ____ south of the south line of Main Street.

- (C) Freight carrying vehicles of 1-ton capacity of more or vehicles of more than 20 feet in length shall not park within the business district, except for the purpose of loading or unloading freight. (Prior Code, § 10.36.030) (Ord. 1-56, passed 11-7-1956) Penalty, see § 10.99

SCHEDULE III. PARKING RESTRICTIONS.

This schedule shall regulate the parking of vehicles on the streets and roadways in the town.

- (A) All vehicles must be parked parallel with the curb or edge of the roadway and within 12 inches thereof, unless otherwise provided by this schedule, and no person shall park any vehicle otherwise in accordance with this schedule.
- (B) The Council shall permit on certain designated streets and parts of street vehicles to be parked at angles or angle parking. Angle parking shall not be permitted on any state highway, except in accordance with proper resolution of the state's Highway Commission.
- (C) When property signs are in place, no person shall park a vehicle at anytime upon any of the following described streets or parts of streets:
 - (1) On the west or inbound traffic side of Jefferson Street from Morgan Street to Carey Street;
 - (2) On the east side of Harrison Street from Third Street to Madison Street;
 - (3) On the south side of Pine Street from Adams Street to Madison Street;
 - (4) On the west side of Adams Street from Main Street to Third Street;
- (5) On the west side of Adams Street from Penn Street to Carey Street, from the north edge of the school ground to Carey Street;
 - (6) On the east side of Washington Street from Penn Street to Carey Street;
 - (7) On the north side of Carey Street from Jefferson Street to Adams Street;
- (8) On both sides of Penn Street (or the alley immediately north of the school ground) from Washington Street to Adams Street; (Ord. 1-56, passed 11-7-1956)
- (9) On the east side of Adams Street from Morgan Street to the Athletic Field of Charles A. Beard Memorial School Corporation;
- (10) On the south side of Jackson Street from Madison Street to Hill Avenue; (Ord. 1-65, passed 11-3-1965)
 - (11) On the east side of Franklin Street from Brown Street to Morgan Street;

- (12) On both sides of Adams Street from Silver Street to North Street; and
- (13) On east side of Harrison Street from Third Street to Carey Street. (Ord. 1-67, passed 11-15-1967)
- (D) When proper signs are in place in each block, no person shall park for longer than 2 hours at any time between the hours of 7:00 a.m. and 6:00 p.m., except on Sundays and legal holidays, upon any of the street or parts of streets as follows:
 - (1) Both sides of Main Street from Adams Street to Franklin Street;
- (2) Both sides of Jefferson Street from Brown Street to the first alley south of Main Street, which alley is parallel to Main Street;
- (3) Both sides of Jefferson Street from Brown Street to the first alley south of Main Street, which alley is parallel to Main Street;
- (4) Both sides of Washington Street on the west side of the Public Square; (Ord. 1-56, passed 11-7-1956)
- (5) The town parking lot on the east side or real estate owned by Knightstown Methodist Church; and
- (6) The town parking lot on the north side of the real estate owned by the Knightstown Baptist Church.

- (E) No person shall park any motor vehicle or permit any motor vehicle belonging to the person to be parked, upon the street of the town for any period longer than 72 hours. (Ord. 3-53, passed 8-20-1953)
- (F) No parking any time shall be established on the south side of U.S. 40 (Main Street) from the west curbline or S.R. 140 (Jefferson Street) to a point 190 feet west of the west curbline of S.R. 140 (Jefferson Street, a distance of approximately 190 feet. (Prior Code, § 10.45.010)
- (G) No person, firm, corporation, agent or employee shall park a 1-ton truck or larger capacity or what is commonly called semi-trucks or semi-trailers, with or without the tractors attached hereto on the public streets or alleys of the town, except when the vehicle is in the process of loading or unloading and such vehicles that are parked on the streets and alleys of the town for a period less than 2 hours. (Ord. 3-75, passed 10-15-1975)

- (H) Parking on the Town Square shall be regulated in the following manner:
- (1) When appropriate signs are in place, no person shall park a vehicle between the hours of 8:00 p.m. and 4:00 a.m. in the absence of a valid parking permit on the Town Square.
- (2) When appropriate warning signs are in place, the vehicles of violators shall be towed at the owner's expense.
- (3) A valid permit allowing parking on the Town Square between the hours of 8:00 p.m. and 4:00 a.m. may be obtained from the Town Clerk-Treasurer but only for those persons who live or work in the area during the prohibited parking times. The cost of a parking permit shall be \$10, which shall be refunded when the permit is returned to the Town Clerk-Treasurer. The permit must be displayed on the rearview mirror of any vehicle parking in the restricted area.
- (4) The above restrictions shall not apply to special events and activities on the Town Square which are sanctioned by the Town Council.
- (5) (a) Violations of this division shall be punished by a fine of \$75 and each day of violation shall be considered a distinct and separate violation.
- (b) Violations of this division shall result in a penalty of \$75 per violation and shall be enforced by the Ordinance Violations Bureau upon the terms and conditions set forth at Ordinance 3-1990, adopted by the Town Council.
- (6) To the extent that this division is inconsistent with any previously adopted ordinance, this division shall control.
