2020 Poverty Guidelines Resolution

Resolution Number _2019-11-12-01_

WHEREAS, the adoption of guidelines for poverty exemptions is within the purview of the township board; and;

WHEREAS, the primary residence of persons who, in the judgment of the Supervisor and Board of Review, by reason of poverty are unable to contribute to the public charges is eligible for exemption in whole or part from taxation under Public Act 390, 1994 (MCL 211.7u) as amended by PA 620 of 2002; and

Whereas, pursuant to PA 390, 1994 as amended, Melrose Township, Charlevoix County adopts the following guidelines for the Supervisor and Board of Review to implement. The guidelines shall include but not be limited to the specific income and asset levels of the claimant and all persons residing in the household, including any property tax credits, filed in the current or immediate preceding year.

To be eligible, a person shall do all the following on an annual basis:

- 1) Be an owner and occupy as a principal residence for which the exemption is requested.
- 2) File a claim with the supervisor or board of review for each year claimed along with state and federal income tax returns for all persons residing in home.
- 3) Provide proof of ownership if Board of Review requires it.
- 4) The total income of all occupants of the property for which the exemption is being claimed may not exceed 120% of the federal poverty income standards annually determined by the U.S. Department of Human Services.

Approved Asset Test

- 1. Things of value that a person can own and are exempt from consideration in determining eligibility for a poverty exemption.
 - a. Applicant's principle residence
 - b. One motor vehicle per working adult.
 - c. Essential household goods.
 - d. Personal assets of any nature with a total value up to \$10000
- 2. The Board of Review shall consider the value of the assets, or indebtedness otherwise owned by the applicant (except those exempt from consideration as listed above), shall not exceed \$15000.

NOW,THEREFORE BE IT HEREBY RESOLVED, that the Board of Review shall follow the above stated policy and guidelines in granting or denying an exemption for the _2020_ tax year, unless the Board of Review determines there are substantial and compelling reasons why there should be a deviation from these policies and these are communicated to the claimant.
