AIRPORT COMMISSION MEETING REGULAR BUSINESS MEETING May 8, 2019

NCM, Chris Donovan of Boston Executive Helicopters and Matt MacDonald of the Norwood Record are recording this meeting.

PROJECTS

AIP Project Update: Jeff Adler, DuBois & King
 MassDOT was approached about supplying additional funding to finish the project because of
 the overruns due to the environmental issues. MassDOT is willing to contribute. They also said
 they would move forward with funding the outstanding balance to the contractor. Taxiway D
 will be able to be completed with this money.

On a motion made by Mr. Odstrchel and seconded by Mr. Shaughnessy, the Commission voted 4/0 approve Pay request No. 4 for AIP project in the amount of \$426,696.45, 100% MassDOT funded.

Technical Master Plan, Jeff Adler, DuBois & King
 The public hearing was held. Comment period open until Friday to accept comment.
 Comments will be addressed. Draft submitted to FAA and MassDOT. Goal will be to address comments from FAA and the public and finalize the document. Mr. Donovan was the only tenant at the meeting.

On a motion made by Mr. Odstrchel and seconded by Mr. Shaughnessy, the Commission voted 4/0 approve Pay request No. 6 for AGIS in the amount of \$14,831.52. FAA's portion is \$13,348.37; MassDOT's portion is \$741.58; Norwood Airport's share is \$741.37.

MassDOT Amendment to Standard Contract AIP Project No. 3-25-0037-38
 There is an amendment to 435,459.06 to cover the Taxiway A project, change orders 1 and 2.
 This covers the engineering as well as construction.

On a motion by Mr. Shaughnessy and seconded by Mr. Sheehan, the Commission voted 4/0 to have the Chairman sign the standard contract form with the amended amount of \$435,459.06.

AIRPORT MANAGER'S REPORT

 Mr. Maguire discussed the Airport Manager's Report.
 Administration building should be complete by the end of July. Vegetation Management Program, Solitude Lake Management of Shrewsbury will be doing the work. It is 100% funded by the State.

On a motion by Mr. Shaughnessy and seconded by Mr. Odstrchel, the Commission voted 4/0 to approve the Airport Manager's Report.

OLD BUSINESS

Boston Executive Helicopters' fuel truck operating in vicinity of helicopter circles.
 On February 11, the NAC received two letters from helicopter operators complaining about BEH's fuel truck driving around the south end helicopter circles for no apparent reason. The BEH fuel truck delayed helicopter operations for two helicopters according to the letters. Both letters expressed concerns of unsafe operation by BEH fuel truck. The Chairman recommends a letter to be sent by the airport manager to BEH expressing concerns by tenants and management of the airport of unusual and unsafe operation by BEH fuel truck and to use better judgment in the future.

NEW BUSINESS

- Commercial permit interest, Southern Airways Express
 Mark Cestari of Southern Airways Express made a presentation about their company. They would like to launch their first route in New England this summer between Norwood and Nantucket.
- Parking lot grant
 Mr. Ryan discussed the grant from MassDOT for a 22 space parking lot. There will be handicapped parking and accessibility for the Mark Welch Administration Building. It will provide handicap access to the viewing area. The parking lot will be environmentally friendly.

Advertisement for proposals, Lot A, B, C
 There was discussion regarding the lease of the property. A formal vote is needed to lease the property.

On a motion by Mr. Sheehan and seconded by Mr. Odstrchel, the Commission voted 4/0 to make available for lease lots A, B and C, totaling approximately 95,446 square feet for aircraft parking, aircraft ground handling, fueling of aircraft and construction of an aircraft hangar for a lease period of 20 years beginning on November 1, 2019. The ground lease rate shall begin at 51 cents per square feet and is based on current ground lease rates charged by the Norwood Airport Commission. In said lease, rates shall increase by 2% each year from years through year 10 and increase by 3% in year 11 through year 20.

• MassDOT pay request #1, Tower Construction re: fit-out of airport administration building. On a motion by Mr. Shaughnessy and seconded by Mr. Odstrchel, the Commission voted 4/0 to submit payment to MassDOT in the amount of \$49,305.85.
