WHEREAS, Act 156 of 1917 authorizes any city, village, county, township, or school district, to operate a system of public recreation and playgrounds, acquire, equip and maintain land, buildings, or other recreational facilities, employ help as needed; vote and expend funds for the operation of such system; and

WHEREAS, the Township of Norwood wishes to create a system of public recreation and playgrounds;

THEREFORE, BE IT RESOLVED, that the Norwood Township Board hereby creates a Parks and Recreation Commission;

BE IT FURTHER RESOLVED, that the Parks and Recreation Commission shall consist of eight (2) members. One shall be from the Township Board, two from the Township Planning Commission, and five at large members. Members of the Parks and Recreation Commission shall be appointed by the Township Board. Each member shall serve a four year term, except the initial appointments. The initial appointments shall be made in such a manner that the terms of office of two members shall expire each year on December 31. Thereafter, each year two members shall be appointed for four years.

The Parks and Recreation Commission shall elect from within its membership a chairman and other officers it deems necessary and adopt bylaws and rules and regulations necessary for the proper conduct of its duties.

The Parks and Recreation Commission shall operate a system of public recreation, subject to the approval of the Township Board, with power to conduct and supervise public playgrounds, parks, athletic fields, recreation centers, and other recreational facilities and activities on properties owned or controlled woulden.

by Norwood Township or on other properties with the Aconsent of the owners thereof.

It shall have the power to conduct any constructive form of recreation or cultural activity designed to employ the leisure time of adults and children.

The Parks and Recreation Commission shall have the power, subject to the approval of the Township Board, to select and appoint competent and qualified persons, such as Recreation Director, Assistant, Supervisors, Leaders, and other such personnel as necessary for the proper conduct of public recreation and parks program.

The Parks and Recreation Commission shall prepare their annual budget for submission to the Township Board. They may also solicit and receive any gifts or bequests of money or other recreational property or any donations to be used for recreation and parks purposes.

The Parks and Recreation Commission shall prepare and submit an annual report to the Township Board, along with any other reports as may be requested by the Township Board.

The Parks and Recreation Commission shall, when a new park is proposed or a new park is expanded, (either geographically or services provided) submit the proposal to the Township Planning Commission, for their review and suggestions. Once the review is complete, the proposal will then be submitted to the Township Board.

All resolutions or ordinances or parts thereof in conflict with the provisions of this resolution are hereby repealed.

a special meeting was held on 22 January 1979 at the Norwood Township Hall for the purpose of upgrading the Norwood Township Park. Township Board Members present were: RIETSMA, FARRELL, LORD, CAMPBELL and BOGART. Planning Commission members included: POTTER, SMITH, RICHARDSON and JARKIETSKI. Foring Aministrator PEARL was also present.

Meeting was called to order by Supervisor FAPRELL who introduced MR. DAVID WARKER representing the Northwest Michigan Regional Planning and Development Commission. His presentation consisted primarily of counties, townships, etc., applying for Federal grants for coastal zone projects, along with developing critical areas thru DNR and local grant programs. He gave detailed information regarding requests for proposals, format for submission of applications to provide seed money for local projects - such monies to be primarily used for planning purposes, i.e., site design etc. Money is available on a matching basis - 20% local, 80% State money funded - to be used for surveying, site design, planning. Low cost construction money is available for restoration, enhancement, fund a boardwalk, go thru wetlands and educational purposes. a feasibility study is required to explore the best alternatives. October 1 is deadling for funding. Other funds for projects are available. For information regarding this funding, contact JOHN HESS, County Planner and also the Charlevoix County Planning Commission. Nevertheless, an Outdoor Recreation Planner is required. The name of JOHN VILICAN of Southfield, Mi., was submitted by BOGART. Hiring a Planning Consultant to work with the Planning Commission and Township Board was recommended by WARNER. GORDIE FRASER & ASSOCIATES of Traverse City were mentioned as possible consultants. Plans are definitely needed for all Land and Water programs. The average size of grants allocated for this year have been in the \$20,000.00 range. CAMPBELL suggested that \$2,000.00 for planning money is what the township could afford at this point in time.

A general discussion followed plus a question and answer period. Contact Persons named were: RISTSMA, PEARL AND RICHARDSON. These persons will work directly with DAVID WARNER regarding park proposals. When submitting application for park funding include map of Charlevoix County plus Norwood Township Park Area also a copy of County Recreation Plan available from JOHN HESS.

Meeting was adjourned.

THE ORGANIZATIONAL MEETING was called to order at 7:50 PM by acting Chairperson Leslie Vanderjagt.

NOMINATIONS for chairman were opened. Lesite Vanderjagt was nominated chairman by Pearl, seconded by Lord. Sotion passed. There were no other nominations.

CHAIRMAN VANDERJAGT asked for numinations for secretary. Williams numinated Doris Pearl for secretary, seconded by Lord. Motion passed. There were no other numinations.

CHAIRMAN VANDERJAGT requested suggestions for immediate gomls for the Park and asked that we all think about long-term goals and envision what we would like the Park to become. This will be discussed at a later date.

IMMEDIATE GOALS

1 RECOMMENDED MOTION: Remove the underbrush along the bluff and below the bluff so that people on the level area (picnic) can see the lake and so that anyone driving by could observe what is going on along the beach area. Clean up this area and kill or control the poison ivy. Motion was moved by Lord. seconded by Williams.

The commission also discussed the possible need for a DNR permit since this area is close to the beach area. We also discussed the need to protect this area from erosion which may occur if too much vegetation is removed. We agreed to leave any/all healthy trees which are presently growing, our concern is with the underbrush.

Lord said that he would check on poison try control. Bon Contright of the Cooperative Extension Office in Boyne City said that the best product to eradicate poison try was Zeb. It should be sprayed on while active growth is occuring. May-June is best. I quart to 20 gallons is the formula. With the size area we me taiking about the best way to apply this is with a farmer's sprayer. (He suggested we contact Dave Parsons). If after we spray the first time, new growth tecomes active. It should be sprayed again. This can be purchased by anyone at any farmer's Co-op. This product will kill out all broadleaf plants, including summer and trees. So any trees that we do not want to kill, we should avoid getting too close to. This will not kill grasses. So he did not think we would have to be too concerned with erosion on the hillside.

2 RECOMMENDED MOTION: If pichic tables are put back into the

park, we would recommend that they only be made of pre-formed cement. Motion moved by Williams, seconded by Hannerberg. Motion passed.

Several other Ideas were discussed including the planement of a retired couple in a mobile home to watch the Park; eliminate the sign which now exists and replace it with a small, attractive wooden sign with an 8 x 10 copy of the Park rules on it such as the State Parks use; possible implementation of 1900 Master Plan by Site Planning; having a work bee day of residents to help with efforts in the Park.

- CALL TO ORDER Chairman Vanderjagt called the meeting to order at 7:14 PM.
- II. ROLL CALL Vanderjagt, Pearl, Parsons, Lord and Hammerberg present. Drewa and Alpert absent.
- III. READING/APPROVAL OF MINUTES Minutes were read by Pearl. Motion to accept the minutes as read by Parsons, seconded by Hammerberg.
- IV. BUSINESS
 Minutes of the Norwood Township Board's December 11, 1989
 meeting were reviewed and discussed. Number of members on
 the park commission was a concern. Parsons said he would
 check into the law on it.

Several items were then discussed by the Commission members. Using the 1980 Master Plan for the Norwood Township Park as the basis, the following additions/changes were made:

- 1 Poured trailor pad for caretaker's trailor. NO improvements to the Park unless a caretaker will be on the premises from Memorial Day weekend until at least Labor Day weekend and possibly until the end of October.
- 2 Holding tank that can be pumped out for caretaker's sewage. (Doubtful that a Health Department permit could be obtained for a standard septic field.) Possibility of combining holding tank for both public outhouse and caretaker's use.
- 3 Electrical service for the caretaker's trailor.
- 4 Well drilled for the caretaker's trailor and line run to picnic area.
- 5 Telephone and emergency hook in (radio or phone) either to sheriff's office or DNR office of the Fisherman's Island State Park or both.
- 6 Ten (10) picnic tables with attached seats of poured cement or other indestructible material located in the picnic area.
- 7 Eliminate all fire rings from the beach area and relocate five (5) fire rings constructed of two large tire rims welded together in the picnic area.

- 8 Picnic pavillon with pre-formed indestructible stationary tables and benches.
- 9 Poured cement single building outhouse with free standing privacy walls, eliminating the need for doors.
- 10 Eradicate all polson Ivy.
- 11 Clean out excess underbrush, prune nice trees.
- 12 Excavate and level berm in picnic area.
- 13 Eliminate parking area on North side of Lake Street. Create single-car pull-in parking areas on both sides of North Lakeshore Drive that lends itself to development.
- 14 Eliminate the boardwalk. (In the future the back area may lend itself to developing a nature walk).
- 15 Boulders placed in front of parking areas on the West side to prevent infringing on the picnic area.
- 16 Mulch (wood chips/shredded bark) spread on picnic area. This will allow ease of walking for the first tew years and will establish a good base for grass in the future.
- 17 Excavate and stabilize a parking area for the boat launching area at the end of Lake Street. Permanent boat launching should be established for fishermen's small boaters use.
- V. RESOLUTION Moved by Parsons to adopt the above changes to the 1980 Master Plan for Norwood Township Park. Seconded by Lord. Passed.

Pearl agreed to check into monies available for development of parks. She also agreed to check into availability of former DNR personnel to act as caretakers for the Park.

VI. ADJOURNMENT Meeting adjourned at 9:24 PM
