### GENERAL STIPULATIONS

- No portion of the fence shall project beyond the property line.
- No fence shall extend toward the front of the lot farther than the front building line.
- Fences containing barbed wire, razor wire, spikes, nails, sharp points, or electric current or charge are prohibited
- No fence shall be erected in excess of six feet (unless otherwise required by city ordinance), or less than three feet in height above the grade of the surrounding land. No chain link fence shall be erected in excess of four feet, or less than 30 inches
- It is the responsibility of the property owner of which the fence is located to repair, upkeep, maintenance, and reconstruction of any such fence and any area adjacent thereto. Routine maintenance and repair must be able to be completed from the property on which the fence is located.
- The finished appearance of the fence must face away from the owner's property. The fence must be designed or located so as to permit the cutting of vegetation which grows between the lot line and the fence or between the existing fence and the new fence.
