**Opioid Class Action Lawsuit:** State of Missouri received \$730,000 grant for opioid addiction prevention and recovery efforts, to be divided out between state's seven regions.

County Clerk: HB 1631 lawsuit about Voter I.D.'s received a judgment to prohibit the State of Missouri and the Secretary of State (lawsuit's defendants) "from requiring voters otherwise qualified to cast a regular ballot under section 115.427.2 to execute the sworn statement set out in section 115.427.2(1) and 115.427.3." The Attorney General's Office filed an appeal of the decision and an emergency stay to the ruling October 11, 2018. The motion to stay the ruling is still pending.

County Clerk's office has voting tabulator set up in back room, where in-person absentee voters can immediately cast their ballots after voting. Sales Tax Distribution Notice for September 2018 published to Commission.

Road & Bridge: Weekly report submitted. Foreman Kempker summarized safety meeting and Pipeline meeting for Commission, stating that both went well. On October 15, new grader broke down with sensor issues, which will be covered under warranty, and expected to be fixed today, October 16.
