# **Meetings:**

#### **Old Business:**

**BRO Project, CR 531:** Commissioner Kliethermes reported that he has received the deed and will take it out to get the owners signatures tonight and will get it recorded. Presiding Commissioner Dave Dudenhoeffer signed the Floodplain Permit for CR 531.

**T Sheets Software:** Deputy County Clerk Nicci Bouse provided an update on T Sheets and that most of the problems have been resolved. Most employees are becoming familiar with it and we should be ready to use this for April pay checks. Deputy Clerk Bouse has brought the cost down to \$2,000 per year for as long as we use the service.

#### **New Business:**

Commissioner Kliethermes made the motion to accept and sign Resolution No. 5-2018, the Multi-Jurisdiction Natural Hazards Mitigation Plan; the motion was seconded by Commissioner Glavin, and motion carried with three ayes in the roll call vote.

Sheriff Department: Sheriff Bonham discussed options with the damaged wall in Cell D

**Road and Bridge Department:** Written report was provided by Foreman Ron Kempker. T 31 is about ready to be fired up and returned to work. T47 is still a work in process.

# County Clerk:

County Clerk Steele reported that he had met with Lucas Honn of Farm and Home Publishers yesterday about the agreement for the contract for the 2015 Plat Book. He offered to let Osage County print the second part of the original agreement in 2019. Clerk Steele asked to have that plat book printed for sale in December 2019. **Sheriff:** Sheriff Bonham said the cell was damaged by an inmate who had managed to break the concrete board. He said that the best option was probably the use of stainless steel as suggested by Commissioner Kliethermes. It was discussed that 16-gauge stainless steel should be used. Presiding Commissioner said that Scotty Dudenhoeffer should be able to do the repairs.

Sheriff Bonham announced that they have been awarded the \$400 Check it or Ticket grant; they have received \$700 in cash toward the new K9 member of the Sheriff Department.
