BRO Project, CR 531: Commissioner Kliethermes reported that he still had one more sheet that needs to be signed by the owners agreeing to waive any cost for right of way as they have agreed to donate ROW. He is having the deeds recorded today and he will get them to MoDOT. Donation letters still need signatures.

New Business:

There was a brief discussion about the letter that was delivered to the Commissioners, the Unterrified Democrat, and the County Clerk by the Assessor after the April 19th meeting. He surrendered his Gas Card from the County because a statement was made that the policy is that County Gas Card should only be used to put fuel in County vehicles.

Departmental Reports:

Sheriff Department: Sheriff Bonham left a bid for stainless steel panels for repair of the walls of the jail cell. He was advised contact local companies to get bids from them.

Road and Bridge Department: T47 has been put back in service. The blade and old bed will be scrapped. Send form to County Clerk with the old number to remove from inventory. Bed rail and spreader bar will be added by R&B crew. Foreman Ron Kempker was given approval to seek an assistant Foreman from within the department with interviews the week of May 21, 2018

County Clerk:

911: Andi Rice talked about the mobile training she attended last week. She met the County 911 Director from Hamilton County Ohio and he shared the tapes and lessons learned from that tragedy. There will be an active shooter training done with the Sheriff's Department to keep 911 staff on their toes.

Public Comments:


