- -Commissioner Darryl Griffin went over the closing on CR 611. It is still going to be closed, waiting to here from the engineers from MoDOT. The county has no jurisdiction over it, we understand it needs to be open.

# Road and Bridge:

- -Foreman Ron Kempker presented Foreman's Road Report for October 1st October 8th, 20193
- -Kempker stated that they are hauling rock on CR 503 for the next two weeks, it's an ongoing thing. Then we will have most of our pretty well caught up.
- -Road and Bridge hired another hand, Steven Brey started Monday.
- -Commissioner Kliethermes asked about hauling gravel on CR 521? Kempker responded they are still on CR 503 now, Kliethermes said he received a call this morning asking about it. Kempker stated it is in time. We will try to haul some there and back on CR 505. We should get a little better rock, beware the road is riffled from trucks going in and out, it will take a little bit to get the road straightened back up, but it will happen. Kempker, you will just have to be patient we will get it straightened up.
- -Commissioner John Glavin asked Kempker if they were still going to fix the box on CR 275.
- -Kempker said some Missouri S&T students were down meausing the shed and the bathrooms again.

#### **Sheriff:**

- -Sheriff Bonham presented commission with a lighting strike letter from MoPERM.
- -Speed Trailer can be set up where ever you want it, it is in Westphalia now, it will measure speed, vehicles, and it will give you a timestamp data.

-Sheriff Bonham and the Commission discussed the traffic issue about State Tech and the high school/elementary. He said it's flowing better. However, some days there is traffic backed up from Tech to the courthouse. They are going to add another 2 million dollars building and another 500 students. The best solution is to add another drive or a roundabout. Commissioner Kliethermes said there are more apartments going up. Commissioner Griffin said Preston Kramer from MoDOT agreed to do another Hwy study, Tom Hurst informed me of it. Foreman Ron Kempker said the traffic is backed up for Road and Bridge, so they have to go a different route. Sheriff Bonham said he spoke with Dr. Strong and Amy Ames, and they feel that the problem is going to get better. Sheriff Bonham would like to sit down with State Tech, and MoDOT when they new Hwy study is done. Bonham said I guess we will have to wait and see. The traffic isn't bad in the evenings, but awful in the morning. Sheriff Bonham said they are always looking for grants, the public safety grants are harder to get due to the fact they think we don't have problem.
