Approval of the Agenda and Minutes:

-District 2 Commissioner Larry Kliethermes moves to approve the Agenda and Meeting Minutes, seconded by District 1 Commissioner John Glavin with a few changes, followed by 3 ayes in a roll call vote.

Bills, Notes and Communication:

- -Bills were approved Commissioner Kliethermes made a motion to approve the bills, Seconded by Commissioner Glavin, followed by 3 ayes in a roll call vote.

- -Commission asked if damages were to occur on the roads with the heavy machinery who should be contacted? Wagner informed commission they could contact him and he would reach out to Tulsa.
- -As of right now the crews are working 12-hour days at 6 days a week.

Road and Bridge:

- -Foreman Kempker present commission with his road report.
- -Kempker stated that yesterday they had the plow trucks out so everyone could get use to their new routes.
- -He believes everything is going to run smoothly when the first big snow hits.
- -Chief Deputy Hamilton thanked Foreman for bringing his crew to the County Clerk's office last Tuesday to fill out the FormFire. Hamilton stated that everything went smooth.

Sheriff:

- -Sheriff Mike Bonham stated they will be using backup vehicles in case of inclement weather.
- -Bonham stated that another deer was hit, this time it was the 2017 Durango. A report was made by the Highway Patrol.
- -The sheriff's office is preparing a 10-year strategic plan. So far it is up to 58 pages. This is to bring acknowledgement to the citizens regarding the tax that was voted in.
- -Sheriff Bonham had asked Commissioner Kliethermes if he had heard anything regarding the flooring in the jail, Kliethermes stated he has not heard back yet.
