- Sheriff Bonham made the commissioners aware that the City of Linn Maintenance shed was burned last night. Bonham feels the county needs to take precautions immediately. They lost 2 backhoes, partial damage of tractor, total loss of 2 trailers. Upon arrival, the perpetrator was in the third building attempting to set that one on fire as well. There is a person of interest. City of Linn Police have requested the help of the Sheriff. Bonham has requested for additional back up from other agencies. The Sheriff's office requests the public to provide the city with any kind of videos they may have. Bonham will be doing a walk through at the Road and Bridge to identify any potential vulnerabilities.
