Beginning At The Southeast Corner Of Section 36, Township 42 North, Range 11 West; Thence Westerly Along The Southern Boundary Of Section 36 And Section 35 To The Southwest Corner Of Section 35, Township 42 North, Range 11 West; Thence Northerly Along The Western Boundaries of Section 35, 26, And 23, To The Corner Common To Sections 14, 15, 22, And 23, All In Township 42 North Range 11 West; Thence Westerly Along The Southern Boundary Of Said Section 15 To The Southwest Corner Thereof; Thence Northerly Along The Western Boundary Of Said Section 15 To It's Intersection With The Common Boundary Of Cole And Osage Counties; Thence Northerly And Easterly Along Said Common Boundary Of Cole And Osage Counties To the intersection with the centerline of U.S. Highway 50; thence Easterly along the centerline of U.S. Highway 50 to the intersection with the centerline of U.S. Highway 63; thence Southerly along the centerline of U.S. Highway 63 to the intersection with the Southern Boundary of Section 26, Township 43 North, Range 10 West; thence Westerly along the Southern Boundaries of Sections 26, 27, 28, 29 and 30 to the southwest corner of Section 30, Township 43 North, Range 10 West and also being on the Range Line between Ranges 10 West and 11 West; thence Southerly along said Range Line between Range 10 West and Range 11 West back to The Point Of Beginning.
