Motion made by G Johnson to accept the Treasurer's report, seconded by M Brown. Motion carried.

PARK & RECREATION Still waiting on grant. Bushes are planted. Pavilion was rented 12 times in August. Discussion about fees.

CEMETERY Survey finished on east line, fence needs to be put in. Grace markers are on order. Ground radar is scheduled for Sept 9 & 10

COUNTY COMMISSIONER Airport cutting 250 trees for runway clearance. Air Show #10 was a hit but not doing another. Money is dedicated. Trail ribbon cutting is 9-27-19 with time to be announced. Trail washed out in few spots which will be fixed by M & M. Maintenance system will have to be set up for future problems. Pipeline 5 has engineering on site.
