# **Recreation Plan**

# Introduction

Because of the recreational opportunities in Otsego Lake Township, the abundance of natural resources and the desire to make recreation a key component, the Township created a Recreation Plan 2006.

In past years, the Township has provided recreation services and facilities to residents and visitors. The mix of Township owned, along with publicly and privately owned facilities, offers a wide range of passive and active recreational opportunities. A description of these facilities is included in the recreation inventory, which begins on the page six (6). Otsego Lake Township plans not only to continue providing recreation services to its residents and visitors, but to maintain the existing facilities, keeping them compliant and updating where necessary, with the Americans with Disabilities Act (ADA), which mandates accessibility standards for citizens who have mobility difficulty.

As a recreation service provider, the Township recognizes the importance of planning for future recreation services and facilities. A major factor in the provision of any service is the question of how projects will be funded. One possible source of funding for recreation projects is through grants available from Michigan Department of Natural Resources (MDNR).

To become grant eligible for MDNR funding, a community must have an approved recreation plan. Components of a MDNR approved recreation plan include:

- Community Description
- Recreation Inventory
- Administrative Structure
- Description of the Planning Process
- Action Program
- Basis for the Action Program
- Plan Review and Adoption

# **Grants and Capital Improvement Plan**

A Recreation Plan can be used as a guide for future public investment and service decisions, such as the local budget, grant applications and administration of utilities and services. Many communities find it beneficial to prioritize and budget for capital improvement projects, such as infrastructure improvements, park improvements, etc. A Capital Improvements Program (CIP) is one tool which is often used to establish a prioritized schedule for all anticipated capital improvement projects in the community. A CIP includes cost estimates and sources for financing for each project, therefore can serve as both a budgetary and policy document to aid in the implementation of a community's goals defined in the Recreation Plan.

# **Location and Regional Setting**

Otsego Lake Township is located along the southern border of Otsego County, which is situated in the north central part of northern Michigan's Lower Peninsula. Otsego Lake Township is a standard geographic township in area, (approximately 36 square miles), with 32.7 square miles of land area.

The Township is bounded on the north by Bagley Township, the west by Hayes Township, the east by Chester Township all in Otsego County, and on the south by Maple Forest Township in Crawford County. The City of Gaylord is approximately six (6) miles north of the Otsego Lake Township border. Figure one (1) illustrates the township's proximity to a number of other communities in Michigan.

A more detailed description of the Township along with socio-economic characteristics, natural environment data and existing land use patterns can be found in the Otsego Lake Township Master Plan.

# **Inventory of Recreation Facilities in Otsego Lake Township**

## Americans with Disabilities Act Compliance

With the passage of the Americans with Disabilities Act of 1990 (ADA), all areas of public service and accommodations became subject to barrier free requirements, including parks and recreation facilities and programs. The ultimate goal is to provide recreation opportunities that include everyone regardless of physical or mental impairment. When evaluating the accessibility of parks and facilities, barriers should be recognized from the perspective of the participant. These perspectives aid in preparing the design and planning future improvements to both current and existing facilities. Therefore, we can determine whether a site, building, and/or facility comply with the Americans with Disabilities Act Accessibility Guidelines.

## **Transition Plan**

Capital improvement expenditures are targeted for comprehensive accessibility projects. All new playground equipment, site furnishings, landscaping and facilities included in the capital improvements plan shall be designed and installed in compliance with the latest adopted U.S. Architectural and Transportation Barrier Compliance Board and U.S. Department of Justice standards.

# **Other Otsego County Recreational Facilities**

Residents of Otsego Lake Township can also utilize recreational facilities outside the township bounds. Information on recreational opportunities outside of Otsego Lake Township was obtained from the Otsego County Recreation Plan by the Northeast Michigan Council of Governments. There are a number of additional public and private recreational facilities in Otsego County. County/State parks and campgrounds offer a wide range of recreational activities from picnicking and baseball to hiking and swimming. The local public schools within the county also all have recreational facilities. Ten (10) other sites offer water recreational opportunities that are not classified as campgrounds or local government and private parks.

These public access sites have boat launches, parking areas, and toilets. All are maintained by the Michigan Department of Natural Resources. In addition, there are many privately owned recreational facilities open to the public. The county recreation plan also indicates there are approximately twenty (20) resorts for anglers and hunters scattered throughout the county, some of which are located in Otsego Lake Township.

## Trails

There are numerous recreational facilities classified as trails that are in or run through Otsego County. These trails include approximately one hundred forty-five (145) km of walking, hiking, biking and cross country skiing trails and approximately ninety-three (93) miles of signed and groomed snowmobile trails.

## Fairgrounds

The Otsego County Fairgrounds are located on Old 27 north of Gaylord. The fairground facilities consist of exhibit buildings, grandstand, track, and food booths. The fairground is used for an annual fair, a car show, snow-cross and a flea market.

# **Regional Recreational Opportunities**

Several communities in the surrounding area have varied recreational opportunities. To the north, the City of Gaylord has a number of recreation facilities such as a golf course, a historical museum, athletic fields, elk viewing and many resorts.

Additionally, Gaylord has the Otsego Regional Airport, the Otsego County Fairgrounds and the Sportsplex, which has a community hockey rink, walking track and indoor pool. There are also ski clubs, State groomed cross country trails, and over twenty-five (25) golf courses in the region. Nearby Antrim and Crawford Counties offer a number of indoor and outdoor recreational opportunities, similar to those found in Otsego County.

# Administrative Structure and Funding

Otsego Lake Township established a Parks and Recreation Advisory Committee in August of 2007. Working with the Otsego Lake Township Board, it helps oversee the development of recreation facilities and programs within the Township. The Committee serves as a community sounding board on recreation matters and brings the concerns of the residents to the Township Board for consideration.

Recommendations for recreation planning are made by the Parks and Recreation Advisory Committee to the Township Board, which has final authority for recreational policy, administration, and funding. The Committee is responsible for updating the recreation plan. The Township Board must adopt the recreation plan and approve any amendments to the plan.

The Otsego Lake Township Parks and Recreation Advisory Committee consists of five members: chairperson, vice chairperson, secretary, two (2) alternate members with one (1) Board member representing the Township Board.

The Otsego Lake Township Board consists of five members: supervisor, clerk, treasurer, and two trustees.

The Township Supervisor is the chief executive officer of the township and chairs the board of trustees. The Township Clerk is responsible for keeping the Township records, paying bills, voter registration, and cemetery records, while the Treasurer is charged with keeping the Township's financial records, including receipt of tax payments and management of investments. The Fire Chief is responsible for overseeing all activities of the Fire Department/First Responder Service.

Volunteers are an integral part of the recreational projects in Otsego Lake Township. On a project by project basis, volunteers are solicited to provide some of the labor for the Township "in-kind" match. The routine park maintenance is handled by the Township staff, contractors, and volunteers, all operating under the direct authority of the Township Board.

Other recreational facilities and activities utilized by local residents are administered both formally and informally by organizations serving multiple jurisdictions. Otsego Lake Township is located partially within the Gaylord Schools district and partially within the Crawford-AuSable School district, making recreational facilities and activities of both school districts available to Township residents. Township youth may also participate in non-school related recreation organizations. Since both school districts have facilities of their own, they are not directly part of this plan. This plan does include provisions to continue and enhance the working relationship with Michigan Department of Natural Resources as related to the state-owned recreation facilities located within Otsego Lake Township.

Otsego Lake Township's recreational activities and facilities are primarily funded through the Township's general fund. Table four (4) illustrates recreation spending for the past three (3) years, in comparison to the Township's total budget. For the proposed 2011-2012 budget, \$30,000 has been budgeted as a Park and Recreation line item, demonstrating that the Township Board consistently allots funding for recreational purposes.

# **Description of the Recreation Planning Process**

Revisions to the existing Recreation Plan, created in 2005 by the Otsego Lake Township Planning Commission, began in the spring of 2011. The Otsego Lake Township Parks and Recreation Advisory Committee updated the document to reflect the accomplishments of the past five (5) years.

To encourage public participation in the recreation planning process, all meetings with the Otsego Lake Township Parks and Recreation Advisory Committee were open to the public and posted at the Township Hall. Throughout the summer months, at least one (1) member of the Parks and Recreation Advisory Committee attended a meeting for each association within the Township. A short power point presentation was shown and handouts were given for public comment. Public appreciation for the Township's efforts was expressed.

Finally, interested citizens were invited to attend a public hearing on December 29, 2011. Notice was published in The Gaylord Herald Times, on the Township website, as well as posted in local public places. One (1) interested citizen attended the public hearing. After the public hearing, the complete document was finalized for initial submittal to MDNR.

# **Recreation Goals**

Otsego Lake Township, because of its environmental attributes, expanses of state land, and low population density, currently enjoys a favorable reputation as an outdoor recreation area. To sustain and increase the current level of recreational activities for all age groups, the Township should continue to encourage the growth of open-space recreation.

• Develop multi-purpose pathway in the commercial area and throughout the Township.

• Provide additional active recreation facilities to meet the needs of residents and visitors of all ages.

• Encourage operation of public and private camping facilities at designated locations of the Township.

•Through zoning and review procedures, proposed subdivisions, site condominiums, planned unit developments, commercial and industrial developments should be encouraged to provide or participate in the development of neighborhood parks.

• Maintain open space and scenic vistas by encouraging PUD, clustering, and conservation easements.

• Maintain existing and establish new trails for horseback riding, bike, motorized recreational vehicle, crosscountry ski, and walking use in the Township.

• Encourage a designated and regulated snowmobile route through Otsego Lake Township to connect the community to regional state designated snowmobile trails.

Otsego Lake Township has a system of parks, ball fields, and recreational facilities. To meet the needs of a growing population and the increased tourist activity, it is important to improve and expand these recreational facilities. Recreational facilities should continue to be developed to meet the needs of the whole community, all age groups, and income levels.

• Encourage the consideration of recreational facilities as an integral part of community development plans.

• Ensure ADA compliant playground equipment for Township parks.

• Provide more public beach and water access in a park and picnic area setting for residents, seasonal residents, and visitors.

Community-wide programs that provide opportunities for year-round recreation, personal enrichment, art, musical, and theatrical groups are contributors to the quality of life and attractiveness of the Township. It is important to ensure accessibility to adequate public recreation facilities and cultural activities for area residents and visitors. Coordinated programs and facilities that reflect the character and desires of the community can play a key role in attracting new commercial and industrial activities.

• Construct a senior center with a large seating capacity to accommodate a wide variety of educational, recreational, and social activities.

• Encourage community arts and crafts, musical and personal enrichment programs for all age groups and for seasonal and year round residents.

• Encourage cultural facilities and events that meet the needs of the entire community.

#### **Township Park Improvements**

Working with the current Recreation Plan, numerous improvements have been made at the Township Park and nature trail. The parking area has been re surfaced with asphalt creating a barrier free accessible route to the pavilion. A new barrier free restroom facility has been constructed, also with an accessible route from the pavilion. New playground equipment has been installed for toddlers through preteen with a base of sand for safety and play. A basketball court has been installed and improvements have been made to the existing horseshoe pits, hiking trails and baseball field along with new signage for better awareness.

## **Action Program**

The action program is presented below in two (2) tables that describe the development of new facilities and the maintenance to existing facilities. Anticipated funding sources will be in the form of cash from the Township general fund, in-kind labor, and Michigan Department of Natural Resources (MDNR) grants. Sources of the grants are: Land and Water Conservation Fund (LWCF), Michigan Natural Resources Trust Fund (MNRTF), and other appropriate grant programs.

# **Rationale for planned Township Park and Hall improvements**

With each new improvement to the Township Park, more residents are becoming aware and the facilities are being used more and more. A tennis court with a walking track around it, adult fitness equipment, a shuffle board court and volleyball court are some of the facilities planned for the future.

With the senior population comprising a significant portion of the Township, there is the possibility of an increased demand for senior services and facilities. The Township is continuing to investigate incorporating some of the senior facility, programming and service needs within the existing Township Hall.

## **Rationale for New Trails**

There is a need and interest to provide non-motorized pathways that connect from the downtown area of Waters to the State Park, State Forest Campground and ultimately to connect into a regional trail system. The safest trails for pedestrians and bicyclists are trails which are separate from the vehicular routes. Trails throughout northern Michigan are used extensively both by local residents and tourists.

# **Plan Review and Adoption**

The Recreation Plan was reviewed by the Otsego Lake Township Board; additional public comments were accepted as part of a Public Hearing held on December 29, 2011.

The Recreation Plan was adopted by the Otsego Lake Township Parks and Recreation Advisory Committee on January 16, 2012 and by the Otsego Lake Township Board on January 19, 2012. Copies of the minutes when the Plan was adopted are included at the end of the Recreation Plan.

# **Plan Adoption and Implementation**

# **Public Hearing**

A public hearing on the proposed Recreation Plan for Otsego Lake Township was held on December 29, 2011. Notice of the review period was published in the Gaylord Herald Times on November 23, 2011. Notice of the public hearing was published in the Gaylord Herald Times, on December 21, 2011. Copies of the notices are reproduced at the end of this section. During the review period, the proposed plan was available for review on the Township's web site, at the Otsego County Library or by contacting the Otsego Lake Township Clerk.

The purpose of the public hearing was to present the proposed Recreation Plan and accept comments from the public. In addition to the Parks and Recreation Advisory Committee members and Township Board members, one (1) member of the public attended.

The public hearing began with a brief explanation of the planning process. Plan development included Park and Recreation meetings and presentations to Township Associations for input.

# **Plan Adoption**

The Otsego Lake Township Parks and Recreation Advisory Committee formally adopted the Otsego Lake Township Recreation Plan on January 16, 2012. The Otsego Lake Township Board formally adopted the plan on January 19, 2012 by official resolution. A copy of the resolution is on page twenty-five (25) and minutes from the meetings on pages twenty-two (22) and twenty-three (23) are also attached.

A copy of the Recreation Plan Certification is provided on page twenty-six (26).

The adopted plan was transmitted to the Northeast Michigan Council of Governments on February 24, 2012. (See copy of transmittal on page twenty-nine (29).)
