#### PURPOSE OF THE PLAN

This five-year plan identifies the key recreational assets of Peaine Township and the recreational goals, objectives and action programs developed for adoption by the Township Board following public input. It is intended that this recreation plan complement the 2017 Beaver Island Master Plan, which included significant public input, as well as recreation and eco-tourism initiatives island-wide. It is also intended that this plan integrate with the St. James Township Recreation Plan, when combined, would which, serve as а comprehensive recreation plan for all of Beaver Island.

#### **1. COMMUNITY DESCRIPTION**

#### The Beaver Island Archipelago

The Beaver Island Archipelago includes 14 islands that vary in size, biodiversity and ownership. While this Recreation Plan is focused on Peaine Township, it is important to describe the cultural resources, recreational opportunities and land ownership of several of the larger islands in the archipelago. Of the Beaver Island Archipelago, most are within Charlevoix County. North and South Fox Islands are part of Leelanau County.

#### **Beaver Island**

Located about 30 miles offshore from the City of Charlevoix, Beaver Island is the largest island in Lake Michigan, with approximately 56 square miles of land. Beaver Island is unique for many reasons, including a beautiful natural environment with plentiful sand dunes, beaches and wetlands, a distinctly diverse ecology and a close-knit community with a proud island heritage. Beaver Island is the only island in the archipelago home to a permanent population (with the exception of staff at Mirada Ranch on South Fox Island), with a scheduled ferry and an on-demand chartered airline service.

#### Garden Island

Garden Island is 98% owned by the State of Michigan and is overseen by the Michigan Department of Natural Resources (DNR). Once fished, farmed and logged by the Anishinaabe and other groups, Garden Island has a Native American cemetery, an abandoned sawmill, and several standing structures.

#### **High Island**

High Island is 100% state-owned land and is currently uninhabited. The island was originally named after a mountainous sand dune on its western edge. In the past, Native Americans and settlers lived on the island in small numbers. The island is occasionally used by researchers and the DNR owns several cabins currently in disrepair.

#### Hog Island

Hog Island is the fourth largest island in the Beaver Island Archipelago and is 100% state land. The island is characterized by a number of wetland areas that are home to a variety of rare plants and animals. Hog Island also provides vital spawning ground for perch and small-mouth bass and draws many rare and unique birds during migration.

#### Whiskey Island

Whiskey Island is state owned and is uninhabited. Whiskey Island is home to one of most visible shipwrecks in the archipelago, the wreck of the Chandler J. Wells.

#### North Fox Island

North Fox Island is state owned but has been inhabited by private owners in the past. The island has an operational runway.

#### South Fox Island

South Fox Island is partially state-owned (about one-third) and partially privatelyowned. The island has a paved runway, a private residence, two lighthouses and a Native American cemetery for members of the Grand Traverse Band.

#### Other Islands

Other islands in the Beaver Island Archipelago include Gull, Squaw, Trout, Grape, Hat, Shoe and Pismire.

#### Peaine Township

Beaver Island has a land mass of 56 square miles with Peaine Township encompassing the southern portion of the island. The defining features of Peaine Township are its abundant natural resources, forests, wetlands, inland lakes and beaches. While the Township has a few commercial establishments including a gas station, restaurant, plant nursery, gravel pits and two airports (Beaver Island Airport and Welke Airport), most of the Township is characterized by open space. This is in part because 12,507 acres of Township land is owned by the State of Michigan and classified as a "wildlife research area." Further, development has mostly occurred along the shoreline and many of the homes are not visible from the road. Much of the development that has occurred inland is nestled in the woods and also not easily visible from the road. A small portion of the interior land is currently being used for farmland. The total number of households in 2017 was 280, an increase of 22 from 2010 (2017 ACS estimate).



As stated in the 2013–2018 Peaine Township Recreation Plan and restated in the 2017 Beaver Island Master Plan, Peaine Township is a recreation and tourismbased community. Its population and housing gains are attributed largely to the growth of second homes, retirees and seasonal tourism. This slowed during the first decade of the 21st century due to the economic recession of the state and Midwest region. Yet tourism, with its short-term visits and seasonal residences, remains the Township's (and island's) main economic driver. This economic catalyst requires proper access to and conservation of the unique features of the island. Therefore, it is of critical importance that the Township's recreational assets, especially its natural features and sensitive natural areas, be retained now and into the future. If they are lost or destroyed, these features may not be easily replaced and the island will lose its essence and distinctive sense of place.

#### Population

Peaine Township saw population increases from 1990 to 2017 at rates higher than St. James Township, Beaver

Island, Charlevoix County and the State of Michigan as a whole (See Table 1). While this increase in residents was more drastic between 1990 and 2000 when the population nearly doubled in size, this trend of growth has largely plateaued since. As illustrated in Table 2, Peaine Township's population is expected to increase slightly over the next 20 years, with a projected population of 269 by 2030.




Figure 1. Change in Number of Residents by Age, 2000-2017, Beaver Island

#### Age

The majority of Peaine Township residents are age 45 and over. The median age, as shown in Table 3, rose from 49.5 in the year 2000 to 58.2 in 2017. Shown in Table 4, there are relatively few schoolaged children living in the Township. The age groups that saw the greatest increases in percent of the total population between 2000 and 2017 were those 60 to 84. Nearly all of the middle-aged and younger population distributions saw decreases in their proportionate size to the overall population. Table 5 shows a similar trend happening in St. James Township. The island's population change over time can therefore be summarized as follows: The middleaged population has reached retirement age and the younger generations are not growing fast enough to keep up proportionally.

#### Race

Most residents on Beaver Island are White (Table 6), though the Hispanic population in both Townships has slightly increased since the year 2000 (Tables 7 and 8). There is also a small population of individuals identifying as Native American or Alaskan. Overall, the distribution of races has remained largely the same over the past two decades.

#### **Poverty and Education**

While individual poverty rates increased in Charlevoix County and the State of Michigan between 2000 and 2014, Beaver Island has seen a reduction in the percentage of residents experiencing poverty. Peaine Township, as shown in Table 9, slightly increased in the total number of impoverished individuals during the 14year span, though this socioeconomic group now makes up a smaller percentage of the total population. Furthermore, St. James has seen a reduction in poverty in terms of the number of individuals as well as their percent of the overall population. In contrast, poverty rates in Charlevoix County and the State of Michigan increased by 67.3% and 59.9%, respectively.

Peaine Township residents have a relatively higher level of academic achievement than the State of Michigan as a whole. Twenty-seven percent of Township adults over 25 years old have acquired a graduate or professional degree, double the rate for Charlevoix County and the State of Michigan. In addition, 74.2 percent have completed at least some college or have acquired an Associate's degree. Just 2.1 percent of Peaine Township residents did not graduate high school according to 2017 estimates.

Because of the reduction in school-age youth, enrollment in Beaver Island Community School has followed a downward trajectory since the 2010-11 school year. Shown in Table 11, enrollment rates have dropped by nearly 25 percent during the past decade. Charlevoix-Emmett school enrollment rates have experienced a similar reduction in recent years.

#### Housing

The housing trends in Peaine Township and Beaver Island are linked to the aging population trends, as well as the lower school enrollment rates. Between 2000 and 2017, Beaver Island's percent of owner-occupied housing units decreased from 31.6% to 27.1% (see Table 12). The renter occupancy rate also saw a minor decrease. The greatest percent increase in housing units came from those that are seasonally used. Seasonal homes grew from 463 (62.5% of housing stock) to 699 (67.5% of housing stock) during the 17-year span. This means that the vast majority of the Island's housing units are occupied for only part of the year. Tables 13 and 14 show that despite the increase in the total number of owner-occupied and seasonally used housing units, Beaver Island's properties have lower equalized and taxable values than in 2010. Peaine Township's equalized values for residential properties decreased from nearly \$103 million in 2010 to just over \$79 million in 2019. St. James Township's equalized and taxable property values have followed the same pattern as Peaine. In contrast, Beaver Island's agricultural, commercial and industrial property categories have all increased in value during the past decade.

#### 2. ADMINISTRATIVE STRUCTURE

Peaine Township is governed by an elected Township Board consisting of five members (a Supervisor, a Clerk, a Treasurer and two trustees). This board adopts the annual levy and budget of the Township. The following describes how recreation functions are carried out in the Township:

- The Township Board takes direct responsibility for policies and operations of Township-owned recreation assets. It also shares in the costs of recreation assets owned jointly with St. James Township. Paid services such as maintenance are performed by employees or contracted out.
- The current Peaine Township budget (April 2019-April 2020) allocates a total of \$68,000 for parks and recreation. This is about 19% of projected (discretionary) revenue for the year. Detailed projected expenditures include:
  - O Township Hall & campground maintenance (wages): \$16,750
  - O Trail & campground maintenance, repairs and supplies: \$9,700

- O Trail maintenance and improvements: \$11,160
- O Emergency call towers: \$7,700
- O Capital outlay for new outhouses: \$4,000
- O Historical Society: \$12,000
- In addition, the 2019-2020 budget includes utilities servicing the campground and Township Hall and road maintenance and snowplowing so access to the sites is maintained. These items are not accounted for separately in the budget.
- Numerous recreational activities are implemented by island organizations, such as the Beaver Island Chamber of Commerce, the Beaver Island Archipelago Trails Association, sports boosters, and the Beaver Island Wildlife Club, with many island residents and visitors taking part. In addition, a number of recreation-related businesses are active (including kayak trips and rentals, charter fishing, diving and eco-tours). The Beaver Island Community School and Central Michigan University (CMU, which operates research and educational facilities on the island) often partner with the Township. CMU's Biological Station conducts

community field trips every summer, and CMU is creating a museum with an interactive Great Lakes education and outreach exhibit as part of its new research space at the boathouse on Whiskey Point. The Historical Society is working on plans for a new museum that will contain an exhibit on the island's natural features.

#### **3. RECREATION INVENTORY**

The tables on the following pages provide a description of recreational sites on Beaver Island. These sites are organized by location. Table 15 is a summary of recreation sites located in St. James Township. Information on ownership is included as well as the access to the site and approximate size. This information was adopted from the St. James Township Recreation Plan (2018). Table 16 summarizes the same information for sites in Peaine Township. Table 17 is a listing of Beaver Island recreation projects completed with the Michigan Department of Natural Resources (DNR) grant funding. Finally, Maps 1, 2, 3 and 4 show Beaver Island's non-motorized routes, birding trails, recreational facilities and water trail access sites, respectively. There are many additional recreational opportunities not included in the tables on the following pages, including:

- The DNR owns 12,057 acres in Peaine Township. Most of the land owned by the DNR is designated as a Wildlife Research Area. The area is characterized by old logging roads, trails and forests. The land is open to the public for hunting (during season) and wildlife viewing.
- 2. Bird watching and Beaver Island Birding Trails.
- 3. The Beaver Island Water Trail.
- 4. Kayaking, canoeing, sailing and motor boating on Lake Michigan, around the shore of Beaver Island or to one of the outer islands of the Archipelago. All of High Island, Whiskey Island and most of Garden Island is owned by the DNR.
- 5. Diving. A certified diver operates a Dive Shop on the island. There are a number of shipwrecks in the area, and the clear water is highly sought after by divers.
- 6. Star gazing and astronomy. Beaver Island has a dark sky and little ambient light to interfere with viewing.
- 7. Morel, oyster and other edible mushrooms, cranberries, blueberries and apples are abundant on the island and harvesting them is a favorite pastime. Old orchards and bogs are plentiful in Peaine Township.
- 8. Privately owned campgrounds (two).
- 9. Golf course (privately owned).
- 10. Beaver Head Lighthouse to be developed as a county park.


#### Accessibility Assessment

The accessibility evaluations for Peaine Township have been conducted by the Planning Commission as part of the recreation planning process. The evaluations were based on the United States Access Board's Section 15 – Recreation Facilities, the Accessibility Guidelines for Buildings and Facilities, and the Americans with Disabilities Act, using the ranking criteria suggested by DNR's Guidelines for the Development of Community Park, Recreation, Open Space and Greenway Plans (2016). These criteria are based on the 2010 ADA Standards for Accessible Design. The criteria are as follows:

ADA Ranking System Rank Interpretation


- 1. None of the facilities meet accessibility guidelines.







# 4. ASSESSMENT OF PARKS AND CAMPGROUNDS

Officials from Peaine Township assessed the current conditions of public access sites and noted improvements that have already been or should be made to increase the function and aesthetic appeal of these sites for public use. It was noted at the public hearing that some of these initiatives would require land acquisition efforts by the Township or an associated entity.

#### **General Comments for All Sites:**

- Signage with a consistent theme placed at all access points. This new signage should replace much of the current signage.
- All sites with fishing access should be provided with receptacles to dispose of spent fishing lines, lures and bait.
- Trash receptacles consistent in theme with St. James and cleaner in appearance. Consider adding recycling receptacles.
- Addition of BBQ cook sites.
- Work with the DNR to utilize DNR specs for needed docks.
- Wheelchair/handicapped accessible outhouses.
- Research possible land acquisitions that would promote the implementation of items in this plan.
- Boat racks and permitting for storage. Explore the feasibility of doing this on DNR and other public entity-managed sites.
- Interpretive signage to encourage appreciation and appropriate use of recreation area.
- The addition of bicycle racks.

#### Features to Improve Compliance at Sites:

- Provide educational information for all recreational sites including permitted activities, prohibited activities, emergency contact information, ORV regulations and private/public property demarcations.
- For the previous bullet point, implement additional signage and brochures at sites and at points of entry to better circulate enforcement information.
- Consider placing trail cameras near sensitive areas to enhance enforcement efforts.
- Work with the Beaver Island Chamber to circulate information on permitted and prohibited activities at particular locations.
- Develop a visitor information center to distribute information regarding permitted and prohibited uses on the island.
- Work with Northern Island publisher on informational articles about permitted and prohibited activities.
- Improve communication with law enforcement, emergency services and Township leadership (i.e., regular reporting of incidents to Township boards).

#### Fox Lake:

- Outhouse has been paced off to indicate adjacent property line.
- New signs have been installed for boat washing.
- Signage to indicate water trail park access (GPS coordinates) for boat launch. Picnic table or seating at the site.
- Develop universal access amenities to the lake.
- Consider enhancing the 20 acres and 2,000' (Lot 11) on Fox Lake and adding signage to deter camping and fires.
- Collaborate with the DNR to designate Fox Lake as a no wake lake.
- Add trash receptacles to encourage good stewardship.
- Identify opportunities to improve parking.
- Research limitations and opportunities associated with the access site's size (66' easement).
- Add signage regarding prohibited activities (fires, camping) and permitted uses (picnicking, birding).

#### Green's Lake:

- Seating area (chairs/benches). Picnic table with cooking available.
- Boat washing sign.
- Fire and glass sign.

#### **Iron Ore Bay:**

- Determine a location for a platform large enough to accommodate folding chairs, accessible ramp for viewing and stargazing – a possible location is to the left of the creek just cresting the higher bluff.
- Installation of emergency call box.
- Add picnic tables (2).
- Possible bridge over the creek bed. Structure designed in sections for storage in the winter. Consideration for how the creek changes from year to year.
- Collaborate with St. James joint ownership.
- Better maintenance of outhouses.

#### Wagner Campground:

- Installation of emergency call box at the juncture where the old lines still exist (by the pump).
- Create a fire ring in the circle round, which is free of potential tree canopy hazard that is near most of the campsites.
- Remove old sign posts at the entrance.
- Consider placing informative sign about Bill Wagner.
- Well and shower facilities.

#### Font Lake Park:

- King's Highway signage showing park access.
- Addition of another pavilion with picnic table.
- Cook stoves at each pavilion.
- Possible addition of more picnic tables toward the landing site on Font Lake.

- Clean up debris along the south and west exposure to the existing pavilion site.
- Removal of all fallen trees.
- Directional signs to the landing site.
- Addition of a pickleball court.
- Addition of a badminton court.
- Landscaping and maintenance of the park area in general.
- Outhouses in the park area.
- Directional sign to boardwalk (not a landing site).
- Work to control blight or build an 8' fence to limit sight of blight.
- Develop bocce ball courts, restrooms and a washroom.

## 5. DESCRIPTION OF PLANNING AND PUBLIC INPUT PROCESS

#### A. Appointment of Committee

This recreation plan was developed through a set of planning and public input processes. The processes in Peaine Township began in March 2019 with a community forum attended by a broad range of Beaver Island residents including public officials; business owners; retirees; members of the planning commission, zoning board of appeals and the Beaver Island Association; volunteers; representatives of non-profit organizations; the press; and others. This forum was moderated by Kirk Welter. This initial meeting included a thorough review of the previous Recreation Plan. This meeting was publicized in a variety of places including the Beaver Island Forum, Beaver Island News on the Net, public postings and the Township website. A second follow-up meeting took place in May, 2019. The purpose of this second meeting was to review and refine the preliminary vision and goals that were created during the first input session.

Information from past planning efforts and recent community input helped to form the goals and objectives outlined later in this plan. For example, the committee reviewed survey data from the 2017 Beaver Island Master Plan update process. Many of the ideas supported in the survey related to recreation, including but not limited to developing a water trail and expanding the birding trail, improving campgrounds and increasing the quality of fishing. In addition, 54 out of 78 respondents answered that the Township "must do" or "should do" for the comment, "Look for ways to accommodate bicyclists through separate paths, bike lanes, and signs where appropriate." The survey also found that every idea for tourism that related to recreation received at least a "should do" majority vote. The results of this survey can be found in Appendix B.

# D. A One-Month Public Review and Comment Period

Before a recommended plan was submitted to the Peaine Township board for adoption, a 30-day public comment period was held. Information regarding the comment period was reviewed at a public hearing on September 17, 2019, held by the Peaine Township Planning Commission. A published hearing notice was made available for viewing to residents and all local units of government included in the plan. Following the public comment period, all of the received feedback was aggregated, analyzed and integrated into the final plan.

#### 6. GOALS AND OBJECTIVES

Setting goals for the recreation plan takes into account three factors in addition to the current preferences of Peaine Township residents, organizations and businesses:

- What has been the Township's traditional interest in recreation?
- What are the Township's financial resources?
- Given the environmental and community interdependencies of St. James and Peaine townships, which recreational priorities can be pursued solo and which require municipal collaboration?

# <u>The Township's Traditional Interest in</u> Recreation

The 2013-2018 Peaine Township Recreation Plan identified three overarching goals to promote and enhance recreation opportunities for island residents and visitors. These goals were reviewed by officials and the public during this plan's input process and were largely expanded upon for the 2019-2024 plan.

### Goals:

- Maintain and restore condition of natural resources and ecosystems that contribute to recreation and quality of life on Beaver Island.
- 2. Increase recreational opportunities, especially for youth, those with disabilities and elderly residents of Beaver Island.
- 3. Increase the recreational assets/services of Beaver Island for attracting tourists, seasonal residents and new full-time residents.

Because of the Township's limited government funding, recreation development on the island often occurs through community (rather than just government) efforts, and often with funding attracted from the state or federal governments, conservation-minded nonprofit organizations, or individual donors. Sometimes the Township provides local matching funds, but rarely provides all of the funding for a project. With the current stagnation of property values - the main source of Township government funds – and its likely continued stagnation into the foreseeable future, the strain on government resources is increasing. As a result, most recreation priorities will have to be funded the way they have been in the past, without substantial contributions from the Township. This also puts an emphasis on making sure that, even if the capital costs of a project can be covered, the operating costs are also calculated and feasible.

#### **Municipal Collaboration**

Peaine Township is only a part of Beaver Island. Because of its small size and distance from the mainland, the island's system of natural resources is highly integrated and management decisions affect the entire island. On some recreation matters it may not make sense for the Township to act on its own when collaboration with St. James Township (and the Michigan Department of Natural Resources, which manages the third of the island's land that is owned by the state) would make more sense. Peaine has tremendous opportunity for trails, land preservation, waterfront access and preservation of the character of Beaver Island.

A strong indication of the Townships' interdependence when it comes to the island's natural resources is grounded in the Beaver Island Natural Resources and Ecotourism Steering Committee (NRESC). Created in 2011, the NRESC is an advisory body appointed by both Townships with at-large community membership and representatives from the Native American tribes, the School, the Historical Society, the Chamber, the two townships, the two township Planning Commissions, the DNR, the Wildlife Club and Central Michigan University. The resolution that established the NRESC specifically authorizes the group to undertake several activities relevant to recreation planning, including:

- "Develop a plan for promoting the island as a unique opportunity for an ecotourism experience."
- "Advocate for preservation of areas where our natural resources should be preserved to enhance our ecotourism opportunities and to maintain the unique beauty of Beaver Island."
- "Identify areas for expanded and/or improved trails for nature walks. Propose improvements which would enhance the experience in those areas, such as boardwalks, benches, viewing areas, picnic tables, maps, signage, trail markers, brochures and other such improvements."
- "Identify bird-watching opportunities on the island and locations where improvements such as viewing stations and viewing equipment could be located. Create and distribute informational brochures."

 "Identify potential forest trails where forest land could be preserved, and identify old-growth access sites."

These collaborative efforts continue today with the development of the island-wide birding trail, water trail and other eco-tourism initiatives. In addition to the NRESC, Beaver Island more recently worked with the Michigan Department of Natural Resources to create the Northern Lake Michigan Islands Collaborative. This organization consists of a network of stakeholders and other interested parties that engage in discussions regarding ways to manage state-owned land in the archipelago in an effective manner. This collaborative was created as a result of the DNR's *2016 Management Plan for State-owned Lands on Northern Lake Michigan Islands*.

Through the community input process and review of past planning efforts, the following goals and objectives were created to help guide the prioritization and implementation of recreation projects in Peaine Township.

#### Goal One.

Maintain and improve the condition of the island's natural and cultural resources and ecosystems that both support recreation opportunities and contribute to the island's quality-of-life.

#### **Objective A.**

Address invasive plant and animal species that threaten natural resources and property values.

#### **Action Program**

- Prevent the introduction of invasive species to the island and control the spread of invasive species through best practices and techniques.
- Educate property owners and visitors on identification of invasive species and coordinate management across property lines.
- 3. Evaluate all recreational areas and activities to prevent and control invasive species.
- 4. Seek funding through foundations, state and federal grants, or cost sharing.

#### **Objective B.**

Continue to support the restoration and longterm preservation of key natural and cultural areas in the Beaver Island archipelago.

#### **Action Program**

- 1. Continue to support St. James Twp. in its efforts to clean up trash on Garden and High islands.
- 2. Include language on interpretive signage that addresses the "carry-in-carry-out" ethos.
- 3. Support the Little Traverse Bay Band, Beaver Island Historical Society, AMICK Society and other ongoing preservation efforts.

#### **Objective C.**

# Continue to make improvements to key recreation sites.

#### **Action Program**

- Stabilize the bluff at Martin's Bluff by providing a stairway to the beach. At present, there is a rope ladder that, when used, causes further erosion and destabilization of the bluff.
- 2. Protect the beach from erosion at Bill Wagner Campground by placing a fence between the campground and the beginning of the beach dune, providing access in only a couple of places to avoid the trampling of beach grasses. Also include signage with information about the dune ecosystem and sensitivity.

- 3. Provide a single designated fire ring on the beach below Bill Wagner Campground, as the only place where fires are allowed on the beach.
- 4. Install new fire rings at the Bill Wagner Campground that are not moveable to avoid the current condition where fires are built under trees.
- 5. Work with the Island Wildlife club to enhance fishing docks at Fox Lake and fishing docks and campsites at Lake Geneserath.
- 6. Work with Charlevoix County to continue improvements to Beaver Head Lighthouse and the surrounding park area.

#### Goal Two.

Increase recreational opportunities, especially for youth, those with disabilities and elderly residents of Beaver Island.

#### **Objective A.**

Improve the quality of year-round recreational assets that provide new opportunities for recreation and improve quality-of-life for Beaver Island residents.

#### **Action Program**

- 1. Develop more opportunities for winter sports.
- 2. Build an outdoor ice-skating rink in a central location.
- 3. Identify and groom certain trails for cross-country skiing, snowshoeing and fat-tire biking during the winter months.
- 4. Identify and maintain certain trails exclusively for snowmobiles.
- 5. Develop a fitness and recreation center for the island that includes unique features such as a pool, running track, climbing wall, etc.
- 6. Work with the Beaver Island Historical Society to develop additional natural and historical signage throughout the island.
- 7. Improve access and recreation opportunities on island lakes and beaches.
- 8. Continue to support St. James Twp. in its efforts to develop a public boat launch at St. James Harbor.
- Continue to support St. James Twp. in its efforts to work with the Wildlife Club, the USFWS and the DNR to increase healthy habitat for fish in St. James Harbor.
- 10. Continue to support traditional outdoor sporting activities such as fishing and hunting.

- Continue to support efforts of the Northern Lake Michigan Island Collaborative around decisions related to ecological management.
- Continue to contribute financially to the Community Center, as it houses many recreational activities in the winter months.

- 13. Develop a new shelter with a fire pit in the park area behind the Township Hall.
- 14. Explore the possibility of hiring a full-time recreation administrator and grant writer who also focuses on natural and cultural resources.
- 15. Develop an island-wide sign assessment and development plan that addresses signage aesthetics, consistency and readability.
- 16. Follow through on commitments to fund and make improvements to parks resources.
- 17. Build public canoe/kayak storage racks at all inland lakes. Collaborate with the DNR or other managing entities on feasibility.

- 18. Prioritize acquisition of property to support access to inland lakes for fishing and boating.
- 19. Increase parking access for paddlecraft and explore opportunity for a boat ramp at Iron Ore Park.
- 20. Develop a formal plan for boat launches around the island.
- 21. Continue to work with and support Charlevoix County, the Historical Society or other entities in their efforts to restore and develop the lighthouse area as a park with trails.
- 22. Consider news ways to better collaborate with St. James Twp. on recreational and natural and cultural resource initiatives and projects, including the creation of a Recreational Authority.
- 23. Work to establish a separated bike trail on King's Highway.

#### **Objective B.**

Improve access to recreational opportunities for residents and visitors with special needs.

#### **Action Program**

- Provide access for wheelchairs at the Iron Ore Creek by maintaining an all-terrain beach mat to the water's edge.
- Support efforts in St. James Twp. to get the St. James Public Marina certified as handicapped friendly.
- 3. Obtain adaptive recreation equipment for use by the school, residents and visitors, including all-terrain wheelchairs for beach access or a "duet" bicycle, which is a wheelchair tandem bike.
- 4. Explore opportunities for accessible kayak launches at inland lakes.

#### Goal Three.

Increase the number of recreational assets/services of Beaver Island and the archipelago that attract tourists, seasonal residents and new full-time residents.

#### **Objective A.**

Maintain existing trails and expand/connect island-wide hiking and biking trails systems around the island.

#### **Action Program**

- 1. Develop a comprehensive non-motorized trails master plan for the island.
- 2. Continue to work with the DNR to develop a water trail around the island with proper support amenities, including primitive camping stops, a boat launch at Bill Wagner Campground and an access site on the west side of the island suitable for quick emergency response.
- 3. Work with the DNR to finish the bridges on the Seven Bridges Trail.

#### **Objective B.**

Explore trail and recreational opportunities that are unique to the island and will attract tourists.

#### **Action Program**

- 1. Develop a plan to create a world-class mountain bike trail system on the island.
- 2. Develop a guide to shipwrecks around the island.
- 3. Promote diving within the Beaver Island archipelago.
- 4. Investigate the possibility of securing a marine sanctuary designation.
- 5. Continue to promote the island as a destination for both serious birding and casual bird watching.

- 6. Establish an online reservation system for the Bill Wagner Campground.
- 7. Develop brochures and online maps of the island's historical sites and recreational assets.
- 8. Develop signage that addresses safety, 911 service, emergency call systems and the limitations of cellphone service.
- Expand the current transportation system to include connections to all recreational facilities all year round.
- 10. Develop a formal boat ramp at Bill Wagner Campground.
- 11. Establish small access sites with benches at scenic locations around the island.
- 12. Develop a central guide for all of the island's recreational components for citizens and visitors.

#### **Objective C.**

Utilize the "dark skies" around Beaver Island for recreation and tourism.

#### **Action Program**

- 1. Secure a dark-sky designation.
- 2. Continue to develop and employ strategies that support the dark-sky concept, such as a lighting ordinance.
- 3. Take steps to provide additional resources in support of the dark-sky designation.

#### **Potential Funding for Projects**

Stated previously, recreation projects in Peaine Township tend to come together through the collaboration and funding of multiple partners, often without utilizing the limited resources of Peaine Township. For each of the projects in this plan, potential multiple sources of funding have been identified below:

Below are our thoughts based on the recent review of the Peaine Township Recreation Plan.

Page 15-#6 Keebler Trail (partly public/private)- it *is not public*-it runs through private property complete with deed restrictions and legal opinions about the use.

As stated in the plan, the Beaver Island Natural Resources and Ecotourism Steering Committee(NRESC) was developed to address a broad swath of interests using a collaborative model for the use and protection of island lands and interior lakes. The Northern Lake Michigan Islands Collaborative is an out growth of the NRESC to address use and assistance for state held lands administered by the Wildlife Division in the archipelago. The NRESC developed the *Recommendations for Natural Resource Management in the Beaver Archipelago* funded by

the Wildlife Division, produced a very successful Biking and Driving Guide, coordinated invasive species control, worked to secure the Fox Lake property with the Little Traverse Conservancy for the township, sponsored natural resource lectures, and resulted in the formation of the Beaver Island Birding Trail and Water Trail to name a few promotional activities. The NRESC was a very useful township advisory board in terms of project efficiency, coordination of diverse interests, and distribution of work. The current Park and Recreation does not have a committee and has never been formally adopted by the township board. This gap leaves Peaine Township's recreational potential at a disadvantage without input into promotion or assistance with development.

Priority areas to address with this updated recreational plan should include in our opinion:

\*Build into every water and terrestrial recreational activity-a threat and management plan with the intent to control the introduction or spread of invasive species. Introduction of zebra or quagga mussels will destroy the interior lake fisheries-identify education and boat cleaning recommendations. Infestations of non-native forest insects will lead to loss of mast, timber, nesting sites, be hazardous to trail use, and degrade the forests. Terrestrial invasive species once widely spread will decrease recreational access, decrease property values, and degrade the ecology of the island.

\*The Peaine Township board should consider adopting a resolution to develop and fund a committee or commission for the purpose of promoting, developing the appropriate use of the island's natural resources and the management of properties within the township boundaries. Examples of priority projects could include: redeveloping the Iron Ore Bay Park to remove existing walkway that routes the public through a dune and a stream bed in order to access the beach. Check out CZM grants for dune walkways and interpretive signage. Each interior lake and campgrounds need review, recommendations, and improvements to enhance recreational experiences. More emphasis is needed on fisheries of interior lakes and less on the harbor area. Best practices for the interior lakes should be established with assistance from the MIDNR Fisheries Division to make the lakes no wake zones due to loon nesting, no use of lead sinkers, limit live bait (control live bait to prevent the spread of infectious fish diseases (viral hemorrhagic septicemia), unwanted fish species, and invasive species) and boat cleaning station identified. Page 32 has no mention of the Water Trail Plan-utilize the 140+ page water trail site plan to implement development and secure grant funding.

\* Acknowledging that people invest and recreate on the island related to water resources and addressing any of the water recreational activities listed in this plan would be an improvement. The increased recreational pressure on the Lake Michigan shoreline and interior lakes requires addressing better access, amenities, and invasive species control. Peaine Township should look to develop their own water access and recreational opportunities with attention to identifying property acquisitions. Priority property acquisitions and site development should focus on improving recreational opportunities to interior lakes and Lake Michigan for all visitors and taxpayers. Addressing localized issues or concerns will mitigate the effects of public access.

\*Pickle ball is a popular sport on Beaver island with all of the recreational activity occurring in St. James Township. Peaine Township's Font Lake Park could be developed but burning in adjacent lots needs to be halted. Utilize the Community Center in the winter to provide for senior activities such as game board days,

arthritis classes, and pickle ball. I see no mention of the Community Center in this plan which is a fabulous asset.

\* Township goals should be reflective of the State of Michigan's 2017 island management objectives for their properties located within Peaine Township: *goals that call for effective management of the archipelago's natural resources, economic vitality and growth that results from effective management, and how education and outreach focused on unique natural, historical, and cultural resources can lead to greater appreciation and protection of those resources.*

Dear Krys,

This comment is in regard to page15/47 Table 16 listing recreation sites located in Peaine Township.

#9 lists Bonner's Bluff State Beach (Bonner's Landing) as located at the end of private road, and being accessed through private property. My husband and I are the owners of Lot 13 through which we have allowed pedestrian access to the state beach through our beachfront lot.

The concern we have is one of safety and homeowner liability with the public driving vehicles down the narrow bluff road which is maintained by the homeowners association. This road, to our knowledge, has never been maintained by Charlevoix County Road Commission below the top of the bluff.

The road provides the only ingress and egress for property owners at Bonner's Landing. At times, cars parking at the bottom of the bluff to access state land, partially block the road and limit safe access for homeowners on this single lane private road. We have also noted increased use of fat tire bikes and ATV's on the beach which contains threatened pitcher's thistle and potential piping plover habitat.

Current maps of the island are unclear regarding the start of the private road. The Bonner's Landing Association has provided signage, though this has not proved adequate. Perhaps, clarification on future maps and more official signage would be helpful. We are willing to discuss more permanent solutions for access to this state beach.

We, the undersigned homeowners of Fox Lake would like to express our thoughts about the proposed, possible purchase of the Jeff Powers land adjacent to the existing Fox Lake boat launch for the purpose of establishing a campground and the development of the 20 acre, 2000' lake frontage parcel of township land that currently exists in a natural and pristine state.

We are **strongly opposed** to this development and will take whatever action is needed to stop this. We have set forth our case for NOT purchasing NOR developing land on Fox Lake.

According to the goals and objectives listed on page 26 of the 2019-2024 Recreation Plan, The 2013-2018 Peaine Township Recreation Plan identified three overarching goals to promote and enhance recreation opportunities for Island residents and visitors. The establishment of a campground on property currently owned by Jeff Powers adjacent to the current Fox Lake Boat Launch, would be counterproductive and not supportive of the three goals stated.

The goals stated are:

Maintain and restore condition of natural resources and ecosystems that contribute to recreation and quality of life on Beaver Island.

Increase recreational opportunities, especially for youth, those with disabilities and elderly residents of Beaver Island.

Increase the recreational assets/services of Beaver Island for attracting tourists, seasonal residents and new full time residents.

The establishment of a campground on the Powers property on Fox Lake would NOT maintain NOR restore the natural resources NOR the ecosystems of Fox Lake NOR the quality of life on Beaver Island. The additional noise and disturbances could disrupt the breeding cycle of the fragile loon population. We have already witnessed this by boaters using high horsepower motors and racing across Fox Lake, sometimes even pursuing the loons. As recently as August 31, 2019 there were 2 people in a boat with a powerful engine circling the perimeter of Fox Lake at full throttle. This action was just a few feet off shore, creating wave action against the shoreline that is currently experiencing erosion issues due to an extremely high water level. The proposed campground would remove natural land as it exists now and convert it into developed land, which would be counterproductive to the preservation of natural resources and ecosystems as stated in the Recreation Plan's goals.

The establishment of a campground on the Powers property on Fox Lake would NOT increase the property value of seasonal residents NOR full time residents NOR vacant landowners on Fox Lake. The added noise and lake activity could greatly decrease the resale value of existing homes and vacant land. If we had known that a campground would be placed on Fox Lake, we never would have bought or built the homes where we currently live.

The existing boat launch has served as a place for late night activity that includes, fireworks, gunfire, loud music and noise. An expansion of this area would only make matters worse. Why is there activity at a boat launch at night with hours of activity ranging from 10 pm - 3am? Are people really launching boats at this time of the night?

People purchased land and homes on Fox Lake because of the peace, serenity, calm, natural beauty and belief in the stewardship of the land, NOT because there was a campground on the Lake.

At this point, to the best of my knowledge, there are no campgrounds on any of the inland lakes where there are residential

homes. Many questions come to mind from this proposal to build a campground on Fox Lake.

- Is there a real need to place a campground in a residential area rather than an area surrounded by public land?
- Has anyone spoken with Jeff Powers about this purchase?
- What is the current occupancy/vacancy rate at the existing campgrounds?
- Will homeowners be compensated by Peaine Township for the loss in value in their property by the establishment of a campground on Fox Lake?
- Is it necessary to take yet more property off the tax rolls?
- Where will the funding come from to purchase land for the campground?
- How will Peaine Township replace the lost tax dollars from the sale of the Powers property to a nontaxable entity?
- Where will the funding come from for the establishment of the campground, i.e. fire rings, clearing of land, picnic tables, water, emergency phones, signage, sanitary facilities?
- Where will the funding come from for the maintenance of the campground?
- Have any of the plan developers looked at the current condition of the Fox Lake Boat Launch?
- It is run down and not an appealing place. Wouldn't it be more beneficial to clean up the area, remove the dead trees and fix the road?
- Instead of a campground, wouldn't making Fox Lake a "no-wake" lake be more beneficial to the existing wildlife, peace and tranquillity of the area, help with lakeshore erosion when water levels are elevated and improve the overall ecosystem of the lake?
- Is there that great a demand for a campground for the elderly and those with disabilities?
- How do existing campgrounds attract elderly and those with disabilities?
- Is there any data to support this supposed need?
- On page 23 of the 2019-2024 Recreation Plan, it is stated that under consideration is the development of the 20 acres and 2,000' of Township-owned property on Fox Lake. Why would anyone want to "DEVELOP" a pristine natural area?
- Again, where would the funding come from to "DEVELOP" this natural area and what kind of "DEVELOPMENT"?
- The language of the "development" of the 20 acre parcel is too vague what are the particulars of this development?
- Will an impact study be done to see what harm development might be done to an unspoiled natural area?
- What rules will be put into place to govern the usage of the development of the 20 acre parcel, ie. Will hunting be allowed, overnight camping, picnic facilities?
- To those points who will maintain this area in terms of trash removal, cleanup, fire hazard, and emergency infrastructure?
- Will the township create a paid position for a maintenance person for both properties?
- Will the sheriff be able to come out and monitor these areas on a consistent basis when we start calling about noise and partying in these locations?
- How will the fire department be able to combat a fire on the 20 acre parcel since there is no access by land to the property?
- A smoldering fire site was recently reported on the 20 acre parcel of township land located at the far east end of Fox Lake. Why does humankind always think that nature has to be improved and developed?

Specifically, we would like to see the following verbiage removed from The Recreation Plan.

1. Page 23, Fox Lake: Strike "Consideration for purchase of Powers property (600 ft.) for development of campsites."

**2.** Page 23, Fox Lake: Strike "Consideration to the development of the 20 acres and 2,000' of Township-owned property on Fox Lake"

**3.** Page 23,Fox Lake: Strike "Addition of picnic tables and fire pits." Page 29, Objective C, 5. - Strike the words "Fox Lake and"
