### CITIZEN'S COMMENTS

Lucinda Murphy — Referenced Ordinance No. 20-007 (agenda item 10-B) amending the City's budget to provide for the funding of an administrative assistant position for the police department. She likes the idea but was wondering about a City dispatcher, which is something that was previously discussed. She hopes that is something that could be included in the process. She wanted to know if this was a position that has to be filled now or can this be put on hold for a while? Is our Police Department fully staffed? Because she only saw 4 names on the report. Addressing the job description, she says Council needs to be aware that the ethnic makeup of the City is changing. She would advise that the job description would include that bilingual is very desirable. In fact in the future, bilingual should be included in all job descriptions for the City of Somerville. She has been walking the streets since she is running for City Council. The two questions that come up are "do we have a Police Department?" and "Will our streets be fixed?". She has never been asked, "Do we have an administrative assistant for the Police Department?" She prays that Council will discuss this item, maybe even table it for now.

# **MAYOR & COUNCIL COMMENTS**

Alderman Orozco – Reference to bond election, "when approved, it was approved for 8<sup>th</sup> Street and Memory Lane. The way it reads on the ballot, it says streets, drainage or sewer and streets. That's very misleading for the people in Somerville. Now they find out only 8<sup>th</sup> Street and Memory Lane is going to be paved or repaired, they will wonder what's happening to the other streets. The newspaper, you read it and it has basically the same thing as the ballot but, then at the end it has, turn the page and it has, Memory Lane and 8<sup>th</sup> Street. To me that is such a back door, if you don't explain it right at the beginning and it's not explained right at the ballot, we're voting for 8<sup>th</sup> Street and Memory Lane. We do not vote for streets. That's the way it reads on the ballot which is very misleading. I don't want people hollering at me about this bond on the ballot that streets were going to be done when only 2 streets are going to be done. I don't want that to go, you know people blaming me for that. That's all I have to say, I wasn't very happy with it."

Alderwoman Coleman – She said that she thought about that herself. She wanted to know if it was just going to be those 2 streets?

Administrator Segundo – The wording that you are referring to comes from the attorneys.

Alderman Orozco – said that the attorneys could have been corrected to what we are actually voting for.

Administrator Segundo – in the bond election it does say that it is dedicated to those streets.

Alderman Orozco – said it doesn't refer to the streets that COuncil voted for, it just says streets.

Administrator Segundo- "it's too late to change it".

Alderman Orozco - "It's too late, I know it's too late, it's after the fact now, but I'm saying that Citizens are going to be upset when they pass that and they are looking for their streets to be repaired and it's not. They are going to blame us, well I don't want to be blamed for that. Cause that's not what we voted on.

Administrator Segundo – the newspaper has an article that references 8<sup>th</sup> Street and Memory Lane.

Alderman Orozco - "But see it references that what's on the ballot first, and then when you go to the page, whatever it is 8 or 5 whatever, then it explains and then at the end it explains 8<sup>th</sup> Street and Memory Lane. But the beginning of the article is just like the ballot. It doesn't say Memory Lane it just says sewer and streets. It says streets. Sewer and Streets".

Alderwoman Coleman - "It says streets. Streets are streets".

Alderman Orozco – "But that's not what we voted on. We voted on 8<sup>th</sup> Street and Memory Lane. We didn't vote on Streets".
