#### **Finance**

Included in this board packet is the monthly finance report and minutes from the September 28th Finance Committee meeting. At the meeting, the committee reviewed draft general fund budget amendment as prepared by McNamara and Gillespie. The clerk will send the monthly **Standard Budget Report** which shows adopted budget revenue and expenditure categories compared to what has been received and spent each month. The standard budget report reflects current expenditures compared to the budget as amended at the September 2, 2020 regular board meeting. The clerk will email a copy to board members and have a hard copy at the meeting. She will also forward a copy of the bills for payment – please contact her if you have questions about the bills.

# Update on Marina Infrastructure Projects - North and South

At the meeting on Wednesday I will provide an update on current projects at the marinas. Both marinas are officially closed for the season. As you know, work on the fuel pier is at a standstill awaiting approval from the Army Corps of Engineers. I will have updated information on the upcoming work on the ship's store, the bathhouse and electrical work at the marina north. Electrical at the Marina South could be on track to be completed before the boat stops running. Attached to your board packet is a recommendation from Performance Engineers to enter into a contract with Shoreline Power Services to complete the necessary work. I suggest we accept the recommendation and move forward with the project. The amount (\$188,430.00) is within our budget and the company has a good reputation; the township is committed to covering \$50,000.00 of the cost of this upgrade and the rest is covered by the Michigan Waterways Commission Grant Program.

#### **Update on Campground Project**

It is becoming less and less likely that the Recreation Passport Grant Campground project will be started this fall. While we had hoped the state would move forward with review and approval of the bid documents, it appears the process may drag out longer. Engineer Aaron Nordstrom, Deputy Supervisor Cynthia Pryor and I met with the DNR Grant Coordinator last week and it was decided to resubmit the bid documents, incorporating the few changes requested by the grant coordinator. We plan to have these updated documents submitted this week and the grant coordinator indicated that she will review them as quickly as possible in hopes that we can still get the bids out this fall.

# **Telecommunications Advisory Committee**

The townships established the committee in October of 2018 and authorized its work for two years. I recommend that the extend the committee's authorization for another two years. Current members are: Kathleen McNamara, Paul Welke, Wil Cwikel, Theresa McDonough, Garry Conant, Neal Green, and Kevin Boyle. I also recommend that the board agree to a joint meeting with Peaine Township on October 20 to hear an update from the advisory committee.
