

**MINUTES OF THE SPECIAL CITY COUNCIL MEETING &
COMMITTEE OF THE WHOLE

CALL TO ORDER: Mayor Lansford called the meeting to order at 1:30.

ROLL CALL: Members present: Tara Bedei, Ed Brozak, Brian Crouch, Joe Scarbeary and Mayor Jimmie Lansford.

APPROVAL OF AGENDA:

OLD BUSINESS

1. RESOLUTION: 2019-22. AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN THE CITY OF STREATOR AND THE ILLINOIS FRATERNAL ORDER OF POLICE UNION FOR THE PERIOD BEGINNING MAY 1, 2017 AND ENDING DECEMBER 31, 2019.

Jeremy Palm, City Engineer, presented the signed and ratified contract to the Council and Robert Turner, Deputy Police Chief, reported the changes in the contract to the Council. Mayor Lansford requested a motion and second to pass the resolution for the execution of the agreement between the City of Streator and the FOP union.

NEW BUSINESS

2. ORDINANCE 2019-16. AN ORDINANCE AUTHORIZING THE ISSUANCE OF GENERAL OBLIGATION BONDS (ALTERNATE REVENUE SOURCE), SERIES 2019, IN ONE OR MORE SERIES, OF THE CITY OF STREATOR, LASALLE AND LIVINGSTON COUNTIES, ILLINOIS, IN AN AGGREGATE PRINCIPAL AMOUNT NOT TO EXCEED \$2,500,000 FOR THE PURPOSE OF FINANCING THE COSTS OF CERTAIN CAPITAL PROJECTS WITHIN THE CITY AND PAYING FOR COSTS RELATED THERETO.

Palm presented this item to the Council since he was the Interim City Manager during the time frame this Redevelopment agreement and process with the South Industrial Park began. Mayor Lansford request a motion and second to authorize the ordinance for the issuance of the General Obligation Bonds.

MOTION: Scarbeary made a motion to adopt the ordinance and issue the bonds for this project; seconded by Bedei.

COMMENTS FROM CITY OFFICIALS:


Mayor Lansford reminded the City Council to sign up to visit Vactor and see the plans for the expansion of the facility.
