## Anderson Fields 2019 Cart/Club Storage Agreement

I hereby agree to rent one golf cart storage stall and/or club storage at Anderson Fields, Streator, IL and subject to the following terms and conditions:

1. The term of this storage rental is from March 1, 2020 to February 28, 2021. The rental for cart and /or club storage is assigned as part of this lease. Resident is anyone living within the corporate limits of the city.
2. I hereby hold the City of Streator, the golf course manager, and any of its/their employees, agents, and representative free from all liabilities or claims resulting from damage to the above said golf cart and/or golf bag w/clubs during the term of this rental agreement except such damage is caused directly by an error or omission of said persons, firms, or corporations.
3. I understand that it is not the responsibility of the City of Streator or Anderson Field or any representatives, agents, or employees to provide liability or physical damage insurance covering said golf cart and its use and /or golf bag w/clubs. As owner of the golf cart and/or golf bag w/clubs, I understand that is my responsibility to provide insurance coverage for my own golf cart and/or golf bag w/clubs. I hereby represent that I do have such insurance on said golf cart and/or golf bag w/clubs in adequate amounts.
4. I hereby assume all responsibility for and all liability of any operator or guest passenger using the golf cart during the term of this rent agreement whether or not such guest passenger or other driver has signed this or any other rental agreement.
5. I agree not to allow anyone to operate the above said golf cart who does not possess a valid driver's license.
6. Proof of insurance is required when golf cart and/or golf bag w/clubs are brought to Anderson Fields.
7. A \$2.50 per 9-hole round trail fee will be charged to anyone that is not a first degree relative or 1/2 owner of the cart. There will be no exceptions. (First degree relative is defined as spouse, parent, sibling or child and half owner is someone that is not a first degree relative and pays half of the storage fee as listed on this agreement. \* A non-relative half owner of cart must be listed as half owner on Proof of Insurance supplied within 30 days of signing cart storage agreement. As it implies, only two people can be claimed as half owners.

*The City of Streator specifically disclaims any liability or responsibility for damage or loss due to fire, theft, collision, vandalism or otherwise to vehicles, carts, golf bags and their contents, however caused.*
