

**MINUTES OF THE REGULAR CITY COUNCIL MEETING
COUNCIL CHAMBERS - STREATOR, IL 61364
JANUARY 15, 2020 - 7:00 P.M.**

CALL TO ORDER: Mayor Lansford called the meeting to order at 7:00 p.m.

PLEDGE OF ALLEGIANCE

ROLL CALL: Members present: Tara Bedei, Ed Brozak, Brian Crouch, Joe Scarbeary and Mayor Jimmie Lansford.

APPROVAL OF AGENDA: There were no changes to the agenda.

PUBLIC COMMENT:

Zupansic, John – He wanted to express his concern for the kids in this community due to the new cannabis law. He stated that we already have problems, do we really need all this? Young kids are smoking already.

NEW BUSINESS

1. MOTION TO PLACE ON FILE PLAN COMMISSION'S RECOMMENDATIONS:

1. PC Recommendation 2020-01. Recommending approval and adoption of an ordinance amending Title 17 of the Streator Municipal Code (Zoning Ordinance) concerning Adult-Use Cannabis Business Establishments for the City of Streator, LaSalle and Livingston Counties, Illinois.

2. PC Recommendation 2020-02. Recommending approval and granting award of a "Facade Grant" to owner, American Legion, 218 W. Main Street, in the amount of \$12,076.

3. PC Recommendation 2020-03. Recommending approval and granting award of a "Facade Grant" to owner, Gaspare Atria, 613 E. Main Street (old Fire Station), in the amount of \$15,000.

Mayor Lansford requested a motion and second to place the Plan Commission's recommendations on file.

MOTION: Brozak made a motion to place the Plan Commission's recommendations on file; seconded by Crouch.

2. ORDINANCE 2020-01. AN ORDINANCE AMENDING TITLE 17 OF THE STREATOR MUNICIPAL CODE (THE ZONING ORDINANCE) CONCERNING ADULT-USE CANNABIS BUSINESS ESTABLISHMENTS FOR THE CITY OF STREATOR, LASALLE AND LIVINGSTON COUNTIES, ILLINOIS.

City Attorney, Sheryl Churney, presented this item to the Council and explained a few changes that had been made to the ordinance following the Plan Commission. Mayor Lansford requested a motion and second to adopt the ordinance Amending Title 17 of the Streator Municipal Code (The Zoning Ordinance) Concerning Adult-Use Cannabis Business Establishments for the City of Streator, Lasalle And Livingston Counties, Illinois.

MOTION: Scarbeary made a motion to adopt and pass the ordinance; seconded by Bedie.

3. RESOLUTION 2020-01. APPROVAL AND GRANTING AWARD OF A "FACADE GRANT" TO PROPERTY OWNER, AMERICAN LEGION, 218 WEST MAIN STREET, IN THE AMOUNT OF \$12,076.

Jeremy Palm, City Engineer, presented this item to the Council. Mayor Lansford requested a motion and second to approve and grant a "Facade Grant: to the American Legion Post 217, owner of property at 218 W. Main Street, in the amount of \$12,076.

4. RESOLUTION 2020-02. APPROVAL AND GRANTING AWARD OF A "FACADE GRANT" TO PROPERTY OWNER, GASPARE ATRIA, 613 EAST MAIN STREET, IN THE AMOUNT OF \$15,000.

Palm presented this item to the Council. Mayor Lansford requested a motion and second to approve and grant a "Facade Grant: to Gaspare Atria, owner of property at 613 E. Main Street, in the amount of \$15,000.

MOTION: Crouch made a motion to approve and award the facade grant; seconded by Brozak.

5. ORDINANCE 2020-02. AN ORDINANCE DESIGNATING THE FAR WEST ALLEY NORTH OF BRONSON STREET BETWEEN BLOOMINGTON AND PARK STREETS BE DESIGNATED AS ONE-WAY WESTBOUND IN THE CITY OF STREATOR, ILLINOIS, COUNTIES OF LASALLE AND LIVINGSTON.

Palm presented this item to the Council. Mayor Lansford requested a motion and second to adopt an ordinance Designating the East-West Alley North Of Bronson Street Between Bloomington and Park Streets as One-Way Westbound in the City Of Streator, Illinois, Counties Of Lasalle And Livingston. The motion was amended to designate the alley as an East-West Alley and omit Far West Alley.

MOTION: Crouch made a motion to adopt and pass the ordinance; seconded by Brozak.

6. MOTION TO APPROVE THE PURCHASE OF INFLUENT PUMP(S) FOR THE WASTEWATER PLANT.

Dave Plyman, City Manager, presented this item to the Council. After discussion on this item there was consensus from the Council to purchase and order 3 pumps to save cost per pump. Mayor Lansford requested a motion and second to approve the purchase of pumps for the Sewer Treatment Plant.

MOTION: Crouch made a motion to approve and award the facade grant; seconded by Brozak.

ROLL: Ayes: Bedei, Brozak, Crouch, Scarbeary and Mayor Lansford.

7. CONSENT AGENDA:

Mayor Lansford requested a motion and second to approve the Consent Agenda with an amended fund warrant total of \$758,560.74.

ROLL: Ayes: Bedei, Brozak, Crouch, Scarbeary and Mayor Lansford.

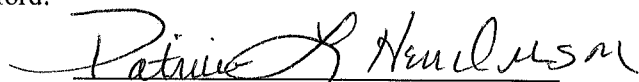
20. CITY OFFICIALS COMMENTS: None.
