DATE November 6, 2019

A bid opening was held on November 5, 2019 for the 2019 TIF funded project which includes the installation of the roadway base for the west 1,000 feet of the proposed new industrial park road near Vactor and relocation of a portion of the existing watermain that runs through the industrial park. This project is being presented so that the temporary road can be installed yet this year to service the new Vactor employee parking lot with construction of the new road to be completed next year. Additionally provided weather cooperates the re-location of the watermain will allow the road construction to be more easily completed in the spring.

Proposals from three bidders were received and read at the bid opening. The three bidders and their respective bids were as follows:

■ Tobey's Construction & Cartage- \$385,062.00

Opperman Construction Co.- \$423,455.00

D Construction Co. - \$532,070.00

Based on these bids and the engineer's estimate of \$471,570, Tobey's Construction & Cartage of Herscher, IL was determined to be the lowest responsible bidder. The selection of Tobey's as the contractor that would be recommended to perform the work was made following tabulation of the three bid proposals, review of Tobey's bid proposal to assure that all required information was included, and after review of Tobey's available work rating and available financial rating.

After review of the above material by the Community Development Department it is being recommended that the construction contract for the 2019 TIF Industrial Park Temporary Road and Water Main Project be awarded to Tobey's Construction & Cartage, Inc.

AWARDING A CONSTRUCTION CONTRACT TO TOBEY'S CONSTRUCTION & CARTAGE, HERSCHER, ILLINOIS, FOR THE 2019 TIF FUNDED INDUSTRIAL PARK TEMPORARY ROAD AND WATERMAIN PROJECT, STREATOR, ILLINOIS.

WHEREAS, the City of Streator, LaSalle and Livingston Counties, Illinois, finds it necessary and in the public interest to make improvements and general maintenance to City streets, and

WHEREAS, bids were received on November 5, 2019 at which time they were opened and publicly read aloud: and

WHEREAS, at that time, three (3) bids were received with the lowest qualified and most responsible bid submitted by Tobey's Construction & Cartage, Herscher, Illinois in the bid amount of Three Hundred Eighty-Five Thousand and Sixty-Two Dollars (\$385,062.00); and

NOW THEREFORE, be it resolved by the City Council of the City of Streator, Counties of LaSalle and Livingston, State of Illinois as follows:

That an award of contract to Tobey's Construction & Cartage, Herscher, Illinois Section 1: in the bid amount of Three Hundred Eighty-Five Thousand and Sixty-Two Dollars

(\$385,062.00); be and the same is hereby approved in connection with the 2019 TIF funded Industrial Park temporary road and watermain project.

The City Manager of the City of Streator is hereby authorized, empowered, and directed Section 2: to execute a contract with said Tobey's Construction & Cartage, Herscher, Illinois. as

provided for in Section 1 of this resolution above in connection with the 2019 TIF funded Industrial Park temporary road and watermain project.
