- Total of Six (6) Vehicles; Four (4) White Ford Police Interceptors (Explorer) and two (2) colored Ford Police Interceptors (Explorer). All vehicles must be equipped with a 3.3L V6 Engine
- All vehicles shall be equipped with the Standard Police Package
- 10-speed auto all-wheel drive or 2WD (if available)
- Vehicles shall be equipped with power door locks and windows and shall be driver-controlled only.
- The systems must be capable of being connected to full capacity if necessary.
- Vehicles shall be equipped with Back up Cameras and Bluetooth.
- Remote Keyless Entry with 4 Key Fobs shall be provided for each vehicle.
- The vehicle alternator shall develop no less than 200 amps.
- Trailer Tow Package
- SOS Post Crash Alert System
- The tires shall be premium quality, tubeless, radial, and designed for law enforcement use. Full-size Spare Tire included.
