### STATEMENT OF COMPLIANCE

1. I have read and am thoroughly familiar with the Access Channel Programming Guidelines (Policy & Procedures, Rules documents).

  - a. Neither lottery nor lottery material will be cablecast.
  - b. No advertising material will be cablecast.
  - c. No obscene or indecent material will be cablecast.
  - d. Arrangements, clearances, and signed releases have been obtained from broadcast stations, networks, sponsors, music licensing organizations, performers' representatives, parents or guardian of minors, and any other persons necessary to authorize transmission of program material on this cable television system's public access channel.
3. I further understand that I assume full responsibility for any disputes arising from unauthorized use of copyrighted material(s) and agree to hold harmless in any such dispute(s) PATH TV, Two Harbors Cable Commission, the City of Two Harbors, and Mediacom and its employees.
4. I further understand that I bear full responsibility for all program content. I assume all responsibility to obtain all necessary rights to program production materials, this includes all necessary literary, artistic, intellectual, performance, and music rights as well as all necessary clearances from owners or licensees of such material.
5. I hereby agree to indemnify and hold harmless PATH TV, Two Harbors Cable Television, the City of Two Harbors and Mediacom and their respective officers, employees, and agents from and against any damages, liabilities, and costs of any nature resulting from any action related in any way to the my use of access channels and/or equipment and facilities. This includes, but is not necessarily limited to, any damages and liabilities in costs, which may arise as a result of the my failure to abide by the operating rules of PATH TV.
6. I understand that I may be criminally or civilly liable for performing material which contains advertising, lottery or lottery information, or obscene and/or indecent material(s).
7. I agree to pay the costs of any repairs to PATH TV access video equipment made necessary by abuse, theft, loss mishandling or careless handling of any and all such equipment that has assigned to me – whether it is in my possession or not (normal wear and tear expected).

I further acknowledge and agree that PATH TV, the Cable Commission of Two Harbors, the City of Two Harbors, Mediacom, or their agents and employees, whether jointly or severally, in their official or personal capacity, undertake no liability for damages (direct, consequential, or of any other kind) for their good faith acts or omissions taken in connection with the administration of these operating rules.
  
9. False or misleading statements made in this application are grounds for forfeiture of any and all rights – present or future – to the use of PATH TV's public access equipment and facilities.
