- Section 71-3 of the Village Code of Ordinances authorizes the Village Council to adopt, by resolution, a schedule of fees and charges applicable to the licensing of peddlers and solicitors.
- The Village Council has reviewed the proposed schedule of fees and reimbursable charges and determined that the same are fair and reasonable.

THEREFORE, BE IT RESOLVED that:

The following schedule of fees and charges is hereby adopted and made effective as of the date the ordinance amending the Code of Ordinances Title VII, Chapter 71 entitled Peddlers and Solicitors:

(1) Fees:
