SUBJECT: April 11th Citizen Advisory Group (CAG) Meeting and Roadshow format options

Following the Planning Commission hearing overview of proposed updates included in the notice to all property owners in Wasco County, the Wasco County 2040 Citizen Advisory Group (CAG) will be meeting to review staff's three proposed options for this spring/summer's public process "roadshow" format. You can view the public participation schedule here for a refresher on all Wasco County 2040 activities.

To help identify the most appropriate format, staff has outlined the goals of the roadshow. These include: public visioning of Wasco County for the next twenty years; narrowing the scope of the work plan to focus on most relevant policies and implementation tools and strategies; continuing public education and outreach on land use planning; and to ensure a broad, diverse range of public participation in the update process.

Based on past CAG recommendations, staff is working with organizations in different communities in Wasco County to leverage existing events and groups to increase participation rates. Tentative scheduling has suggested an hour long event is ideal, particularly when combined with other organization's agenda items.

Therefore, staff has drafted three options for formats which roughly fit into an hour long meeting and can be flexible considering different venues/technological capabilities.

Option 1: Open House & Presentation

The first option is a 30 minute "open house" style meeting where attendees are invited to mingle and review poster boards, and speak to staff and commissioners. Staff recommends this be combined with a more formal 30 minute presentation provided by staff.

Option 2: Presentation & Dot Exercise

The second option is for a 30 minute presentation covering general process, timelines, and purpose followed by a dot (or similar) exercise that asks the group to categorize or pinpoint priorities. Specifically, attendees would be asked to identify which land use planning goals they think are most impactful.

Option 3: Presentation & Small Group Listening Sessions

Finally, the third option would be to have a brief 15 minute presentation followed by a "listening session" small group, where members of the audience break up in to smaller groups to prioritize the list of land use planning goals for the work plan and provide additional feedback.

These options are examples of the types of formats staff can replicate in an hour in numerous settings. It is possible that different elements could be combined into a different option. Your feedback will be useful in validating these as options for the roadshow, and ensuring we are making the best use of time.

Outcome and Schedule

Staff will be using all information collected in these roadshow sessions in combination with survey results, stakeholder interviews, questionnaires, survey results and comments from the public, to identify a broad vision for the future of Wasco County. This will include some alternative growth and development scenarios and policy guidance/focus areas for the Comprehensive Plan revision process.

We are also asking CAG members to provide some additional suggestions for roadshow meeting partners and/or locations. We currently have three tentative dates scheduled including May's scheduled PC Meeting. We have a date scheduled in May to meet with the Petersburg community (area east of Dufur) and a tentative date to hold a joint town hall with the South Wasco Alliance in June in Tygh Valley. To ensure broad representation and participation, staff is recommending we plan for an additional four to six meetings (depending on attendance). Staff suggests focusing those remaining meetings on the following target regions of the county: area near Mosier, south of Maupin, west of Dufur, and Pine Hollow.

Staff is requesting you come prepared with suggestions for possible meeting locations and potential partners.



Purpose of Roadshow Events:


- Engage the public to identify local visions and values for Wasco County 2040;

30 minute meet and greet with opportunity for one-on-one time. Followed by 30 minute presentation on project timelines, process, etc.






Road Show Option 2

Presentation & Dot Exercise

30 minute presentation on project timelines, process, etc. Followed by dot exercise to prioritize goal related work and public visioning.



Road Show Option 3

Brief Presentation & Small Group Listening Sessions

15 minute overview of process/project by staff followed by breaking into small groups to discuss individual visions and focus on prioritizing goal work.
