# Roadshow Topics

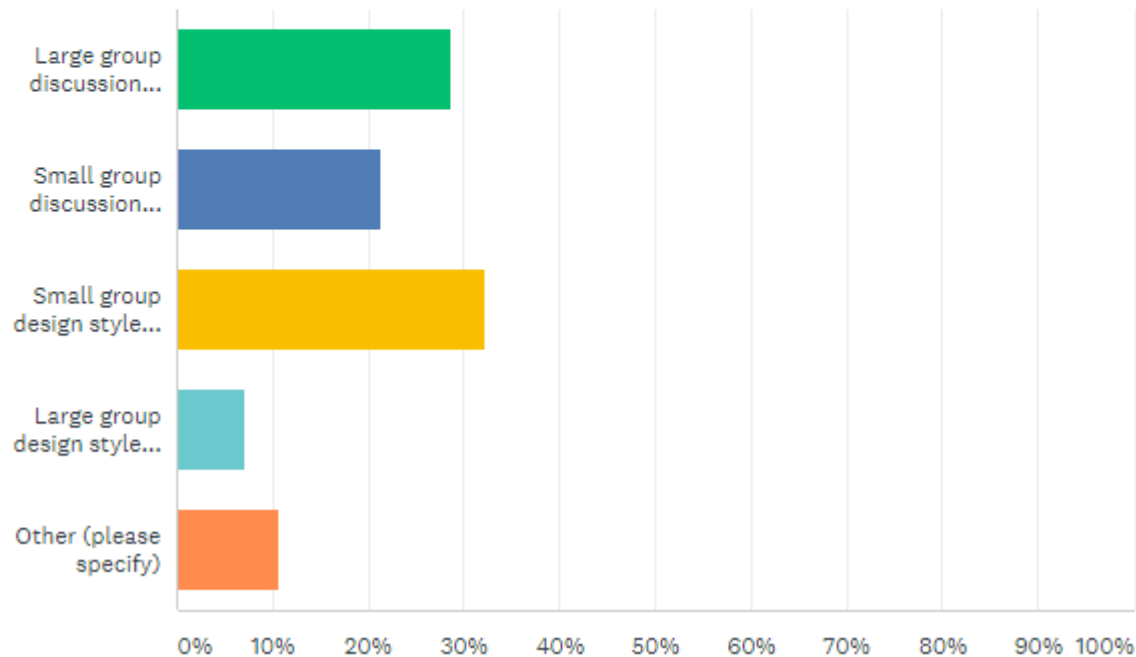
- Housing:
  - alternative housing, higher densities, short term rental restrictions, more residential size lots/opportunities, single wide restrictions
- Flexible parcel size:
  - Opportunities for smaller lots, including rezones, non-resource designation, rural service boundary changes, TDR, non farm dwelling

# Survey Results

- 28 respondents between July and November
- 82% had not previously been to a Wasco County 2040 event
- Over 70% expressed preference for online options, 18% to participate at meetings

In Spring 2019, we will be looking for feedback about flexible housing options and minimum parcel sizes in agriculture and forest zones. Which of these meeting formats do you think would help you and others best participate and share feedback?
