WOOFhaven Dog Park

WOOFhaven Basics

WOOFhaven is a dog park where people and their dogs can play together. It offers an off-leash area where dogs can run and play with others. WOOFhaven is open to City of Woodhaven/Trenton residents.

WOOFhaven is enter at your own risk. Dog owners are responsible and liable for the actions and behavior of their dogs at all times. A liability waiver and registration form must be filled out and signed. Proof of all shots, a current city dog license and a picture must be given at time of registration. An annual fee also must be paid at time of registration. Annual fees for one (1) dog is \$25.00 for City of Woodhaven/Trenton residents. There will be a \$5.00 charge for each additional dog per owner. Annual fees cover from January to December of each year. These forms are available at the City of Woodhaven Clerks Office, 21869 West Road, Monday thru Friday 9:00 am to 5:00 pm, or on line at www.woodhavenmi.org.

WOOFhaven Etiquette and Rules

Once you and your dog get into the park, it's tempting to just stand back and watch all the activity. However, everyone will have a more rewarding time if you observe some basic etiquette for visiting the dog park. Please be courteous to other dog owners and ensure that your dog is getting along with the other dogs in the park. Please be mindful of your cell phone usage while in the park, as they can be distracting. The following rules and laws must be observed at all times. Anyone not following the park rules and laws will be removed from the park. Violators of rules for the use of the park are subject to removal from the park, suspension or revocation of the dog park permits and could result in citations. Please read each of the following rules and initial.

- All dogs must be kept on a leash at all times except in the designated "Off-leash" area.
 This means that the dogs must be on a leash while walking to and from the park. Any dog off leash outside the park can be cited for dog running at large.
 - Woodhaven Ordinances Sec. 10-3. Running at large. & Sec. 10-42. Running at large.
- 2. "Off Leash" dogs must be under voice control of their owner at all times. If voice control is not possible, do not enter the "Off Leash" areas.
- 3. Large Dog Only Area is designated for large breed dogs. The Small Dog Only Area is designated for small breed dogs.

- 4. Owners will be held legally responsible for their dog, and any injuries it may cause to any human, other dog(s), or to the WOOFhaven Park property.
- 5. Dog owners must have the leash in hand at all times. In the event of problems, dog owner should quickly leash and remove their dog from the park.
- 6. No children allowed unless accompanied by an adult. Children MUST be closely supervised by an adult and must behave appropriately: No running, shouting, chasing dogs or petting others dogs without the owner's permission.
- 7. Immediately clean up and dispose of feces left by your dog. Woodhaven Ordinance Sec. 10-45 Defection
- 8. Immediately fill any holes your dog may dig.
- 9. Limit of 2 dogs per adult per visit.
- 10. Access Codes cannot be shared between pet owners. Anyone who shares their code will not be allowed back into the park.
- 11. Only authorized handlers may take dogs to the park. If you want friends or family members to enjoy the park, they must be listed on the Registration Form.
- 12. The park is open from dawn to dusk all year round. The park will be closed at certain times for maintenance, such as tree trimming, grass cutting, etc. For your safety and that of your pets, do not enter the park during these times. The park will be closed for maintenance and neutralizing the grounds in the Spring and Fall. Actual dates will be posted.
- 13. All dogs must be licensed, current on vaccines, healthy and parasite-free.
- 14. Dogs must wear a collar with its city dog license and park membership tag at all times. In addition, your Registration card must be kept with you while at the park. You may at any time be asked to show this to a Police Officer, Animal Control Officer and/or City Park Representative.
- 15. Keep your dog(s) in sight at all times and never leave your dog(s) in the park unattended.
- 16. Females in heat and puppies under 4 months of age are prohibited. Spayed and neutered animals are recommended.
- 17. No aggressive dogs allowed. Immediately leash your dog and leave the park if any aggressive behavior is observed.

- 18. No human/pet food or treats of any kind is allowed within the fenced area. Close all gates for park after entering or exiting.
- 19. No outside toys, raw hides or bones allowed in park.
- 20. No smoking or eating while in the park.
- 21. Do not brush or groom pets inside the park.
- 22. No fires or fire pits allow in the park.
- 23. All items you bring in during you visit must be taken with you when you leave.
- 24. Emergencies must be immediately reported to the Woodhaven Police Department, at (734) 676-7337.
- 25. Other problems or concerns must be reported to Woodhaven Animal Control and/or Woodhaven City Clerk Office.
