Wood, and Ross Wood.



#### Coming Soon to Woodway: Fiber Optics Verizon's "Fiber-To-The-Premises" Project



## What It Means To Woodway Residents

Verizon is committed to providing its King and Snohomish County customers with the latest telecommunications services. "Fiber-To-The-Premises," or FTTP, is our most ambitious effort ever in that regard.

- FTTP will provide our customers with the highest-speed data services available anywhere (between 5 and 30 megabits per second) at competitive prices.
- FTTP will also provide improved service quality and network reliability to local customers as well as the potential for providing many new and exciting services in the future.
- King and Snohomish Counties are the first areas in Washington to receive Fiber-To-The-Premises. The FTTP service package, known as FiOS, will only be available to customers within Verizon landline service areas.

- Current services will continue to be available. For those
  customers who want to keep what they have, no change is
  necessary and rates will not be affected.
- Contractors for Verizon have already begun installing fiberoptic cable in selected areas of King and Snohomish County. This construction is being done only after Verizon and our contractors have obtained the necessary permits from the local city and county governments.
- Generally, Verizon's new fiber network will be placed in the public right of way under streets and sidewalks, where Verizon already has copper facilities. In instances where existing underground pathways are not available and need to be created, our contractors will use the latest in conduit installation techniques, "directional boring," to minimize construction impact.

#### Stormwater Utility Update

The Public Works Department and PACE Engineering have been working this spring to get the design work completed for several of our storm water capital projects, which we are planning to complete either late this summer, or in early fall. The Town Council voted to move the Wachusett conveyance and catch basin project up on the priority list so that it could be completed this year in conjunction with the Town's plans to overlay Wachusett Road.

The table below summarizes the various projects identified for 2008. Please note that the Stormwater Comprehensive Plan, completed in 2005, determined the preliminary budget for each of these projects. Actual costs may be higher depending upon the final contracted bid amount.

#### Zoning Code Changes

Setback restrictions have been an important element in preserving Woodway's open space and maintaining privacy between property owners. This past spring, the Council researched whether our codes needed to be revised to allow certain structures in the setback areas. Over the years, several requests had been made to our Building Department to specify what type of structures might be allowed and under what conditions.

The Council engaged in extensive discussions and sponsored two public hearings to gain input on this issue. Our existing code for game courts became the framework for the revisions. Below is a short summary of the changes. Please contact Town Hall for a complete copy of the updated ordinance.

- All areas of Town are allowed to have hives and houses for beneficial pollinating insects (example: honeybees, bumblebees, orchard mason bees). These hives and structures are allowed anywhere on your property including the setbacks.
- The following structures or projections are the only things allowed in any of the setbacks in Town. This applies to all of the zoning areas.
  - Fences, fence walls, and fence gates in compliance with the Town's Zoning codes
  - Utility poles, vaults, irrigation sprinklers, and well heads

- Light poles that are in compliance with Town codes
- Mail boxes
- Rockeries and retaining walls not exceeding four feet in height unless supporting a cut in the grade
- Driveways, sidewalks, and grade level steps
- Landings at doors not more than 18 inches above grade
- Bird houses and bat houses not exceeding eight cubic feet in volume
- One and two acre lots are allowed to have a play structure (including a tree house) in the setbacks with certain distances established between the property line and the exact location of the play structure.

Tree houses can not be over 15 feet in height, not lighted, no larger than 120 square feet in area, properly screened (and approved by the Town's building official). The location of the tree house must not create a straight line of sight between the tree house and the interior of a residence on any adjoining property.

4. Riding arenas are allowed only on the two acre lots and have certain restrictions regarding distance between the arena and the property line. The arena (if covered) can not exceed 25 feet in height and must be screened from neighboring properties (as approved by the Town's building official).

#### Wachusett Paving Project

As part of the Snohomish County overlay program, the Town has contracted to pave portions of Wachusett Road this summer. Access to properties along Wachusett will be coordinated with those residents impacted. When paving commences, your patience and cooperation will be greatly appreciated. If possible, please choose an alternate route during construction. Thank you!

#### Notes From Your Police Chief

As we begin to finally experience warmer weather and residents open doors and windows, I am reminding residents of the Town's false alarm ordinance. Nearly 10 years ago the council considered the costs of having the police department continually respond to false alarms. After careful consideration, the council passed an ordinance that calls for a fee of \$250.00 to be assessed on the second and subsequent responses to false alarms within any 6-month period of time.

After your first false alarm, you will receive a letter that will remind you to either have your alarm serviced or to take steps to correct whatever caused the initial false alarm. Please read the letter and take whatever steps you can to avoid the fine, the stress, and our response to further alarms at your residence.



We have compiled the police department statistics for 2007; the numbers show that Woodway is definitely not a crime-ridden community. The "Other" portion of the calls in the pie chart are a conglomeration of reports where we assist other neighboring agencies, arrests, or investigations as a result of traffic incidents or domestic related contacts, to name a few of the categories within this section of the chart.


Besides the "Other" calls, the largest number of police responses is for residential false alarms. We also have a growing number of "hang -up" or "dropped" calls. Town residents could reduce the unnecessary responses to these types of calls by:

- 1. Carefully reviewing alarm procedures with all members of their family and anyone else who may have access to the home. Have alarms checked and serviced regularly.
- 2. Remember that once a caller has dialed 911, even if they change their mind prior to speaking with a 911 operator, the call will be traced, and an officer will be dispatched. With hang-up or dropped calls, the dispatcher will attempt to call back and will need to ask several qualifying questions. Please, stay on the phone and explain the reason for the dropped call. Doing this will prevent an officer from being needlessly dispatched.

Alert: Notice that vehicle prowls account for 11% of calls within Woodway. Residents could reduce this number and the loss from theft in these cases if they would remove all "theft attractive" items from their vehicles (iPods, GPS, wallets, purses, etc.). Think prevention; if you do not remove it, someone else may do it for you!



We were also asked to provide information on when crimes occur during the day. The chart to the left reflects when our dispatch center received reports of crimes, but may not reflect when the crimes actually occurred. This is due to the fact that people report crimes when they discover them, not necessarily while they are occurring. We encourage all residents to use the best prevention practices to deter opportunities for crime. We also encourage residents to call 911 when they see something out of the ordinary in their neighborhood.

#### Town Council Corner

General Government: Mayor Nichols reported that the 2005/2006 accountability audit conducted by the State Auditor's Office did not result in any findings. Heard a presentation by Port of Edmonds Executive Director Chris Keuss regarding the plans for the Edmonds Crossing project and the waterfront area in Edmonds. Proclaimed April as Public Education Month. Approved proclamations of appreciation for Dr. John & Brenda Bush, Dr. John Wright, Gwen Johnson, and the Adrian Dominican Sisters at Rosary Heights. Heard a presentation by Snohomish County Councilmember Mike Cooper on upcoming items that will have an impact on areas around Woodway. Heard a Presentation by Caldie Rogers, President, Greater Marysville Tulalip Chamber of Commerce about the Military Family Friendly Employment Partnership Alternative. Adopted Resolution #08-328 declaring Woodway to be Military Family Friendly. Approved Ordinance #08-488 changing employees' deferred compensation plans from ING to ICMA.

**Public Works & Lands:** Mayor Nichols and staff met with Woodhaven residents regarding the stormwater project on their street. Heard update on the planned stormwater projects;

approved recommendations for project prioritization. Heard formal letter of complaint from Town to DOE regarding oil leaks from Allied Waste trucks. Heard report on Right-of-Way violation by Pt. Edwards. Approved Ordinance #08-490 adding a penalty for late payment of stormwater bills.

Land Use & Planning: Held a public hearing on structures in the setbacks. Worked with the Post Office to change city/town name for the 5 houses on Richmond Beach Drive from Shoreline to Woodway. Approved Ordinance #08-489 amending the allowed structures in setbacks. Discussed possible ordinance addressing RV's in setbacks.

**Public Safety:** The City of Edmonds notified the Town of the 2008 fire costs: the fees will increase 6%; the budget included a 5% increase. Approved an Interlocal agreement with Edmonds for Police Vehicle Maintenance.

**Building & Municipal Services:** Discussed the current fee schedule and possible updates. Discussed whether a permit should be required for water heater replacements. Discussed current business license policies.

#### Planning Commission Update

Over the last three months, the Planning Commission has been working with Margaret Clancy of ESA Adolfson to update the Environmentally Sensitive Areas Ordinance (Section 16.10 of the Woodway Municipal Code). This section is being updated to comply with state rules and to ensure that our resources are being adequately protected when development occurs.

#### ENTERING THE TOWN OF WOODWAY

Read at the  $50^{+h}$  anniversary celebration of the Town of Woodway's incorporation,

Sunday, March 16, 2008, at Rosary Heights

You may enter from the east where, returning home on a hot day, you are greeted by a cool embrace easing through Algonouin's curve, or from the north by an up-hill grade enfolded by a lush evergreen and deciduous canopy that spreads soothingly through mind and body or you may enter from the south where, confronted by urban forests, you are called to care about nature, reminded of the connected life. But from the west only fog horns, train whistles, views of Puget Sound, the Olympic mountains and rain riding the Chinook enter—enter as blessings to the fertile mind.

Our founders were not Utopians, nor were they Autocrats, but they had a vision which they trustingly passed into our hands. Although that vision can be compressed to a simple phrase: preserve the rural character, keep the lots large, the streets narrow, dark at night and keep through buses out, behind these words lay their wisdom: the possibility of building a life while earning a living, a way of being, a life with all five senses in play:

the red crest of pileated woodpeckers, their drumming, the whinnying flight of the flicker, its white rump, the owl and eagle, the basket bark of cedar, the insipid taste of salmon berries, the wild huckleberry's tartness, the fragrance of evergreen after rain, licorice ferns rooted to maple bark south of our iconic, concrete bridge, the purple blush of alder in March, its hanging catkins, the white blossoms of Indian plum, the Oregon grape.

Woodway is as Woodway would be, read the headlines heralding the 99 to 83 vote in favor of incorporation.

How crucial is *place* to one's life? We are in the swirl of the present, scurrying through this green town, worried about the news, keeping up to date, changing with the times, while the beauty of Woodway is here, at the center of our daily lives, giving us space to think about ourselves —human beings on this planet, and what we ought mean to each other. Yes,

Woodway *is* as Woodway would be, but only by a narrow margin.


