MAYOR'S MESSAGE

PROPOSITION #1 REPORT

The general election results for Woodway's Proposition #1, which would have raised property taxes to pay for the Town's public safety and general operating expenses, was defeated by approximately 60% of Woodway voters. I want to assure you that your Mayor and Town Council have taken this result seriously. We have reviewed Town operations and every line item of the Town's budget to make necessary adjustments, while ensuring that the Town continues to provide quality services in the most cost effective manner possible.

Cuts in every department are a necessary result of the vote. However, we believe that we have developed a plan that works within our contractual and statutory limitations, and preserves our core operations, while eliminating over \$140,000 per year in costs. Cuts will include reductions in police, permitting, and public works staffing and benefits; reductions in

our legal, planning, and engineering services; and a reduction in a variety of smaller expenses.

As a result of these cuts, we will have changes in our operations. Major changes include more limited office hours; more limited schedule for permit review/issuance; elimination of beautification projects; reduced park and right-of-way maintenance; elimination of police house checks; and elimination of chipping services.

What will not change in the budget are our contractual costs for fire, emergency medical, police backup, emergency management and dispatch services. It simply is not possible to reduce the costs for these services without substantial risks to life safety. We also will maintain our \$1 million emergency fund, which we project will be sustained until 2022. We unanimously believe that this level of reserve is essential to deal with a

major or catastrophic emergency.

The last remaining item that the Council will discuss this Spring is whether to continue the Town Fair. We will be holding a public meeting in March to discuss options and gauge interest in alternative funding/staffing for the Fair. Please keep an eye out for public meeting notices.

POINT WELLS UPDATE

You might have recently read an article in the Everett Herald that there is major news related to Point Wells. As reported, and as has been relayed to the Town by County planning staff, environmental review of the developer's proposal is on hold. The County recently sent BSRE (the owner and developer of the property) a letter stating that the project application has major deficiencies and the County will not continue processing the application until it receives a revised application from the developer.

The problems identified include, among other things, failure to comply with conservation and landslide hazard area regulations, failure to meet parking and landscaping requirements, failure to identify a second access road across the railroad tracks and through the Town of Woodway. The letter further states that if the deficiencies are not corrected by May 17, 2017, the County will likely recommend denial of the project.

The types of revisions requested by the County are significant in nature. With regard to the secondary access road, the Town is aware of a general preference by the developer to utilize a strip of land that they own in Woodway that connects Point Wells to 116th Avenue West. However, we have not yet received a proposal from the developer to which we can respond.

Wipe Out Illegal Dumping

Help keep our streets clean and our stormwater system working!

Given the Town's limited budget, staff, and the size of the infrastructure, the Town relies heavily on resident involvement to help keep streets safe, keep catch basins clean, and notify the Town if a higher level of maintenance is needed at a particular location.

Please do not rake or blow the leaves from your yard into the street. Bag them and place them in your yard waste bin. If you employ a landscaper, please tell them to do

the same and not to blow leaves into the street. This is illegal.

Do not put leaves, dirt, grass clippings, or any materials in the stormwater system. Doing so can cause flooding. It is against the law to dump any material into the drainage system. To report illegal dumping, call (206) 542-4443.

SPEEDING BY THE NUMBERS IN WOODWAY


Occasionally, in the nicer weather months when people are out and about, we get complaints about speeding vehicles in Woodway that often sound like this, "everyone is speeding...I see lots of cars doing 40-50 MPH on Park Road...it happens all the time...". Many things can fuel these perceptions like the sounds of exhaust, tires and even the type of vehicle driven. These are more noticeable when

you are out walking close to the roadway or when doing yard work.

Do drivers speed through the Town? Yes, just not as often or as much as you might believe. We gathered some numbers from a radar speed sign along Woodway Park Road on a weekend (a Friday-Sunday) this last July and put them into a graph so you can see the actual numbers. On average, most drivers obey the 25 MPH limit within the Town. In fact, eighty-

seven percent of the total drivers counted on this weekend were under 30 MPH leaving a much smaller percentage over 31 MPH.

Not "all or most" drivers are speeding and I want to assure you that officers spend a good deal of our patrol time monitoring traffic and looking for those violating the 25 MPH speed limit. We encourage all residents to continue their good driving and to please let us know if you have concerns.

The Comprehensive Plan amendment request proposes to reduce the level of service standard on Woodway's portion of Richmond Beach Drive.

TOWN COUNCIL CORNER

General Government:

- Completed several chapters of the Woodway Municipal Code review and update.
- Adopted Ordinance 16-572, Annexing Certain Unincorporated Territory Commonly Known as the Upper Bluff and completed the annexation process.
- Mayor Nichols presented the 2nd Quarter 2016 Finance Report.
- Heard a presentation on fundraising efforts to build the Edmonds Waterfront Center.
- Held a discussion about the levy lid lift proposal and decided to put the measure on the fall general election ballot.
- Heard a presentation by the

- Snohomish Health District, which requested funding in 2017.
- Heard a presentation by staff on the preliminary 2017 budget and held public hearings on the budget and revenue sources.
- Adopted Resolution 16-388, allowing for the disposition of: surplus property.
- Adopted Resolution 16-389, setting the 2017 property tax levy.

Public Works & Lands:

- Held a public hearing on the Six-Year Transportation Improvement Plan, 2017-2022, and passed Resolution 16-385, adopting the plan.
- Authorized the Mayor to sign the Interlocal Agreement between

Snohomish County and the Town of Woodway for road overlay services.

Building & Municipal Services:

 Adopted Ordinance #16-573, Amending Title 12, Buildings and Construction, adopting 2015 Code Updates and repealing certain sections.

Land Use & Planning:

- Adopted Resolution 16-387, Reaffirming Support for the Master Annexation Interlocal Agreement with Snohomish County.
- Confirmed the Mayor's appointment of Teresa Pape to the Planning Commission.
