The Adams County LEPC held its monthly meeting at the Adams County Fire District in Othello WA on March 17, 2022. Chair Rosenda Henley opened the meeting at 10:02 am and concluded at 11:08 am.

Approval of Minutes:

Motion was made by Brad to accept the February 2022 minutes as written; motion seconded by Gary. Motion carried.

Hazardous Materials Incidents:

- On February 12th a report was received from the WA State Emergency Management Alert & Warning staff of a 20-to-30-gallon diesel spill. WSP notified the State of a collision that occurred just after midnight at East Hwy 26 and Booker Rd. A car and semi-truck collided causing the release to the soil in a roadside ditch. No water impacts, no remediation at the time.

Old Business:

1. Tier II Reports, as of the date and time of the meeting about 60% of reports have been received.

New Business:

1. February 28, 2022, there was a report of a fertilizer plant in Sunnyside that had a fire. The fire caused evacuations due to the smoldering sulfur in the storage building. A nearby school Sheltered-In-Place and turned the HVAC system off to prevent smoke from getting inside the building. The fire started just after 1 pm and was still in progress after five hours.
