SEPA (ENVIRONMENTAL CHECKLIST) REQUEST PACKET

The purpose of the Environmental Checklist (SEPA) is to ensure government agencies consider environmental impacts of development proposals. Applicants provide information via an application form which assists the lead agency in identifying, evaluating and potentially mitigating any likely environmental impacts which would result from the proposed development and reduce or avoid these impacts, if possible. The agency will also use this information to decide whether the likely environmental impacts of the project need a further study, have been adequately addressed by existing regulations, or can be mitigated. The lead agency will also notify other regulatory agencies of the project, initiate a public comment period, and issue a final SEPA review determination.

The process starts after a complete application is submitted and reviewed. The County must determine if there are possible adverse environmental impacts which would result from the proposed project. There are three possible determinations:

- **Determination of Non-Significance (DNS):** The impacts can be addressed by applying the Adams County Code
- **Mitigated Determination of Non-Significance (MDNS):** The impacts can be addressed through conditions of approval; or
- **Determination of Significance (DS):** The impacts cannot be mitigated through conditions of approval; thus, requiring the preparation of an Environmental Impact Statement (EIS).

Once a determination has been made, the County will send out a notice of application to the newspaper of record and notice and request for comments will be sent to a variety of concerned agencies for their review and comment. Typically, the review period of a SEPA application is a minimum of 30-45 days, however the review period may be extended if additional information is required or if the determination needs to be reconsidered based upon comments received during the review period.

Application Instructions for the applicant. The **SEPA** checklist asks you to describe some basic information about your proposal. Please answer each question accurately and carefully, to the best of your knowledge. You may need to consult with an agency specialist or private consultant for answers to some of the questions. **All questions must be answered – do not leave any question blank.** You may use “not applicable” or “does not apply” only when you can explain why it does not apply and not when you do not know the answer. You may also attach or incorporate by reference additional studies or reports. Complete and accurate answers to these questions often avoid delays with the SEPA application process as well as later in the decision-making process.

The checklist questions apply to all parts of your proposal, even if you plan to do them over a period of time or on different parcels of land. Attach any additional information that will help describe your proposal or its environmental effects. The agency to which you submit this checklist may ask you to

explain your answers may ask you to explain your answers or provide additional information reasonably related to determining if there may be significant adverse impact.

Appeals to the SEPA checklist must be done within 10 days of the decision and are appealable under the terms and conditions as set forth under ACC 18.04.230.

SEPA CHECKLIST:

- Completed **General Land Development Application** – must include signatures of all parties with ownership interest. Incomplete applications will not be accepted. **The SEPA Checklist MUST be submitted concurrently with another permit.**
- Site Plan Map:** A detailed map drawn to scale showing the dimensions of the property, location and size of all existing and proposed structures, access to the site, adjacent roads, well, septic systems, easements and parking areas.
- SEPA Checklist Application** (separate from the General Land Development Application).
- SEPA Checklist **fee** is required with the application. The fee is based on the required amount listed in the Adams County Building and Planning Master Fee Schedule.
 - If a Determination of Significance (DS) is made and an **Environmental Impact Statement (EIS)** is required, the applicant must pay the **non-refundable fee** for processing the EIS. The fee amount is listed in the Master Fee Schedule.
 - The **non-refundable** fee for a **Threshold Determination Appeal** for Determination of Non-Significance (DNS) or Determination of Significance (DS) is listed in the Master Fee Schedule. An appeal of the determination must be made in writing to the Adams County Building and Planning within 10 days from the date of the determination and a public hearing will be scheduled. There is no administrative appeal for a DNS.

SEPA ENVIRONMENTAL CHECKLIST

Purpose of checklist

Governmental agencies use this checklist to help determine whether the environmental impacts of your proposal are significant. This information is also helpful to determine if available avoidance, minimization, or compensatory mitigation measures will address the probable significant impacts or if an environmental impact statement will be prepared to further analyze the proposal.

Instructions for applicants

This environmental checklist asks you to describe some basic information about your proposal. Please answer each question accurately and carefully, to the best of your knowledge. You may need to consult with an agency specialist or private consultant for some questions. **You may use “not applicable” or “does not apply” only when you can explain why it does not apply and not when the answer is unknown.** You may also attach or incorporate by reference additional studies reports. Complete and accurate answers to these questions often avoid delays with the SEPA process as well as later in the decision-making process.

The checklist questions apply to **all parts of your proposal**, even if you plan to do them over a period of time or on different parcels of land. Attach any additional information that will help describe your proposal or its environmental effects. The agency to which you submit this checklist may ask you to explain your answers or provide additional information reasonably related to determining if there may be significant adverse impact.

Instructions for lead agencies

Please adjust the format of this template as needed. Additional information may be necessary to evaluate the existing environment, all interrelated aspects of the proposal and an analysis of adverse impacts. The checklist is considered the first but not necessarily the only source of information needed to make an adequate threshold determination. Once a threshold determination is made, the lead agency is responsible for the completeness and accuracy of the checklist and other supporting documents.

The lead agency may exclude (for non-projects) questions in “Part B: Environmental Elements” that do not contribute meaningfully to the analysis of the proposal.

5. Does the proposal lie within a 100-year floodplain? If so, note location on the site plan.

6. Does the proposal involve any discharges of waste materials to surface waters? If so, describe the type of waste and anticipated volume of discharge.

1. Will groundwater be withdrawn from a well for drinking water or other purposes? If so, give a general description of the well, proposed uses and approximate quantities withdrawn from the well. 7. Environmental Health [Find help with answering environmental health questions](#)

- a. Are there any environmental health hazards, including exposure to toxic chemicals, risk of fire and explosion, spill, or hazardous waste, that could occur because of this proposal? If so, describe.

- a. Describe existing hazardous chemicals/conditions that might affect project development and design. This includes underground hazardous liquid and gas transmission pipelines located within the project area and in the vicinity.

8. Land and Shoreline Use [Find help answering land and shoreline use questions](#)

- a. What is the current use of the site and adjacent properties? Will the proposal affect current land uses on nearby or adjacent properties? If so, describe.
- b. Has the project site been used as working farmlands or working forest lands? If so, describe. How much agricultural or forest land of long-term commercial significance will be converted to other uses because of the proposal, if any? If resource lands have not been designated, how many acres in farmland or forest land tax status will be converted to nonfarm or nonforest use?
 1. Will the proposal affect or be affected by surrounding working farm or forest land normal business operations, such as oversize equipment access, the application of pesticides, tilling, and harvesting? If so, how?
