Street canopy trees are to be planted within 15'-20' of the edge of the road



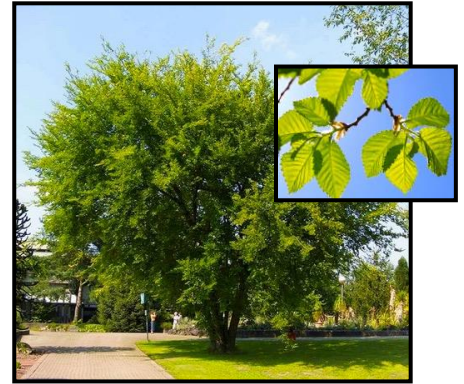
Emerald City Tulip Poplar

Spread 40'-50', Full Sun

Medium Tree 60'-70' tall
Spread 35'-55', Full Sun



Swamp White Oak

Medium Tree 50'-60' tall
Spread 50'-60', Full Sun



Princeton American Elm

Large Tree 50'-70' tall
Spread 30'-50', Full Sun

Specialty trees may be planted anywhere in the front yard except within 20' of the road

Medium Tree up to 50' tall
Spread up to 20'
Deer resistant, Evergreen
Full Sun/Partial Sun

Small Tree 20'-25' tall
Spread 15'-20'
